4. When there is no notification even calling for sponsoring the candidates from the employment exchange no direction can be given in this connection. However the applicants are at liberty to apply for that post as and when it is notified. ^{to help} But facilitate them, the respondents should inform the four applicants in case the selection for filling up the post of ED Packers of Kurnool is going to be held or the concerned employment exchange is going to be approached ^{to} for sponsoring the candidates to that post.

5. The OA is disposed of at the admission stage itself. ^{in due} No costs.


