
2. The OA was disposed of with the following Order:-


"It is now stated that applicant has been taken as permanent Steno Gr.II and will be assigned/alotted the seniority of Steno Gr.II with effect from the date of joining the organisation i.e., from 1-6-93. The letter bearing No.5116/DGAQA/ADMIN-III, dt.26-5-97 has been produced today for proving the above said statement. This letter is taken on record. In view of the decision of the respondents, the OA has become infructuous. Hence, the OA is dismissed as having become infructuous. No costs."

3. The applicant now submits that no seniority list is issued and hence it is violation of the Order of this Tribunal referred to above.

4. Seniority list assumes importance. Further promotion above that of Steno Grade-II is not in order. *when promotion is later ordered -*
The right of the applicant will be safe-guarded if an Order is passed to the effect that further promotion above the grade of Stenographer-II should be issued in future only after the seniority list of Steno Grade-II is issued.

5. With the above direction the CP is closed.
