Heard Mr. P. Jayaseela Rao, Party-in-Person who is aggrieved in this OA by the reported cancellation of allotment of a Type-I/Type-A quafter which was earlier proposed to be allotted to him. Mr. Rajeswar Rao was heard for the Respondents.

The applicant, a Senior Observer, is entitled to Type-C/Type-III quarter. He, however, stakes his claim for a Type-A/Type-I quarter. It is revealed that an entitled person duly applied for the only vacant Type-I/Type-A quarter, was allotted the same, and has also occupied it in the meanwhile. There is thus no scope anymore for any intervention on the applicant's behalf, specially as any irregular allotment of Type-A/Type-I quarter might result in depriving a low-paid Group-D official of his own normal entitlement. There is no reason why the applicant should apply for, or allotted a type of quarter which is 2 steps below that of his entitlement, with or without any undertaking, as seems to have been contemplated at one stage.


It is revealed that one Type-II quarter is available for allotment and occupation and applications have been called for for the same. The applicant would be well advised to apply for the same within the time fixed for it, i.e., 31.10.97. Allotment, if any, shall have to be made strictly as per the relevant rules.

Thus the O.A. is disposed of as per the rules.
