Heard Mr. Srinivas for Mr. S. Laxma Reddy on behalf of the applicant, and Mr. N.R. Devaraj for the respondents.

1. The applicant is a candidate for the post of Postal Assistant in Chittoor Postal Division for which the selection is reported to be underway. It would appear that the respondents addressed the concerned Employment Exchange to sponsor certain number of names of candidates to fill up existing vacancies. The selection is stated to be based on a Departmental examination and an interview. It is confirmed by the learned Senior Standing counsel that the above procedure is in replacement of an earlier long-standing practice of recruiting candidates by paper notification on the basis of their performance at the matriculation examination.


2. The grievance of the present applicant is that her name did not figure in the list of candidates sponsored by the Employment Exchange for recruitment of the said post and that the respondents, for that reason, are not entertaining her candidature. Hence, this OA.


3. In view of the judgement of Hon. Supreme Court in 1996(6)SCALE 676 Excise Superintendent, Malkapatnam, Krishna Dist. vs. K.V.B. Visweswara Rao and others, it becomes necessary to direct that the candidature of the applicant be considered for the post of PA under a suitable community category, along with those candidates whose names have been sponsored by the Employment Exchange. For this purpose, the SSPO is to arrange to supply an appropriate form to the


applicant to enable her to apply for the post, provided she calls on SSPO, Chittoor, in the forenoon of 17-11-97. If the completed application is submitted in the said respondent's office in the afternoon on the same day, and if she is otherwise found eligible for it, <sup>she</sup> should be permitted to take, the examination along with other candidates, the examination which is scheduled for 18-11-1997.

4. Thus the OA is disposed of.




