Sri N.R.Devaraj, standing counsel for the respondents.

2. The applicant is aggrieved about his non-promotion to  
selection grade (Rs.4,500-5,700) as per his turn. He was earlier  
considered for such promotion in August, 1992, August, 1993 and June,  
1994, but was not found suitable to be given the selection grade.  
The officer has since submitted a further representation dt.30-6-97  
to Respondent No.1 projecting the same grievance as before, and states  
that he is due to retire very shortly i.e., in January, 1998. Consi-  
dering this aspect, it would be necessary to direct the Respondent No.1  
to have the case of the officer examined very expeditiously, take a  
suitable decision and communicate the same within four weeks from  
today to the applicant. In case the decision so taken goes adverse  
to the officer, a detailed, speaking order is to be issued to the appli-  
cant expeditiously.

3. Thus the O.A. is disposed of at the admission stage  
itself. No order as to costs.
