2. There are two applicants in this O.A. A provisional seniority list of OS Gr.II in the scale of pay of Rs.1600-2660 was issued by memorandum No.G/P.612/III/3/Vol.V/Clerks dt.9-4-97 (Annexure-V to the OA). The applicants submitted representation which was disposed of by the impugned order No.G/P 612/III/3/Vol.V Dt.9-4-97 (Annexure-I to the OA) rejecting their representation. Thereafter the applicant No.1 submitted representation dt.8-7-97 (page-53, Annexure-XIV to the OA) and applicant No.2 submitted representation dt.6-9-97 to Respondent No.3 (page-50 to the OA) against seniority of Respondent No.4 shown above them. It is stated that those representation are still pending.

This O.A. is filed to set aside the impugned order dt.9-4-97 (Annexure-I to the OA) and for a consequential direction to the respondents to follow the seniority already published on 30-4-1984 (for Sr.Clerks), 19/20-9-86, 25-1-91 (Hd.Clerks) and to cancel the seniority list of Office Supdts. Gr.II published on 9-4-97 in respect of Clerical Staff of Mechanical Branch, Guntakal Division of S.C.Railway.

4. The representations of the applicants addressed to Respondent No.3 as referred to above ^{are} ~~is~~ still pending. Hence the O.A. is disposed of as under :-




