
2. This OA is filed challenging the show cause notice <sup>for at limits of the</sup> terminating the applicant by the impugned notice dated 21.4.99.

4. In view of the above the order passed in OA.661/99 will ~~also~~ hold good in this OA also.


4. The OA is disposed of. No costs.

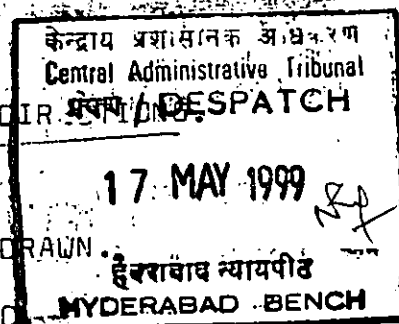
