Oral order (per Hon. Mr. R. Rangarajan, Member(Admn.) )


Heard Mr. Ravinder Goud for Mr. M. Venkatram Reddy for the applicant and Mr. V. Rajeswara Rao for the respondents.

4. With the above direction the OA is disposed of.


