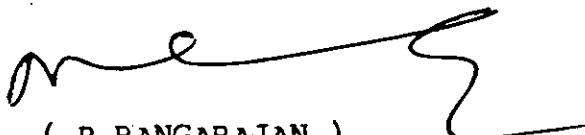

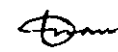

3. Hence, for the reasons stated in the OA.No.949 of 1999, this OA is liable to be dismissed, and accordingly it is dismissed. No costs.

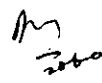
