

ORDER (ORAL)

2. Notice of this Contempt Petition was given to the respondents. ~~and~~ The respondents have filed the reply. During the course of arguments, the learned counsel for the respondents has brought to our notice the order dated 21.12.2004 passed in DB Civil Writ Petition No. 1739/2004 whereby Writ Petition filed against the impugned order of this Tribunal has been admitted by the Hon'ble High Court and the operation of the order dated 25.4.2003 has been stayed.

3. In view of this development, this Contempt Petition does not survive and accordingly, the same stand disposed of. Notices issued to the respondents are hereby discharged.
