Applicant, Govind Ram, has filed this application under Section 19 of the Administrative Tribunals Act, 1985, praying for the following reliefs :-

- "1. Payment of Interest @ 18% P.A. on the DCEG (Gratuity) amount of Rs.31775/- from 1.1.1993 to 27.4.94 total amount of Interest Rs.2483/-
2. Payment of Interest on the Pension amount with arrears of Rs.12025/- from 1.1.1993 to 31.10.94 @ 18% P.A. total amount of interest Rs.13864/-
3. Payment of Interest on the Commutation of Pension amount of Rs.36062/- from 1.1.1993 to 9.12.1994 @ 18% P.A. total amount of Interest Rs.12442/-

Grant Total 31,173/-

4. In view of the immense hardship caused to the applicant at this fag end of his life inspite of his demands an special cost of compensation or penal Interest which this Hon'ble Tribunal may deem just and proper in the facts and circumstances of the case, may also kindly be allowed or any relief."
