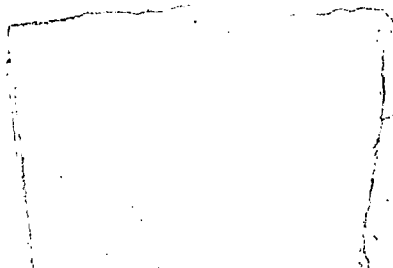

O R D E R :

PER HON'BLE MR.JUSTICE B.S.RAIKOTE :-



This batch of cases we have heard alongwith O.A. Nos. 387/99 (M.D. SHARMA vs. Union of India and O.A. No. 419/99 (K.L. Mehta vs. Union of India and Ors.) as suggested at the bar, in view of the fact that all these cases essentially involve a controversy relating to the principles for determining the seniority of Schedule caste/schedule tribe candidates promoted earlier on roster principles vis-a-vis general category candidates promoted later. In O.A. No. 387/99 and O.A. No. 419/99 today (supra), we rendered a separate common judgement/so as to appreciate the principles of law laid down by Hon'ble the Supreme Court in a number of judgements with reference to facts involved in those two cases, so as to illustrate the applicability of the principles, keeping in view the fact that it would not be possible for us to return a final finding as to the merits involved in each case. The Railway department is a huge department with vast records pertaining to its large number of employees, including innumerable rules, regulations and circulars etc. Therefore, to undertake an exercise so as to record a final finding as to respective cases between the applicants and the respondents in each case would be next to impossibility for us, for the simple reason that the applicability of principles regarding determination of seniority of the roster promotees vis-a-vis general category candidates requires to be considered with reference to the persons similarly situated in the various cadres at different levels, including those who have retired. This kind of an exercise is possible only the department with all the material available at the command. Therefore, noting the contention of the applicants and the respondents in each case by way of

be an exercise in futility. In this view of the matter, we think it appropriate to dispose of the entire batch of these cases on the basis of the reasoning contained in O.A. No. 387/89 connected with O.A. No. 419/99. We have also taken note of the fact that the reliefs prayed for in each one of these cases could be slightly different from the other cases, having regard to the nature of disputes between the applicants and the respondents in a particular case. But at the same time, the fundamental principles involved centre round the issue regarding the determination of the inter-se seniority of the junior roster promotees vis-a-vis senior general category candidates, on the basis of the "catch up" principle enunciated by Hon'ble the Supreme Court in number of judgements, which we have already referred to in O.A. No. 387/99. Moreover, in some cases like O.A. No. 07/93 connected with OA No. 414/2000 and O.A. No. 495/93, in addition to the general issue as to the seniority between reserved promotees and general category candidates, there is an additional issue regarding seniority of an employee promoted on the sports quota, as against the general category candidates and also the reserved category candidates. This aspect as to the sports quota, and the question of seniority of an employee promoted on sports quota, requires to be determined by the department on the basis of the sports quota rule, and other circulars applicable. In some other cases, like O.A. No. 96/99 connected with O.A. No. 324/2000 and O.A. No. 436/2000, there is yet another issue, as to whether the post of Chief Matron in the pay scale at Rs. 7400-11500 is a new post created/or it is a case of upgradation etc. requiring determination of roster point. The department alone can decide on the basis of the materials available with them. These instances we have given

only as an example, and there may be some other additional issues involved, requiring the attention on the part of the department on the basis of the records, apart from the main controversy of the seniority between roster promotees and the general category candidates.

2. For the above reasons, we think it appropriate to dispose of this batch of cases with an observation that wherever eligibility list and/or panel are prepared for the purpose of promotion to the higher cadre, without following the law laid down by Hon'ble the Supreme Court in Ajit Singh-II, Jatinder Pal Singh etc., such eligibility list and panel are prima facie, invalid and ineffective as long as the official respondents have not revised the seniority lists of the lower cadre, keeping in view the "Catch up" principle enunciated by Hon'ble the Supreme Court. We also find that even the impugned seniority lists challenged in different cases are the seniority lists prepared without considering the "Catch-up" rule. In these circumstances, keeping in view the law declared by Hon'ble the Supreme Court in Ajit Singh-II and Jatinder Pal Singh case etc., such seniority lists are required to be revised to bring them in conformity with the law declared by Hon'ble the Supreme Court, as we have already made it clear in O.A. No. 387/99 and O.A. No. 419/99. The judgement in O.A. No. 387/99 and O.A. No. 419/99 rendered separately today, shall be treated as part of this judgement. In fact, Hon'ble the Supreme Court has already issued a general direction dated 16.08.2000 in Special Leave to Appeal (Civil) Nos. 16135-16136 of 1999, directing the Union of India to implement the directions given by the Constitution Bench of Apex Court in Jatinder Pal Singh case. Hence, in our considered opinion, it is the duty of the department to implement the same. It is needless to point out that the law protect those who protect the law (Dharmo Rakshati Rakshatah).

3. For the above reasons, we pass the order as under :-

"All the above OAs are disposed of with a direction to the respondents not to give effect to any eligibility list and/or panel already prepared for the purpose of promotion to the next higher cadre, without revising the seniority in the lower cadre in the light of the "catch up" rule enunciated by Hon'ble the Supreme Court in Ajit Singh -II, Jatinder Pal Singh etc. The official respondents shall now take up the exercise for revising the seniority between the applicants and the respondents in each case with reference to other persons of the cadres at different levels, in terms of the base level seniority. This exercise shall be completed within a period of six months from the date of receipt of a copy of this order or before initiating the process for any promotion to higher cadre, whichever is earlier.

4. Parties are left to bear their own costs.
