## **ORDER**

PER HON'BLE MR.ANIL KUMAR, ADMINISTRATIVE MEMBER

The applicants have filed the present OA praying for the following relief :-

*Anil Kumar*

(i) That the Hon'ble Tribunal may graciously be pleased to direct the respondents to fix and grant Grade Pay of Rs. 4800/- from initial stage and Grade Pay of Rs. 5400/- on completion of 4 years regular service in the cadre of PS-II with gazetted status with effect from 1.1.1986 with all consequential benefits to the petitioners in the light of the judgment dated 5.6.2012 in OA No. 658/2010 passed by Hon'ble CAT Madras Bench and the same has attained the finality in the eye of law.

(ii) Any other relief which the Hon'ble Tribunal deem fit and proper may also be granted to the applicants.

(iii) Award the cost of litigation to the applicants.

2. Heard the learned counsel for the applicants who submitted that the respondents are not extending the benefit of the judgment passed by the Madras Bench of this Tribunal in OA No. 658/2010 filed by the similarly situated employees whereby a historical parity has been established between the Private Secretaries of Central Secretariat and of Central Administrative Tribunal with Railways. A direction was given to the

respondents to grant the Private Secretaries initially Grade Pay of Rs. 4800 and Rs. 5400 after completion of four years regular service in the cadre of Private Secretary-II with gazetted status w.e.f. 1.1.2006. The learned counsel for the applicants further stated that the said order passed by the Hon'ble Madras Bench of CAT has attained finality as it has got stamp of approval by the Hon'ble High Court of Madras as well as by the Hon'ble Supreme Court. He further submitted

C. that the respondent department in compliance to the order passed in OA No. 658/2010 has granted the aforesaid benefit only to those employees who were parties therein and have not applied and implemented that order in respect of those who were not parties in the said OA. The learned counsel for the applicants emphasized that the order passed by the Tribunal in the said OA was the order in rem and not a personam even then the respondents have not enlarged the benefit of the said judgment in respect of all employees having identical case.

3. The learned counsel submitted that the applicants have filed the representations to the respondents (Annexure-A/1) which have been forwarded by the General Manager(P), North Western Railway to

Secretary (E), Railway Board, Rail Bhawan, New Delhi vide letter dated 26.2.2014(Annexure A/1) but these representations filed by the applicants have not been decided so far. He prayed that the respondents be directed to decide the said representations in terms of the order passed by the Hon'ble CAT , Madras Bench in OA No. 658/2010.

4. Having heard the submissions made by the learned counsel for the applicants we are of the view that end of justice would be served if respondents are directed to consider and decide the representations filed by the applicants which have been forwarded by the General Manager(P), North Western Railway to the Secretary (E), Railway Board, Rail Bhawan, New Delhi vide letter dated 26.2.2014 (Annexure A/1). Accordingly, we direct the respondents to consider and decide the representations so filed by the applicants according to the provisions of law by a reasoned and speaking order. While deciding the representations of the applicants the respondents shall also examine whether the cases of the applicants are covered by the order of the Hon'ble CAT, Madras Bench passed in OA No. 658/2010 dated 5.6.2012. The respondents are directed to decide the representations of the applicants expeditiously but in any case not later than 3 months

from the date of receipt of the copy of this order. The applicants are directed to submit a copy of paper book of this OA along with a copy of this order to the respondents. With these directions the OA is disposed of with no order as to costs.
