ORDER

(Per DR. K.B. SURESH, JUDICIAL MEMBER)



With the consent of counsels for the parties, all the aforesaid Original Applications have been heard together since facts and issue are similar in these OAs and, as such, are being disposed of by a common order.

2. In support of their cases, learned counsels for the applicants placed reliance on several orders of other Benches of the Tribunal including the order of Ahmedabad Bench of the Tribunal which is a detailed order dated 18.03.2016 in OA No. 478/2015 (Kaustubha Devang Pandya & Ors. vs. UOI & Ors.) with OA No. 100/2016 (Jadav Ajitsang Banerang vs. UOI & Ors.). Four points were formulated for consideration by the Bench. After hearing counsels for the parties, points were answered.

3. Learned counsel for the respondents placed before us the decision of the Hon'ble Apex Court in **Mahipal Singh Tomar vs. State of Uttar Pradesh** and Others, reported in (2013) 16 SCC 771, which is a connected decision of the Hon'ble Apex Court in

Inderpreet Singh Kahlon and others vs. State of Punjab and others, reported in (2006) 11 SCC 356, in **Onkar Lal Bajaj and others vs. UOI & Anr.**, reported in (2003) 2 SCC 673, in **Chairman, All India Railway Recruitment Board and another vs. K. Shyam Kumar and others**, reported in (2010) 6 SCC 614, in **East Coast Railway and another vs. Mahadev Appa Rao and others**, reported in (2010) 7 SCC 678, and in **Union of India and others vs. O. Chakradhar**, reported in (2002) 3 SCC 146.

4. We have heard learned counsels for both the sides elaborately.

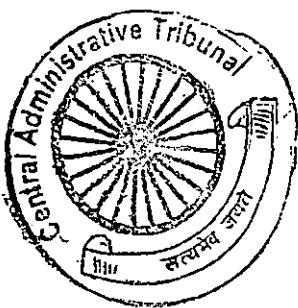


Learned counsel for the respondents on the basis of these judgments of the Hon'ble Apex Court submits that there is a question which had arisen as to whether the judgment of the Ahmedabad Bench of the Tribunal in OA No. 478/2015 with OA No. 100/2016 (supra) will be hit by the principle of per incuriam. We, therefore, examined these judgments and find that the principle of per incuriam will not be attracted for the single reason that the Hon'ble Supreme Court's judgments and C.A.T., Ahmedabad Bench's judgment follows the same stream.

6. In **East Coast Railway and another vs. Mahadev Appa Rao and others** (supra), the Hon'ble Apex Court has held that judicial review is possible on the ground of arbitrariness and further held that though a candidate who has passed an examination or whose name appears in select list does not have an indefeasible right to be appointed, yet appointment cannot be

denied arbitrarily, not can selection test be cancelled without giving proper justification.

7. In **Chairman, All India Railway Recruitment Board and another vs. K. Shyam Kumar and others** (supra), Hon'ble Supreme Court has held that on the basis of vigilance report indicating leakage of question paper, large-scale impersonation of candidates, mass copying etc. in written test, and possibility of involvement of departmental staff and outsiders, there is no illegality in quashing the appointments.



8. In **Onkar Lal Bajaj and others vs. UOI & Anr.**, (supra), the Hon'ble Apex Court has held that in regard to distribution of State largesse, cancellation of largesse already granted. The test will determine the probity in governance and larger interest of public.

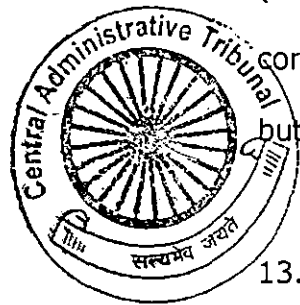
9. In **Union of India and others vs. O. Chakradhar** (supra), the Hon'ble Supreme Court has held that the applicability of principle of natural justice may have some exception in some case, individual notice to candidates may not be necessary where the mischief in conducting the selection was so widespread and all-pervasive, affecting the result, that it was difficult to identify the persons unlawfully benefited or wrongfully deprived of selection.

10. But in the present case the vigilance enquiry had already identified the very number of persons who are involved in it and their names have also been identified, therefore, there is a

question as to why the respondents have failed to act on this enquiry report which is a full detailed inquiry conducted by their own vigilance itself and after going through it we are convinced that they had done a good job.

11. In **Mahipal Singh Tomar vs. State of Uttar Pradesh** and Others (supra), the Hon'ble Apex Court has held that if report is vague and opportunity to controvert the findings recorded were not given then such termination of services would be illegal and liable to be quashed.

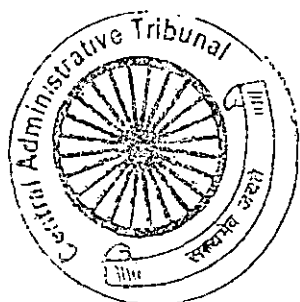
12. After having considered all these judgments cited by the respondents, we hold that the judgment of the Ahmedabad Bench of the Tribunal in OA No. 478/2015 with OA No. 100/2016 (supra) is not hit by principle of per incuriam and having considered all aspects raised herein also is eligible to be followed but because of some factual issues with slight modifications.



13. At this stage, learned counsels for the applicants placed before us the judgment of the Hon'ble Apex Court in **Union of India and others vs. Rajesh P.U., Puthuvalnikathu and another** reported in (2003) 7 SCC 285, wherein it has been held that where from out of the selectees it was possible to weed out the beneficiaries of irregularities or illegalities, there was no justification to deny appointment to those selected candidates whose selection was not vitiated in any manner. This is the main crux of the matter. If there is anybody who is involved in the conspiracy or criminal intents they must be sent out but the denial of appointment to innocent persons would frustrate the

livelihood of these persons which is against the mandate of Constitution of India.

14. Learned counsel for the applicants also placed before us the decision of the Hon'ble Supreme Court in **Joginder Pal and others vs. State of Punjab and others**, reported in (2014) 6 SCC 644, wherein it has been held that once it was accepted that some of the candidates were untainted and who entered service by virtue of their merit and not because of any extraneous considerations and such candidates could be segregated from tainted candidates, cancellation of entire selection process on the ground that the process smacks of mala fides and malpractices was not justified and untainted candidates should be reinstated in service. We are in respectful agreement with the views expressed by the Hon'ble Supreme Court in **Joginder Pal and others vs. State of Punjab and others** (supra).



15. After having heard the counsels for both the sides and examining the matter in a great detail, we hereby issue the following directions:

- (i) The respondents will refer the matter to the CVC and CBI immediately and forthwith with all relevant documents /record and position of the matter, so that they can immediately commence the preliminary enquiry. There will be a time of three months from today for completion of preliminary enquiry so that the clouds can be shifted out from innocent.

(ii) If the respondents are unable to find out the involvement of any of the applicants in all these dealings then it will be deemed that the applicants are innocent of the charges leveled against them and in that case at the end of three months period as granted, the applicants will be reinstated back in service.

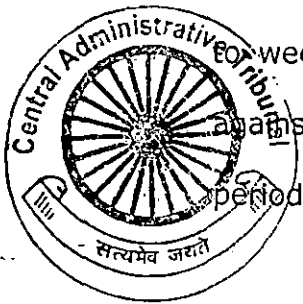
16. At this stage, learned counsel for the respondents submits that at least four months' time may be granted for completion of the enquiry by the CVC and CBI. It is allowed.

17. It appears through the vigilance report and after hearing the counsels for the parties that there might be involvement of senior officers of the department also, it is, therefore, necessary

to weed out all of these persons and take appropriate action against them, which shall also be taken within the aforesaid period.

18. There will be a mandate to the CVC and CBI to treat this matter as very urgent as question of livelihood of so many persons is there, and integrity to be maintained in Government servant is a question, therefore, urgent action will be required to be taken by the CVC and CBI in the matter within a period of four months' time as sought by the respondents. It is to be noted that following orders of other Benches sufficient time is already granted.

19. Besides, there may not be any difficulty in this matter as after having gone through the vigilance report it appears that



there might be involvement of senior officers of the department itself and most of the issues are taken care of.



20. It is made clear that if name of anyone of the applicants is found in such a racket then notice(s) shall be issued to them within 15 days after completion of four months' time already granted to the CVC and CBI for completion of enquiry and appropriate action may be taken against them so that justice may be done. For those applicants who are found innocent in the matter, their rights of employment and consequences thereof shall follow within a period of four months from today as aforesaid.

21. With these observations and directions, all the Original Applications are disposed of with no order as to costs.

22. Registry shall place original copy of this order in OA No. 291/00008/2016 and certified copies in other connected OAs.
