

Applicants, Roop Chand, Ramdev Jat, Surat Singh, Suresh Kumar Shektawat, Suresh Chandra Sharma, Narendra Kumar Sharma, Pooran Mal, Kailash Chand, Mahavir Singh and Asfaq Ahmed, have sought a direction to the respondents to treat them as regularly promoted to the post of Electrician Highly Skilled Grade II as also for a direction to declare the result of the selection for the post of Electrician Highly Skilled Grade I.

2. We have heard the learned counsel for the parties and have perused the record.

3. The applicants have challenged the show cause notices by which they were sought to be reverted to lower posts from that of Electrician Highly Skilled Grade II. The learned counsel for the respondents have produced a copy of the order dated 10.7.1999 by which the impugned show cause notice has been cancelled. He further states that the result of the Trade Test held for the post of Electrician Highly Skilled Grade I has also been declared. In the circumstances the grievance of the applicants, therefore, does not survive. This application having become infructuous is dismissed with no order as to costs.
