ORDER (ORAL)

Shri Hari Singh Meena and 203 others have filed this Original Application under Section 19 of the Administrative Tribunals Act, 1985 for the following prayers:-

- "(i) That the entire record relating to the case be called for and after perusing the same the respondents be directed not to organize special training course as has been organized vide letter dated 12.9.2002 (Annexure A/2) in future and not to utilize officials of Accounts and Entitlement

to carryout work of Audit particularly in respect of Panchayat Raj Institutions and Urban Local Bodies as ordered vide order dated 4.10.2002 by quashing orders dated 4.10.2002 and 12.9.2002 (Annexure A/1 and Annexure-A/2).

- (ii) That the respondents be further directed not to proceed further in pursuance to orders dated 4.10.2002 and 12.9.2002 (Annexure A/1 and Annexure A/2) and to manage the Audit work of Panchayat Raj Institutions and Urban Local Bodies by the Audit Staff (Applicants) as being done in the past.
- (iii) That the respondents be further directed to act as per provisions of CSAG's (Duties, Powers and Conditions of Service) Act 1971 and provisions of MIR (Manual of Restructuring of Cadres in Indian Audit and Accounts Department).
- (iv) Any other order, direction or relief may be passed in favour of the applicants which may be deemed fit, just and proper under the facts and circumstances of the case.
- (v) That the costs of this application may be awarded."

2. We have heard the learned counsel for the parties at considerable length and have very carefully perused the record of this case.


3. The factual matrix of the case is that the applicants are employed on the post of Auditors in the office of the Accountant General, Rajasthan. The said office came to be bifurcated in two parts, one Audit and

another Accounts in the year 1984. Separate rules have been framed for both these organisations. The applicants are having their separate cadres, separate designations of the posts with specified scale of pay and having their independent Sub-Heads. However, they are under the highest authority i.e. the Comptroller and Auditor General of India. The respondents have issued two orders i.e. order dated 4.10.2002 (Ann.A1) and order dated 12.9.2002 (Ann.A2). These orders said to have been issued in pursuance to the DO letter dated 5.6.96. By these two orders, in respect of Ann.A1 certain persons have been transferred from Accounts side to the Audit side without any specification as regards to the type of their transfer. By other order i.e. Ann.A2, the persons from Accounts side have been ordered to be sent for training. The OA has been filed on diverse grounds mentioned in para 5 of the OA.

4. A detailed and exhaustive reply has been filed on behalf of the respondents, which is followed by a rejoinder on behalf of the applicants.

5. The primary contention of the learned counsel for the applicants is that up to the year 2002, the Department of Audit and Accounts have been independently functioning and there was no change or transfer of the staff between these departments. But now, suddenly the respondents have started imparting training to the persons from the Accounts Department and having also sending them for audit job, which is exclusively meant and to be carried out by the Audit Department. Thus, their service conditions are being jeopardised for none of their fault.





5.1 On the contrary, the learned counsel for the respondents has vehemently opposed the contentions raised on behalf of the applicants and it has been submitted that the matter is a policy matter and no interference is called for from this Tribunal. Whatever policy has been framed, it is generally to be taken having its objects and for fulfilling the requirements of the Department and it cannot be lightly interfered with. Certain other contentions have been made in support of the defence like - it is in the shape of Public Interest Litigation and the right of the applicants cannot be said to be infringed, the OA is premature, the affected persons are not impleaded as party-respondents etc.

6. We have considered the matter by carrying out a close scrutiny and analysis and have tried our best to come to the heart of the problem, but we have not been able to find out in what way the applicants are affected, as to whether their seniority is going to be affected and it is only their promotion is going to be affected or their strength is likely to be increased and in what way their terms and conditions are to be ~~be~~ adversely affected. On the other hand, it is also <sup>not</sup> ~~born~~ out from the respondents' side as to what is the service exigency for inducting persons from the other Department and whether the Accounts people have become surplus and were required to be absorbed in the Audit and what is the object of such policy giving them training in a different discipline. It causes an anxiety and doubt as to what could be the circumstances that persons from one cadre are being sent to other cadre, even having different designations and without any specification regarding their tenures or

without disclosing future prospects. They have also taken support of certain judgments and certain decisions alleged to be said as similar matters in support of their contention.

7. We are of the considered view that since complete facts are not made available to us, we shall not be able to arrive at a justifiable conclusion in this case and instead of resolving the matter raised, we find it expedient if the matter is remitted to the respondents for resolving the controversy as they are the masters of the factual aspects as well as equipped with the requirement of the administrative exigencies. In this view of the matter, we dispose of this OA with the following directions:-

The applicants are directed to make detailed representations projecting their complete grievance in the matter to respondent No.2 within a period of one month from the date of receipt of copy of this order, and respondent No.2 is directed to examine the complete matter meeting out all the points and grounds raised in the representations, within a period of 3 months after receipt of representations, and pass a speaking order on the same, which shall be communicated to the applicants within a period of one month from their decision. In case the applicants still feel aggrieved by the decision so arrived, the applicants shall be at liberty to take recourse to availing the remedy available to them. They may also take all grounds which has been raised in the present OA, if so advised. No
