Both the cases were taken up together for consideration, since it involves common question of law based on similar facts.

2. All these applicants are serving as Sub-Divisional Engineer (TES Group B Officer) in the Telecommunication Department. These Officers moved this Tribunal for a direction on the respondents for stepping up their pay at par with Sri D. Sundarmurthy, Sub-Divisional Engineer. The applicants cited the instances of stepping up of pay of similar Officers by the respondents authority on similar grounds.

3. All the applicants, admittedly, ^{are} senior to Sri D. Sundarmurthy whose seniority No. is 19008. Therefore, there cannot be any justification for not giving these applicants the benefit of stepping up of their pay at par with Sri D. Sundarmurthy, Sub-Divisional Engineer.

4. We have heard Mr. B. Sinha, learned counsel for the applicants and Mr. A. Deb Roy, learned Sr. C.G.S.C. as well as Mr. B. C. Pathak, learned Addl. C.G.S.C. for the respondents.

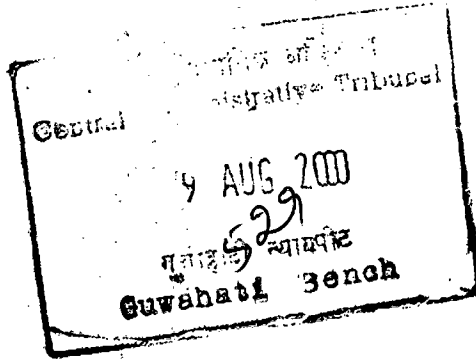

Upon hearing learned counsel for the parties and considering the materials on records, we order upon the respondents to confer the benefit of stepping up the pay to the applicants at par with Sri D. Sundarmurthy with effect from 1.2.97. The respondents shall take necessary step for re-fixation of salaries of the applicants as early as possible.

DETAILS OF APPLICATION :

1. PARTICULARS OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE :

This application is against the action of the Respondents in respect of Basic Pay and salaries of the applicants over the Basic Pay and salaries of their juniors in Telecom Department under the Respondents and in allowing the juniors to get more pay than the seniors.

2. JURISDICTION OF THE TRIBUNAL :

The applicants declare that the subject matter of the application is within the jurisdiction of this Hon'ble Tribunal.

3. LIMITATION :

The applicants further declare that the application is filed within the limitation period prescribed under Section 21 of the Administrative Tribunal's Act.

4. FACTS OF THE CASE :

4.1 : That all the applicants have same and common grievance and relief sought for before this Hon'ble Tribunal are also same and common. As such all the applicants may be allowed to join together in this application as applicants as per provision laid down in Administrative Tribunal (~~Procedure~~) Rule 1987, 4(5)(a).

4.2 : That the applicants are citizen of India and at present residing in North-East States and working under the Respondents in Telecom Department and as such they are entitled to all the rights and privileges guaranteed to a citizen of India under the Constitution of India.

4.3 : That all the applicants at first were recruited under the Respondents as the Junior Telecom Officers. Thereafter in course of time they were considered for promotion in TES Grade-B Officer and after promotion in TES Grade-B, all the applicants have joined in their respective place of posting as the Sub-Divisional Engineer under the establishments of the Respondents.

4.4 : That as the Junior Telecom Officer the applicants were provided with the current and existing pay scale of the Junior Telecom Officer (in short JTO), plus all other allowances admissible in accordance with the Rules alongwith other similarly situated persons. The pay-scale and monthly salaries of the

applicants were revised and refixed from time to time with all service benefits available to them in accordance with the Rules alongwith other similarly situated persons. The Pay-scale and monthly salaries of the applicants were again revised and refixed in the promotional post of Sub-Divisional Engineer (TES Grade-B Officer) with all service benefits available to them in accordance with the Rules alongwith other similarly situated persons.

4.5 : That the applicants while working as the Sub-Divisional Engineer (TES Grade-B Officer) under the Respondents, the CCS (Revised Pay) Rules, 1996 came into force and accordingly the Basic pay-scale of the applicants have been revised and refixed alongwith other similarly situated persons in a bunches on the basis of their existing pay-scale and in terms of the aforesaid CCS (Revised Pay) Rules, 1996 w.e.f. 1.1.96. In other words it may be stated herein thus :-

(i) The applicant No.1 who has been recruited as the Junior Technical Officer (in short J.T.O.) under the Respondents in the year 1973 on a basic scale of pay of Rs. 425/= P.M. In course of time he was considered for promotion in TES Group-B Officer on 18.11.93 and accordingly he has joined as the Sub-Divisional Engineer (in short SDE) on 3.1.94 under the establishment of the Respondent No.5. The Basic pay of the applicant No.1 upto 31.12.95 was

However, after coming into effect of the CCS (Revised Pay) Rules, 1996, the Basic Pay in respect of the applicant No.1 has been revised and refixed at Rs. 8250/= P.M. on 1.1.96 in a bunches. The due date of increment in the pay-scale is in the month of May and as such the Basic Pay of the Applicant No.1 was Rs. 8500/= P.M. on 1.5.96 and it was Rs. 8500/= P.M. on 1.2.97.

(ii) The Applicant No.2 who has been recruited as the J.T.O. in the year 1974 on a basic scale of pay of Rs. 425/= P.M. (xii) The applicant No.12 who has been recruited as the J.T.O. in the year 1979 on a basic pay of Rs. 425/= P.M. He was considered for promotion in TES Gr.B on 27.5.94 and joined as the SDE on ~~30.6~~ 30.6.94 under the establishment of the Respondent No. 4. The basic pay of the applicant No.12 upto 31.12.95 was Rs.2525/= P.M. and it was revised and refixed at Rs. 8000/= P.M. on 1.1.96 in a bunches. The due date of increment in the pay scale of the applicant No.12 is in the month of February and as such the basic pay of the applicant No.12 was Rs. 8250/= P.M. on 1.2.96 and it was Rs.8500/= P.M. on 1.2.97.

(xiii) The applicant No.13 has been recruited as the J.T.O. in the year 1979 on ~~xx~~ a basic scale of pay of Rs. 425/= P.M. He was considered for promotion in TES Gr.B on 3.6.94 and joined as the SDE on 28.9.94 under the Establishment of the Respondent No.4. The basic pay of the applicant No.13 upto 31.12.95 was Rs. 2450/= P.M. and it was revised and refixed at Rs. 8000/= P.M. on 1.1.96 in a bunches. The due date of increment in the pay scale

of the applicant No.13 is in the month of May and as such the basic pay of the applicant No.13 was Rs. 8250/= P.M. on 1.5.96 and it was Rs. 8250/= P.M. on 1.2.97. It may be mentioned here that all the applicants are getting their monthly salaries with due increments on their pay scale on the basis of the aforesaid date of revision came into force on 1.1.96 and availing the same till date.

4.6 : That in the meantime a provisional seniority list of TES Gr.B Officers of the Department of Telecommunications has been circulated to the all concerned. It may be mentioned here that the aforesaid seniority list of TES Gr.B Officers of the Deptt. of Telecommunication has been prepared on the basis of ~~final~~ final All India eligibility lists of Junior Telecom Officers. All the applicants also comes under the purview of the aforesaid final seniority list and have been found placed in such list in order of their seniority.

A copy of the aforesaid final seniority list No. XVII of TES Group-B Officers communicated vide letter No.16-22/95-STG-II dated 22.2.99 are annexed hereto as Annexures-1A and 1B of this application.

4.7 : That the applicants state that all the applicants belonged to TES Group B Officers of the Deptt. of Telecommunication and at present working as the SDE under the disposal of the respondents.

They are also placed in the final seniority list of TES Group-B Officer in order of their seniority and eligibility. It may be mentioned here that seniority Nos. 14086, 15861, 13980, 17038, 16024, 16109, 16037, 16085, 16035 and 16212 have been provided to the applicant Nos. 2, 4 to 11 and 13 respectively and the seniority Number in respect of the applicant Nos. 1, 3 and 12 are provided in other seniority list prepared on the basis of seniority and eligibility.

4.8 : That the applicants beg to state that an irregular fixation and re-fixation in the basic pay scale in respect of TES Group-B Officers who are far more junior than the applicants have come into existence on or after 1.2.97. In this connection it may be mentioned here that one TES Group-B Officer, namely, Shri D. Sundarmurthy who has been recruited as the J.T.O. in the year 1981 on a basic scale of pay of Rs. 425/= P.M. He was considered for promotion in TES Group-B Officer on 3.6.94 and joined as the SDE on 27.11.96 under the establishment of the Respondent No.6. The basic pay of the aforesaid Sri D. Sundarmurthy upto 31.12.95 was Rs. 2375/= P.M. and it was revised and refixed at Rs. 8000/= P.M. on 1.1.96 in a bunches in terms of the CCS (Revised Pay) Rules, 1996. The due date of increment in his pay-scale is in the month of February and as such he was allowed to draw Rs. 8250/= P.M. on 1.2.96 as his

Basic Pay. Thereafter on 27.11.96 he was promoted and allowed to join as the SDE under the establishment of the Respondent No.6 and accordingly his basic Pay was again fixed at Rs. 8500/= P.M. on 27.11.96 and it was Rs. 9000/= P.M. on 1.2.97 and continuously drawing as such alongwith increments in his pay scale on due date.

In this connection, it may further be mentioned here that many other similarly situated TES Group-B Officers from the establishment of the Respondent No.5, particularly, Shri U.K.Bhattacharjee, M. ~~Mr~~/ Biswas, M. Saha etc. who were recruited as the J.T.O. in the year 1980/1981 had approached the Respondent authorities in connection with the stepping up and refixation of their basic pay in pursuance to the case of the aforesaid Shri D. Sundarmurthy and the respondents accordingly stepping and refixed the basic pay of the aforesaid TES Gr.B Officers at Rs. 9000/= P.M. on 1.2.97 with increments in the pay scale on due date of increment as per letter dated 3.2.99 issued in this regard.

A copy of the aforesaid letter vide No. AP/STEP UP/98-99/25 dated 3.2.99 is annexed hereto as Annexure-2 of this application.

4.9: That from the above it is apparent that all those TES Gr.B Officers who have been recruited in the year 1980/1981 in as much as those officers were

provided with the seniority No. 19008 to Mr. D. Sundarmurthy, No.18174 to U.K. Bhattacharjee etc. below than that of the applicants in terms of the Final Seniority List were facilitated with the basic pay of Rs. 9000/= P.M. as on 1.2.97. From bare perusal of records ~~xxx~~ it appears that the aforesaid TES Gr.B Officers are much more junior than the present applicants and they were considered for promotion in TES Gr.B Officer much later than the applicants and as such they were found place much below than the applicants in the All India eligibility list of Junior Telecom Officer and accordingly placed them with their seniority numbers after the applicants.

4.10 : That the applicants beg to state that the respondent authorities pleased to refix the basic pay of the aforesaid junior TES Gr.B Officers and similarly situated officer at Rs. 9000/= P.M. on and from 1.2.97. As such an irregular fixation in the pay scale of TES Gr.B Officers came into existence and the fact remains that the Junior TES Gr.B Officers are paid with the higher Basic Pay and the applicants being senior to them are paid with the low basic pay viz. Rs. 8500/= P.M. on and from 1.2.97 which are not in accordance with the Rules.

4.11: That the TES Gr.B Officers who are paid with the higher Basic Pay of Rs. 9000/= P.M. in their pay scale on and from 1.2.97 being junior than the applicants who are much more senior to them. The

applicants accordingly approached the respondents authorities and submitted representations praying inter alia for stepping-up of their basic pay at Rs.9000/= P.M. on and from 1.2.97 as it was done in like manner in respect of other junior TES Gr.B Officers mentioned above (Annexure-2).

A copy each of the aforesaid representations submitted by the applicants are annexed hereto as Annexure-3 series of this application.

4.12 : That the respondents did not respond to the representations submitted by the applicants in as much as did not feel like to refer the matters before the higher authorities in order to remove anomalies in the pay scale and salaries of the junior and senior SDE. However, of late, the Senior Accounts Officer concerned of the office of the Director of Maintenance, ETR, Guwahati-3 vide a letter was pleased to communicate the applicants in stating that the pay of all officers of TES Group-B included in the seniority list No.I to XVII is required to be fixed in terms of DOT's letter No.16-3/92-STG-II dated 5.7.94 and 16.8.94 and did not state anything about the pay and salaries of junior SDE who are getting more salaries than the senior SDE. In other words the Accounts Officer on the recommendation and advice of the higher authorities had rejected the representations submitted by the applicants indirectly.

A copy each of the aforesaid impugned letter issued by the Accounts Officer, office of the Director of Maintenance, ETR, Guwahati are annexed herewith as Annexure-4 series of this application.

4.13 : That the applicants state that it is a settled principles of law that no junior employees are entitled to get or avail more pay and salaries than the senior employees on the same cadre which is a matter of prudence, as such all the applicants are entitled to get their salaries at Rs. 9000/= w.e.f. 1.2.97 with all service benefits and increments thereof in accordance with the Rules.

4.14 : That in view of the aforesaid facts and circumstances stated above it is a fit case where Your Lordships would be pleased to direct the respondents to settle the pay scale and salaries of the applicants and refix the pay scale and salaries of the applicants either at Rs. 9000/= w.e.f. 1.2.97 or above giving its effect from 1.2.97 and remove all anomalies in respect of salaries in between the junior SDE and senior SDE.

4.15. : That the representations made by the applicants had been disposed and indirectly rejected by the respondents. The applicants have no other efficacious alternative remedy other then preferring this application and the remedy sought for if granted would be just, proper and adequate.

4.16 : That this application has been made bonafide to secure the ends of justice.

5. GROUND FOR RELIEF WITH LEGAL PROVISIONS :

5.1 : For that the inaction on the part of the respondents in granting more salaries to the junior SDE than the applicants for such a long time i.e. w.e.f. 1.2.97 are in gross violation of relevant Rules.

5.2 : For that there is clear violation of prescribed procedure and relevant Rules in refixing the pay scale and salaries of the senior and junior SDE inasmuch as the applicants being senior are entitled to get either equal pay or higher pay than those of their juniors. There is being no suspicion as regards the genuineness of the claim, the same must have been necessarily settled way back in the year 1997.

5.3 : For that the respondents providing more B.P.R. salaries to the junior SDE fixed at Rs. 9000/= w.e.f. 1.2.97 imposed a penalty upon the applicants as well as the respondents failed to respond the representations submitted by the applicants in this regard.

5.4 : For that the respondents failed to provide opportunity to the applicants to remove anomalies in pay scale and salaries and thereby deprived the applicants from their legitimate pay and salaries.

5.5 : For that the impugned action on the part of the respondents being without sanction of law is per-se illegal, arbitrary and malafide on the face of it.

5.6 : For that the respondents failed to respond the representations submitted by the applicants by reason of that the applicants must suffer and get lesser salary in order to facilitate the junior SDE which are not sustainable in law.

5.7 : For that there has been clear violation on Article 14, 21 and 300-A of the Constitution of India besides being violation of principles of natural justice, legitimate expectation and administrative fairplay.

5.8 : For that in any view of the matter the impugned action of the respondents are not in accordance with the law and as such the respondents have made themselves liable to be directed by this Hon'ble Tribunal to remove all these anomalies in respect of pay scale and salaries of the applicants and the junior SDE.

The applicants crave leave of this Hon'ble Tribunal to advance more grounds both factually as well as legal at the time of hearing of the case.

6. DETAILS OF REMEDIES EXHAUSTED :

The applicants declare that they have no other alternative and efficacious remedy other than filing of the present application.

7. MATTERS NOT PREVIOUSLY FILED OR PENDING BEFORE ANY OTHER COURT OR TRIBUNAL :

The applicants further declare that no other application, writ petition, suit in respect of the subject matter of the instant application is filed before any other Court, authority or any other Bench of the Hon^{ble} Tribunal and no such application, writ petition or suit is pending before any Court of Law.

8. RELIEF SOUGHT FOR :

Under the ~~xxx~~ facts and circumstances stated above, the applicants prayed for this application be admitted, calls for record and notice be issued to the respondents to show cause as to why the relief sought for in this application should not be granted and upon hearing the parties and perusal of record be pleased to grant the following reliefs :

8.1 : To direct the respondents to settle and refix the pay scale and salaries of the applicants and direct the respondents to refix the pay scale of the applicants at Rs. 9000/= or above w.e.f. 1.2.97.

8.2 : To direct the respondents to release all arrear salaries in terms of the pay scale of the applicants at Rs. 9000/= w.e.f. 1.2.97.

8.3 : Cost of the application.

8.4 : Any other relief/reliefs to which the applicants are entitled.

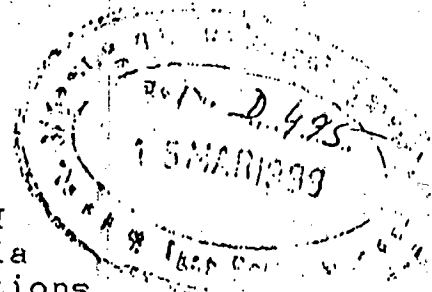

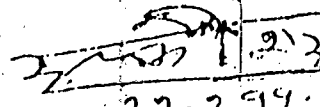

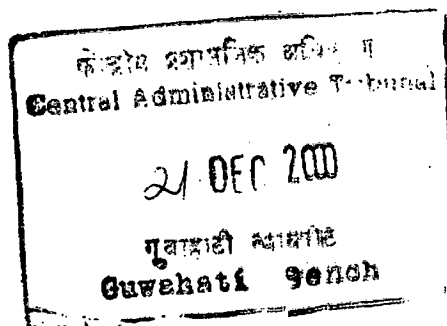

Sundarmurthy on promotion as SDE, would have been done in accordance with the aforesaid orders referred to above the anomaly in pay with the seniors as claimed by the applicants would not have arisen and no unnecessary loss from the public exchequer would have caused and also no administrative inconvenience would have been resulted in.

Further it may be stated here that stepping up of pay of Shri U.K. Bhattacharjee and others in the light of the case of Shri D. Sundarmurthy was made by the officials of the unit where D. Sundarmurthy has been working and liable to face consequences. 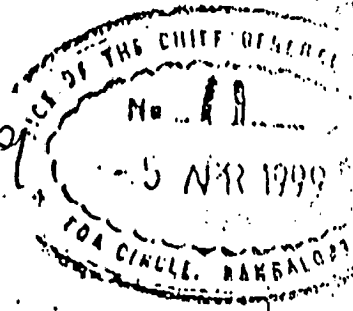

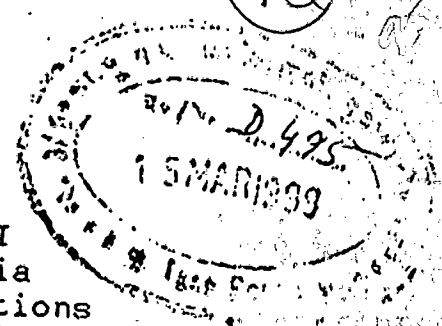
