The issue raised ^{here} relates to one
more facet of Article of 16 of the
Constitution of India.

According to the applicant they
were eligible for the posts & adver-
tised pertaining to filling up the
vacancies of the junior Engineers
Grade II as per Railway notice. The
applicants submitted their application
for Apprentice Jr.Engineer Grade III
as per the advertisement dated 13th
November 1999. The applicants pleaded
that they were legitimately expecting

16.2.01 for the call letters for appearing in the written test that was to be held on 7.1.2000. The applicants did not receive any call any letters. They apprehended that they missed the opportunity to appear in the examination for want of communication of the written test, more so in view of the all India Postal strike that took place in the month of December, 2000 disrupting the postal service. The applicants pleaded in the application as under :

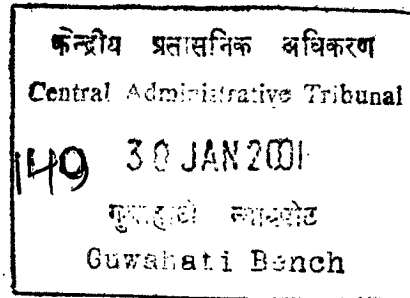
"the office of the Respondent No.2 perhaps issued the call letters during the said period of General Strike and as a result many candidates including the applicants did not receive their call letters and consequent could not sit in the written test."

They are also contended that on account of postal strike the other Railway Recruitment Boards have postponed the date of written examination/interview. Mr.K.N,Choudhury appearing for the applicant also submitted about the requirement of wide publicity of the Employment Notice in the matter of Public employment to meet the mandate of the Equality Clause enshrined in the Constitution of India. Mr.B.K.Sharma learned counsel for the respondents submitted that he was in a position to argue the matter on merit since he has received the necessary instruction from the Respondent through Sri S.Sharma learned Advocate. As per the instructions receive/apprehension raised in the applications are groundless, baseless submitted Mr.B.K.Sharma. According to Mr.Sharma the applicant No.3 did not apply for the post. The applications of the other four applicants were duly received and their applications could not be accepted and their applications were rejected on the ground that those

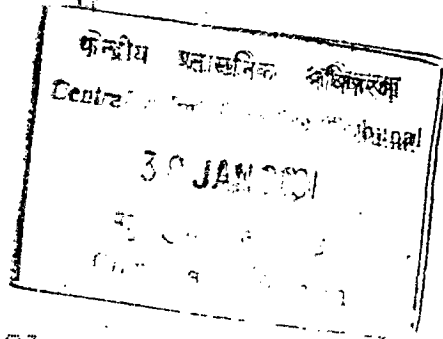

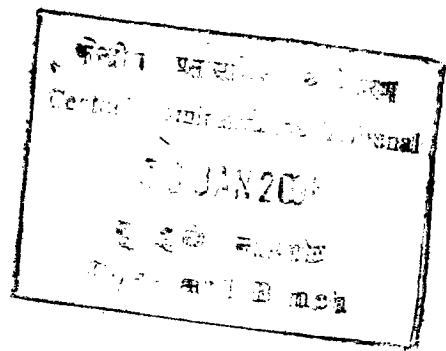

DETAILS OF THE APPLICATION :

1. Particulars of the order against which the application is made :

This application is directed against the arbitrary action of the respondents in not issuing call letters to the applicants pursuant to the Employment Notice No. 2/99 to appear in written test held on 07.01.2001 for the Category No.6 as well as for not postponing the written test held on 07.01.2001 on account of Postal Strike. The application is also directed against the arbitrary action of the Respondents in changing the Examination Centre unilaterally.

2. Jurisdiction :

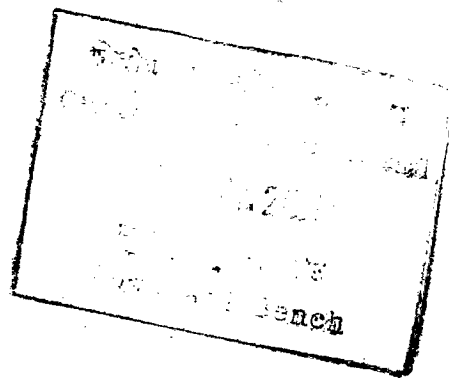
The applicant declares that this Hon'ble Tribunal has got jurisdiction to adjudicate the matter in regard to which this application is made.

3. Limitation :

The applicant further declares that this application is well within the period of limitation prescribed under Section 21 of the Administrative Tribunal Act, 1985.

4. Facts of the case.:

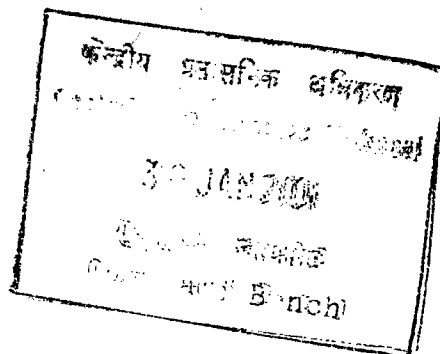
4.1 That your applicants are citizens of India and resident of the State of Assam. As such the applicants are entitled to all rights and privileges available to citizens under the Constitution and other laws of the land. The applicants have a common cause of action and as such they crave leave to file a single petition. Having regard to the common cause of action and similar relief prayed for, liberty may kindly be granted to join together and file a single application as envisaged under sub-rule (5)(a) of Rule 4 of the Central Administrative Tribunal (Procedural Rules, 1987).

4.2 That the Respondent No.1 is represented by the Secretary to the Govt of India, Ministry of Railways. The Respondent No.2 is a statutory Body and is represented by its Chairman. The Respondent No.3 is the North East Frontier Railway having its Head Quarters at Maligaon, Guwahati. The Respondent No. 2 is entrusted with the function of making recruitment to various posts under Respondent No.4.

4.3 That the applicants state that the Respondent No.2 vide its Employment Notice No.2/99 published in the Assam Tribune in its issue dated

13.1.99 invited applications in prescribed Form for some temporary posts, likely to be made permanent in the North East Frontier Railways. The said post were divided into ten categories. Against each category separate vacancies with total number were shown with the break up of reserved and unreserved vacancies in the said Employment Notice. The instant application is concerned with recruitment to the post of Apprentice Junior Engineer, Grade II (P.Way) covered by Category No.6. In terms of the Employment Notice there are 53 vacancies and the qualification prescribed is Diploma in Civil/ Electrical/ Mechanical Engineering. It was also provided that the applications duly filled up were to be submitted on or before 13.12.99 before the prescribed authority. In terms of the Employment Notice out of 53 posts, 9, 12 and 32 were reserved for SC, OBC and General categories respectively.

A copy of the aforesaid Employment Notice 2/99 dated 13.11.1999 is annexed hereto and marked as ANNEXURE-R/1.

4.4 That the applicants are duly qualified, inasmuch as they possess the requisite qualification in terms of the advertisement. All the applicants are Diploma holders in their respective

branch. Thus, all the applicants are eligible to apply for the posts covered by Category No.6.

The applicants crave leave to refer to and rely upon their testimonials at the time of hearing of this application.

4.5 That the applicants state that in pursuance of the said advertisement the applicants who are all eligible applied for the post of Apprentice Junior Engineer Grade-II(P.Way) covered by Category No.6. The office of the Respondent No.2 also issued call letters to the ^{eligible candidates} ~~applicants~~ with intimation that the written examination would be held on 07.01.2001 in respective Centres.

A copy of such call letter is annexed hereto and marked as ANNEXURE-R/2.

4.6 That in this connection it would be relevant to state that the Employees of the Postal Department resorted to all-India strike in the month of December, 2000 thereby disrupting the postal service. The office of the Respondent No.2 perhaps issued the call letters during the said period of General Strike and as a result many

candidates including the applicants did not receive their call letters and consequent could not sit in the written test.) Needless to say that great prejudice has been caused to the applicants in the process. In this connection it would also be relevant to state that the office of the Respondent No.2 also violated the Rules/ Instructions issued by the competent authority of the Respondents of issuing call letters one month ahead of the date of Examination. By the aforesaid practice all the call letters ought to have been issued prior to 7th December, 2000. Because of the aforesaid irregularities, the applicants had to suffer a lot. That apart, other Railways Recruitment Boards published the date of Examination by paper advertisement and other modes besides issuing the call letters. The idea is to give wide publication so that all concerned are informed beforehand. In the instant case the Respondent No.2, other than issuing the call letters, has not published the date of Examination through the media. In view of the postal strike the Respondent No.2 ought to have issued Employment News notifying the date of examination.

cruitment Board, Allahabad are annexed hereto and marked as ANNEXURE-R/3 series.

4.7 That the applicants state that on account of the postal strike referred to above, many of the Railways Recruitment Boards have postponed the date of written examination/ interview. In this connection it would be relevant to refer to notices issued by the Railway Recruitment Board, Bhubaneswar and Ajmer whereby the date of written examination has been postponed.

Copy of the aforesaid Employment News issued by the Railway Recruitment Board, Bhubaneswar and Ajmer are annexed hereto and marked as ANNEXURE- R/4 series.

4.8 That the applicants beg to highlight another serious anomaly in holding the written test. As per the Employment Notice No.2/99 the examination centres have been notified as Guwahati/ Tinsukia/ Lumding/ Alipurduar. But the Office of the Respondent No.2 surreptitiously has chosen New Jalpaiguri also as an examination centre. As a matter of fact admit card has also been issued to one Subrato Sen indicating the examination centre as New Jalpaiguri.

A copy of the admit card dated 04.12.2000 issued to said Sri Subrato Sen is annexed hereto and marked as ANNEXURE- R/5.

4.9 That the action of the respondent No.2 to include New Jalpaiguri as examination centre in addition to the centres notified in the Employment News is not difficult to understand. The idea is to deprive the candidates from N.E.Region in the matter of recruitment. The Respondent No.2 has miserably failed to take note of the plight of the candidate who hails from far flung areas such as Tripura, Silchar, Tinsukia, Arunachal Pradesh and other places of N.E.Region. The centre at New Jalpaiguri has been set up arbitrarily to accommodate the vested interest. All along examination under Railway Recruitment Board, Guwahati were held at Guwahati. It is for the first time that examination is being held at Siliguri and other places. It may be pointed out herein that under N.F.Railway, there are three Railway Recruitment Boards namely, Guwahati, Patna and Ranchi. Under the circumstances, the action of the Respondent No.2 to hold examination in centres other than the notified ones is arbitrary and unreasonable.

4.10 That the applicants state that the applicant No.1 as well as other applicants applied for the post in question in the prescribed form by depositing Rs. 60.00 postal order each.

Copies of each postal orders of Rs. 60/- deposited by the applicants are annexed hereto and marked as ANNEXURE-R/8 series.

4.11 That although the written test was held on 07.01.2001 the applicants could not appear in the written test due to non-receipt of call letters/ admit card. As pointed out above, the Respondent No.2 did not notify the date of examination through media as has been done by other Railway Recruitment Boards. In addition to the above, the other Railway Recruitment Boards have also postponed the date of examination due to the postal strike. As the applicants did not receive any call letter and come to know about the written test having been held on 07.01.2001 recently, there has been some delay in approaching this Hon'ble Tribunal. However, for ends of justice the matter may be entertained and give relief to the applicants.

4.12 That the respondent No.2 has recently published a list of forty candidates selected for Vocational Course for Railway Commercial (VCRC) for the session 2000-2001 vide letter No. RRB/G/CON/155 dated 27.09.2000. Out of the forty candidates as many as twentynine candidates belong to a particular State to which the present incumbent in the Office of the Respondent No.2 belong. This fact has been brought to the notice of this Hon'ble Tribunal to show the bias of the Respondent No.2 as well as to show the action of the Respondent No.2 to deny equality of opportunity to the candidates of N.E. Region in violation of Article 14 and 16 of the Constitution of India.

A copy of the said letter dated 27.09.2000 is annexed hereto and marked as ANNEXURE- R/8.

4.13 That the applicants state that the action of the Respondent No.2 in purporting to select candidates belonging to a particular State, curving out new examination centres, taking arbitrary decisions in matters of recruitment are indicative of colourable exercise of powers. In any case such precipitating actions are not conducive for good administration beside being suffering from

the vice of arbitrariness. To put in other words, the impugned decision making process has denied equality of opportunity to the applicants and other candidates from the region in the matter of public employment in violation of Articles 14 and 16 of the Constitution of India.

4.14 That under the facts and circumstances stated above, it is respectfully submitted that this Hon'ble Tribunal may be pleased to intervene in the matter by declaring the written test held on 07.01.2001 as null and void and issue a further direction to the Respondents to hold fresh examination for Category No.06.

4.15 That although the written test was held on 07.01.2001, but the results of the written test has not yet been declared. Therefore, there may not be any impediment to direct the respondent No.2 not to declare the results without leave of this Hon'ble Tribunal.

4.16 That this application has been filed bonafide and for the ends of justice.

5. Grounds for relief with legal provisions :

5.1 For that the respondents committed manifest error of law apparent on the face of the records in not postponing the written examination as has been done by the other Railway Recruitment Boards. The decision making process also vitiates relevant considerations which ought to have been taken note of have been ignored.

5.2 For that the applicants who are eligible in terms of the Employment Notice No.2/99 have a corresponding right to apply for the post and be considered for appointment. Non-receipt of call letters by the applicants, for whatever reason, therefore, amounts to denial of equality of opportunity in matters of public employment within the meaning of Article 16 of the Constitution of India.

5.3 For that the impugned action of holding written examination on 07.01.2001 without wide publicity is an arbitrary and unreasonable action and as such is violative of Article 14 of the Constitution of India. The Respondent No.2 ought to have given wide publicity apart from issuing call letters as has been done by other RRBs.

5.4 For that the respondent No.2 have miserably failed to take note of the relevant consideration i.e. postal strike in holding the written test on 07.01.2001 as scheduled earlier. In view of the postal strike the examination ought to have been postponed for the ends of justice as has been done by other RRBs.

5.5 For that the legitimate expectation and/or the rights of the applicants to participate in the selection process in view of their eligibility cannot be taken away in the manner as is sought to be done. The Respondents ought to act in a more responsible manner while dealing with rights of citizen guaranteed by Article 16 of the Constitution.

5.6 For that the action of the Respondents ought to have conformed to the requirement of administrative fair play and doctrine of acting fairly. To the aforesaid extent the impugned action is violative of the rules of natural justice.

5.7 For that the malafide exercise of power by the Respondents and more particularly the Respondent No.2 has to be inferred from the facts of the present case as well as the attending circumstances.

5.8 For that in any view of the matter the impugned action is legally not sustainable and the same is liable to be set aside and quashed.

6. Details of remedies exhausted :

The applicants beg to state that they have no other alternative remedy than to approach this Hon'ble Tribunal by way of filing this application under the relevant provisions of law.

7. Matter not previously filed or pending before any other Court :

The applicants further beg to declare that, they have not previously filed any application, writ petition, or suit before any court or authority or any other Bench of the Hon'ble Tribunal regarding the grievance for which this application has been made nor they are pending before any one of them.

8. Relief sought for :

On the fact and circumstances, the applicants pray for the following reliefs :

- (a) For a declaration that the written test held on 07.01.2001 pursuant to Employment Notice No. 2/99 in respect of posts covered by Category No.06 is illegal, null and void.
- (b) To direct the respondents to hold a fresh written examination for Category No.06 post by giving wide publicity.
- (c) To direct the Respondents to hold the examinations in the Centres notified in the Employment Notice No.2/99 only.
- (d) To direct the respondents to hold examinations under the Railway Recruitment Board, Guwahati at Guwahati only.
- (e) To pass any other order/orders as this Hon'ble Tribunal may deemed fit and proper.
- (f) To award cost of the proceedings.

9. Interim order pryed for :

To issue a interim direction to the Respondent No.2 not to publish the results of the

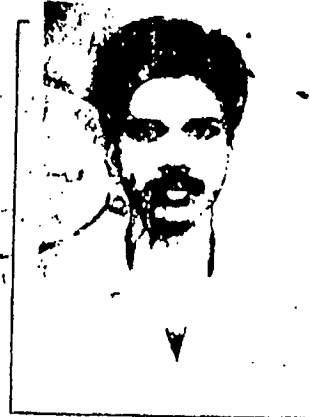
