CHOWDHURY. J. (V.C.)

The issue relates to recruitment for Vocational Course in Railway Commercial for the Academic Year 2001-2002. Ms Mou Datta, daughter of the applicant was also an aspirant for the Vocational Course in Railway Commercial (VCRC for short). The admission to the VCRC are made through written examination followed by viva-voce test. The The Railway Recruitment Board (RRB for short) invited applications from eligible candidates for admission to the VCRC for the academic year 2001-2002. Ms Datta applied for the same under the OBC category. She was issued a call letter by the RRB for the preliminary examination

that was held on 18.2.2001. The result of the preliminary examination was declared by the RRB on 14.7.2001. In the result the name of the applicant's daughter appeared. Accordingly she received a call letter from the RRB for the main written examination which was scheduled to be held on 12.8.2001. She came out successful in the main written examination held on 12.8.2001. She thereafter received the call letter for the viva-voce test. She appeared in the viva-voce test which was held on 16.10.2001. She carried the impression that she did well in the viva-voce test. The result was published in the daily newspaper declaring 39 candidates successful. The result of one candidate was not published. The name of the applicant did not appear there. Hence this application questioning the legitimacy of the selection. According to the applicant his daughter did well in the examination and therefore, she ought to have been selected in the process.

2. The respondents contested the case and submitted their written statement. It was stated in the written statement that the answer sheets of the written examination were evaluated in computer optical marks recorder. 85% marks were allotted for the written examination and 15% marks were allotted for the viva-voce test. In the viva-voce test there were four Junior Administrative Officers excluding the Chairman, one from the department, one from SC/ST community, one from OBC community and one from minority community. The result was declared on the basis of the performance in the written examination and viva-voce test.


3. We have heard Mr M. Chanda, learned counsel for the applicant and Mr J.L. Sarkar, learned Railway Counsel. The whole issue pertains to the process of selection. A person is not entitled to be selected as of right, but is, undoubtedly, entitled for a fair consideration. In the instant case, the Railway Authority notified the process of recruitment, entertained the applications of the candidates

and made assessment on merits. Mr Chanda contended that all throughout the daughter of the applicant had a brilliant track record and in the light of her performance there was no justification for not selecting her.

4. Mr J.L. Sarkar, learned Railway Counsel, fairly placed before us the entire records. The authority decided to hold the test for the VCRC, assessed the individual merit by taking note of their written examination and the viva-voce test. Marks obtained in the School Leaving Examination cannot be the index for selecting such persons. Candidates must qualify themselves in the eligibility test. On assessment of all the aspects of the matter, the procedure adopted by the respondents cannot be said to be unjust or unfair. There is no discernible infirmity in the process of selection requiring interference by this Tribunal.

5. In the circumstances we find no merit in this application and the same is dismissed. There shall, however, be no order as to costs.

The respondents in the above case most respectfully beg to state as under :

1. That the respondents have gone through the original application and have understood the contents thereof.
2. That the respondents do not admit any statement except those which are specifically admitted in this written statement. Statements not admitted are denied.
3. That before traversing the parawise statement of the original application the respondents beg to state the brief history of the case as under:

The written examination for VCRC for 2001-2002 was held on 18.02.2001. Second stage examination was held on 12.08.2001. Viva-voce was held from 15.10.01 to 18.10.01. Result was declared on 06.11.2001. 39 candidates (UR-7, SC-5, ST-7, OBC-19 and handicapped-1) were declared passed against 40 posts (UR-19, SC-05, ST-07, OBC-08 and



handicapped-1). Result of one candidate was withheld for non receiving of vigilance clearance. The daughter of the applicant did not come under the zone of consideration. 9

4. That in reply to the statements in para 4.1 to 4.2 it is stated that as per procedure no correspondence was made to the candidate except declaration of result. Percentage of marks in Board of Secondary education is taken into consideration when the candidate declared passed in VCRC examination for admission which is a 2 year job linked course.

5. That in reply to the statements in para 4.6 it is stated that the result was declared caste-wise separately. The roll numbers starting with digit 1 represents general candidates. Similarly 2 for SC, 3 for ST, 4 for OBC and 5 for handicapped. It is also stated that if a reserved candidate secure higher marks he will be placed in UR category and thus number of UR candidates may be downsize. Number of reserve candidate so placed in the UR category will be made good from the lower merit of that community.

6. That in reply to the statements in para 4.7 to 4.11 it is stated that while declaring the result utmost care was taken. Result was declared for 39 candidates. Result of one candidate could not be declared due to non receipt of vigilance report. It is denied that unfair action was adopted in the examination process. The answer sheet of written examination were evaluated in computer optical mark recorder. 85% marks were allotted for written examination.

and 15% marks were allotted for the viva-voce. In the viva-voce there were 4 Junior Administrative Officers excluding the Chairman, one from department, one from SC/ST community, one from OBC community and one from minority community. Result was declared on the basis of the performance in the written examination and viva-voce test. Marks obtained in schools examination was not taken into consideration. It is further stated that the result declared is correct and final.

7. That in the facts and circumstances of the case the application deserves to be dismissed with cost.

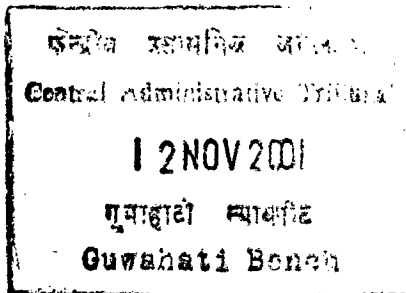

2. Jurisdiction :

The applicant declares that the subject matter of the application is within the jurisdiction of the Hon'ble tribunal.

3. Limitation :

The applicant declares that the application is within the period of limitation under section 21 of the Administrative Act, 1985.

4. Facts of the case :

4.1 That the applicant and his daughter Miss Mou Datta are citizens of India and as such are entitled to the right and privileges guaranteed by the constitution of India. The applicant and his daughters belong to the backward class community.

4.2 That the daughter of the applicant Miss Mou Datta, was born on the 3RD day of February 1986. She passed the Madhyamik Pariksha (Secondary Examination), 2001 under West Bengal Board of Secondary Education which was held in the month of February, 2001 and was placed in the First division. She secured 79% of marks in aggregate in the said Examination.

4.3 That the applicant begs to state that Railways provide Vocational Course in Railway Commercial (for Short VCRC) for the appointment to the post of Railway Commercial clerk and Ticket Collector. The admission to VCRC are made through

the written examination followed by a viva-Voce test. The written examination and the Viva-Voce test for admission to VCRC are conducted by the Railway Recruitment Board. The candidates appearing in 10th standard or equivalent examination expecting to secure 50% marks (for SC, ST and OBC 40% ) in 10th standard or equivalent examination are eligible to apply for admission to VCRC. It is also stated that the vocational course in Railway Commercial is a 2 year job linked course. The successful candidates with 55% marks ( in case of SC, ST and OBC 45%) of the VCRC are appointed directly to the post of Commercial clerk or Ticket Collector in the Railways.

4.4 That the Railway Recruitment Board (for short RRB) Patna and Guwahati by notification No.RRB/PAY/3/2000-2001 called for application from the eligible candidates for admission to VCRC for the academic year 2001-2002. It was also advertised in the daily news paper " Karmasansthan" dated 30.10.2000. The daughter of the applicant applied to the RRB, Guwahati. The total number of vacant posts under N.F.Rly. as advertised are 40 (General- 10 posts, SC-5posts, ST-7 posts, OBC-8 posts and handicapped persons -1 post). The daughter of the applicant applied under the OBC category. She was issued the call letter by RRB, Guwahati for preliminary examination which was held on 18.02.2001. The result of the said preliminary written examination was declared by the RRB, Guwahati on 14.07.2001 in the daily news paper " The Assam Tribune" and she qualified and was found eligible for being called to appear in the main written examination which was scheduled on 12.08.2001. Accordingly. She received a call letter from the RRB, Guwahati for the main

written examination which was held on 12.8.2001.

Copy of the call letter for preliminary written examination is enclosed as Annexure - A.

Copy of the call letter for main written examination is enclosed as Annexure - B.

4.5 That the daughter of the applicant came out successfully in the main written examination also which was held on 12.8.2001. She received a call letter dated 15/9/2001 for viva - voce test from the RRB, Guwahati. The viva-Voce test was taken on 16/10/2001 at RRB, Guwahati and she did very well in the viva - voce test. Apportionment of marks for written test and viva-voce was never published.

Copy of the call letter dated 15/9/2001 is enclosed as Annexure-C

4.6 That the applicant begs to state that his daughter did very well in the written examinations as well as in the Viva - Voce test. He also humbly submits that the result of written examinations did not mention the number of successful candidates under General, SC, ST, OBC and handicapped category separately. The RRB, Guwahati did not take proper care while publishing the result of the written examinations and kept the bonafide candidate into the darkness.

4.7 That the respondent No.2 perblished the result of the Viva-Voce test in the daily new's paper 'The Assam Tribune' on 6.11.2001. On latter surprise, the daughter of the ~~app-~~

applicant found that she has not been selected for the VCRC for 2001-2002. This time also the RRB, Guwahati has not taken proper care while publishing the result. The RRB, Guwahati declared 39 candidate successfull. One post is yer kept unpublished. It was also not declared as how many candidates have been selected against each category i.e. general, SC,ST,OBC and handicapped. Instead the RRB, Guwahati made a declaration that it is not responsible for any typeographical error. It is stated that the respondent No.2 has published the result in a very casual manner and the reason for non-discloser of successfull candidates under each category gives scope for genuine suspicion. The respondent No.2 has acted whimsically and arbitrarily and with some ulterior motive. The matter of reservation for SC/ST/OBC has been deliberately kept undisclosed which is not just and fair. Non-Transperant administrative action is patent in the case.

Copy of the daily news paper 'The Assam Tribune ' dated 6/11/2001 containing the result of VCRC is enclosed as Annexure - D.

4.8 That applicant humbly begs to state that his daughter is a brilliant student. She secured 79% of marks in her secondary examination and was placed in the 1st division. It is also submitted that she did very well in both the written examination as well as in the Viva-Voce test and there was every chance for her selection to the VCRC. It is stated that she was victimised for reasons best known to the respondents and unfair actions adopted by the RRB Guwahati. She is very much confident that if the Hon'ble

Tribunal is pleased to call for the records, she will be found in a very good place to be considered for VCRC. The applicant very humbly states that he has come to know that in a number of cases the irregularities in the process of recruitment by the RRB, Guwahati has come to the light in cases before the Hon'ble Tribunal.

Secondary Examination is enclosed  
as Annexure - E

4.9 That the applicant also begs to state that the respondents did not mention the allocation of marks for written examination and Viva-Voce test. The applicant submit that his daughter has been made a victim of arbitrary action, and a process which is not just and fair, which has done undue favour to others. The non-disclosure of reason for not considering 40 candidates against 40 posts is also the result of whims and arbitrariness of the respondents ( 39 candidates has been selected against 40 posts ). Malice in fact and malice in law is patent in the facts and circumstances of the case.

4.10 That the respondents have started the process for taking in the candidates for the VCRC for 2001-2002 before completing the preparation of the list of successful candidates. The preparation of the list has not yet been finalised. It is stated that if the candidates are allowed to join and are admitted into the course it will also not be just and fair to terminate the in-take of such candidates. The question of violation of rights of such persons

are also likely to come in. The respondents are aware of such a situation and has made an endeavour to avoid such situation by notifying that RRB is not responsible for typeographical error and reserved the right to make amendments to rectify the errors. It is humbly submitted that such course of action on the part of the respondents where the question of life of tendered aged boys and girls including the daughter of the applicant is likely to invite unhealthy consequences effecting the future of the candidates. The VCRC is linked with the bread and butter of the candidates and does not deserve to be disposed of in such casual manner. The entire list dated 5.11.2001 deserves to be reviewed and modified and finalised.

4.11 That the applicant has come to know that the RRB has already advised the persons against the roll numbers notified in the provisional <sup>list</sup> ~~lets~~ dated 5.11.2001 to report respondent No.3 for further course of action and the said respondent will take further action on this provisional list.

5. Grounds for reliefs with legal Provisions :

5.1 For that the respondents have not taken peoper care while publishing the result of VCRC for 2001-2002 and published the same in a sloth sod manner.

5.2 For that the daughter of the applicant has been made victim of action which is not just and fair.

5.3 For that possibility of typeographical error in the declared/published result is manifest in the notification dated 5/11/2001.

5.4 For that non-disclosure of the successful candidates under reserved and unreserved category separately is violative <sup>of</sup> norms and process of selection.

5.5 For that keeping one post vacant, 39 candidates being selected against 40 posts, and not disclosing reason thereof is the result of whims of the respondents.

5.6 For that the acts of the respondents is the result of arbitrariness and whimsical and offend Article 14 of the Constitution of India.

5.7 For that malice in fact and malice in law is the reason for not selecting the daughter of the applicant.

5.8 For that the act of the respondents is against the principles of administrative fair play and is violative of the Directive principles of State Policy.

5.9 For that adopting of such unfair process and reserving that the respondents are not responsible for their own acts in the matter of such vocational course offends Article 21 of the constitution of India.

6. Details of remedies exhausted :

There is no remedy under any rule and this Hon'ble Tribunal is the only forum for redressal of the grievance.

7. Matters not previously filed or pending before my other court :

The applicant declares that he has not filed any other case in any tribunal, court or any other forum on the subject matter.

8. Reliefs sought for :

Under the facts and circumstances of the case, the applicant prays for the following reliefs :

8.1 The respondents be directed to review the select list dated 5/11/2001 and prepare a fresh and final correct list of the candidates selected.

8.2 The record be called for and on being satisfied, the respondents be directed to select the daughter of the applicant to be VCRC for 2001-2002.

8.3 Any other relief /reliefs the Hon'ble Tribunal may deem fit and proper.

The above reliefs are prayed for on the grounds stated in para 5 above.

9. Interim relief prayed for :

During the pendency of this application the applicant prays for the following interim reliefs :

9.1 The provisional select list with possible typographical error be stayed /suspended.

9.2 Candidates to the VCRC /course be admitted after preparation of the final and correct list.
