CHOWDHURY J.(V.C.) :

The legality and validity of the order transferring the applicant along with the post vide order dated 12.10.2001 is the subject matter of the Original Application in the following circumstances ;

1. The applicant was first appointed as Assistant Hydro geologist and joined under the respondents in the year 1977. Thereafter he was appointed to the post of Junior Hydro geologist through the UPSC^{in 1978} and thereafter promoted to the post of Scientist-C in the year 1988. In the year 1994 he was promoted as Sr. Hydro geologist Scientist-D. In due course the applicant was posted at the office of the Regional Director, Central Ground Water Board, N.E.Region, Guwahati as Superintending Hydro geologist and he joined the said duty on 21.1.2001. By office order No.461 of 2001 dated 4.6.2001 the applicant alongwith four other officers of Hydro geological discipline were posted against their functional posts designated as Superintending Hydro geologist. By the said order the place of posting was shown as CGWB, Guwahati. While he was working as such, by the impugned order bearing office order No.769 of 2001 dated 12.10.2001 the applicant was transferred to CGWB, State Unit Office, Agartala alongwith the post with immediate effect. By the said order the applicant was directed to hand over the charge of Head of office in respect of N.E.Region, Guwahati to Sh.G.C. Shah, Senior Hydro geologist (Scientist-D) and proceed to Agartala immediately. According to the applicant, the said

order emanated due to improper motive imputed to respondent/ Nos.5 & 6. According to the applicant, the respondents did not take the objection raised by the applicant regarding allotment of tenders for Spring Development works in good ^{grace.} In _{he} this regard, ^{he}referred to communication sent by him vide communication dated 27.3.2001. The applicant submitted that he was presurised by the respondent No.6 by successive telephone calls for withdrawing his letter, which according to the applicant, was recorded in his letter dated 12.4.2001 addressed to the respondent No.6. The applicant also indicated about his encounter with its office in connection with the visit of Hon'ble Minister of State for Water Resources in January, 2001 as indicated in Annexure-VI Series. The applicant also contended that the order was passed not in public interest, but the same was passed as punitive measure for the reasons stated above. The applicant contended that at Guwahati office with a Superintending Hydro geologist, the applicant was meant to be posted in the Regional office not at the Unit office. The applicant in support of his contention referred to the statement showing the distribution Group-A distribution of posts and mentioned that in N.E.Region there is only one post of Superintending Hydro geologist and that post was meant for Regional Office at Guwahati and there was no such in the Unit office. The applicant contended that with a view to get rid of him, he was transferred out to Agartala without any public interest. It was further stated that after his transfer by the impugned order, the post in question in the Regional office was filled up by another officer, who was brought to Guwahati alongwith the post.

2. The respondents submitted its written statement denying and disputing the claim of the applicant. In the written statement the respondents stated that the applicant was transferred to State Unit office at Agartala along with

the post for more effective implementation/monitoring of programmes of SUO, Agartala being a senior Supervisory officer, in public interest. The respondents also stated that for administrative control, the Unit offices and the Divisions have been placed under the administrative control of the Regional Director of the Region in which the State Unit officers and Divisions are located. It was also stated that the Regional Director happened to be the Head of the office of the Region whereas the other officers posted in the Region/State Unit office/Division were always lower in rank and pay scale. In the instant case the applicant ~~xxx~~ a Scientist -D in the pay scale of Rs.12,000- 16,500/- was nominated as Head of office of the Regional Directorate, N.E.Region, Guwahati as the post of Regional Director was lying vacant. Consequent to the transfer of the applicant another officer who was also Scientist 'D' in the same pay scale had to be nominated as Head of office of the Regional office at Guwahati as the post of Regional Director was lying vacant. The respondents also stated that the applicant was posted to a functional post of Superintending Hydro geologist by virtue of his being a Senior officer in the Hydro geology discipline. There was no change in the pay scale and status what he was having prior to his posting as Superintending Hydro geologist. At Para 8 of the written statement it was also denied that the applicant was pressurized to pay the financial concurrence. At Para 15 of the written statement, it was averred that it was within the jurisdiction of the Board to deploy its officers and staff anywhere in India depending on the requirement of work load and exigency in public interest. Since there was no Senior Supervisory Officer at SUO, Agartala and the progress of SUO was slowing down day by day, due to non availability of a senior officer, it was considered necessary to post the applicant at SUO, Agartala being a Senior Supervisory

officer for effective implementation of Field Season program. Accordingly the post of Superintending Hydro geologist was transferred to SUO, Agartala from N.E.Region, Guwahati to draw the pay and allowance of the applicant to avoid financial hardships.

3. I have heard Mr.M.Chanda, learned counsel for the applicant and also Mr.A.Deb Roy, learned Sr.C.G.S.C. at length. The transfer and posting is, no doubt, within the confines of the administration. The authority is invested with the discretion. But then such discretion are not unfettered. Such discretionary exercise of power is to be confined within the bounds of the power assigned to them. It must be exercised lawfully reasonably freed from whim and caprice. In the instant case the applicant was posted as Scientist-D (Senior Hydro geologist) at Central Ground Water Board, N.E.Region, Guwahati Regional Head Quarter. There are three Units, namely at Itanagar (Arunachal Pradesh) Agartala (Tripura) and at Shillong (Meghalaya). Admittedly, there was one sanctioned post of Superintending Hydro geologist in the Regional office. The applicant, therefore, had to be taken with the post there and subsequently they had to find out and brought his successor by appointing one Mr.A.K.Bakshi, Scientist-D as In-Charge of the Regional office and designated as Regional Director In-Charge as appeared from the verification. Save and except, the bald statement made at Para 15 of the written statement that there was no Senior Supervisory officer at SUO, Agartala and the progress of SUO was slowing down day by day, due to non availability of a senior officer, therefore, it was considered necessary to post the applicant at SUO, Agartala. no other materials were furnished in support of the claim. The criterion of public interest is not subjective, it is objective in the sense that it is subject to independent scrutiny. The sanctioned strength of officers of the department in N.E.Region, as mentioned above was one post of

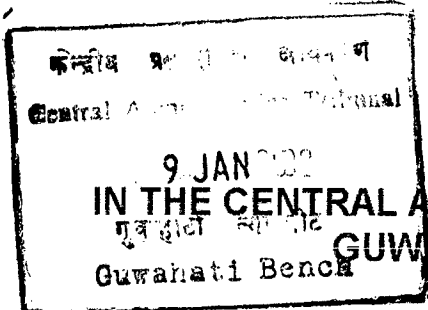
Superintending Hydro geologist that was available at Guwahati. The same officer, under the working Scheme was looking after three units. No reasons were assigned as to why all of a sudden a senior officer had to be shifted that too with the post. There were definite allegations imputing malafide against the persons concerned. They were impleaded as party respondents. They chose not to contest, by filing their reply and the Regional Director In-Charge only verified the statement on behalf of the respondents. No other materials in support of the claim of the respondents for abrupt transfer of the applicant alongwith the post was cited. It may be stated, as was argued by Mr. A. Deb Roy, learned Sr. C.G.S.C. that transfer is an incident of service and an employee cannot complain against the transfer, unless such order is passed in breach of any statutory provisions. The power of judicial review is, no doubt, limited. But then the order of transfer may be punitive or may be vitiated by malafide and arbitrariness. A civil servant is engaged in public duty. He is supposed to act bonafide and in the public interest. In discharge of the public duty such officer, in appreciating and appraisal in the process of administrative action, is free to make critical analysis of such move. An officer is not to be penalised for freely expressing in mind as regards to the steps to be taken by the authority concerned. The written statement including verification leaves no room for giving credence to the pleadings of the respondents. The necessity of the verification of a written statement is to satisfy the Court about the authenticity of the averments made in the written statement. A public servant is also entitled for a fair treatment and he should be allowed to put his point of view freely in the decision making process involving public work and public finance. As mentioned earlier that the power conferred on the authority is not arbitrary. At any rate, the authority failed to justify its

actions even by producing the records as to why the authority had to take such an action abruptly. Materials on record established abuse of discretion and where the respondents declined to supply any justification at all for its decision. It can be reasonably inferred that the respondents had acted unlawfully in passing the impugned order (Reference - Padfield -vs- Minister of Agriculture, Fisheries, Food (1968) AC 997).

For all the reasons stated above, the impugned order dated 12.10.2001 is seemingly arbitrary and discriminatory and on that ground, the order is liable to be set aside, accordingly the impugned order dated 12.10.2001 is set aside.

The application is thus allowed. There shall, however, be no order as to costs.

DETAILS OF THE APPLICATION

1. Particulars of order against which this application is made.

This application is made against the impugned office order No. 769 of 2001 issued by the Respondent No.4 under No. 3-447/76-Esst./8384 dated 12.10.2001 transferring the applicant along with his post from the Regional office, NER, Guwahati to a State Unit Office, Agartala, placing him under a junior, in gross

violation of the principles of service jurisprudence, adversely affecting the rank and status of the applicant.

2. Jurisdiction of the Tribunal.

The applicant declares that the subject matter of this application is well within the jurisdiction of this Hon'ble Tribunal.

3. Limitation.

The applicant further declares that this application is filed within the limitation prescribed under section-21 of the Administrative Tribunals Act, 1985.

4. Facts of the case.

4.1 That the applicant is a citizen of India and as such he is entitled to all the rights, protections and privileges as guaranteed under the Constitution of India.

4.2 That the applicant was initially appointed as Assistant Hydro geologist and joined under the respondents in the year 1977. Thereafter he was appointed to the post of Junior Hydro geologist through the U.P.S.C. in 1978 and eventually promoted to the post of Scientist C in the year 1988 and promoted as Sr. Hydro geologist (SC-D) in the year 1994. Thereafter, he was promoted to

certified

the post of Superintending Hydro geologist in the year 2001 and was transferred to the office of the Regional Director, Central Ground Water Board (in short CGWB), N.E.Region, Guwahati as Senior Hydro geologist in the pay scale of Rs. 12000/- to 16500/- and posted at the Regional office, Guwahati.

- 4.3 That the applicant being the senior most officer of the Respondent Department in the Region, was declared to function as the Head of the office for CGWB, NER, Guwahati vide Office Order No. 248 of 2001 issued under No. 14-6/98-Sci(Estt.)-2306 dated 27.3.2001 by the Respondent No. 7 and had since been discharging his duties and responsibilities as the in-charge, Regional director for CGWB, NER, Guwahati.

A copy of the office order No. 248 of 2001 is annexed herewith as Annexure-I.

- 4.4 That while working as the in-charge Regional Director, CGWB, Guwahati, the applicant was further promoted to the post of Superintending Hydro geologist (Scientist-D) and posted in the same station i.e. GWB, NER, Guwahati vide Office Order No. 461 of 2001 issued under No. 14-10/2000-Sci.Estt.-4419 dated 04.06.2001 and had been continuing to Head the Region, shouldering all the administrative, technical and other responsibilities.

4.5 ✓ That during the tenure of the applicant as stated above, a sister wing under the Ministry of Water Resources, namely, the Water And Power Consultancy Services (in short WAPCOS) invited tenders for Spring Development works proposed to be undertaken in the District of Kamrup by the office of the Deputy Chief Engineer, located at Dispur Guwahati. The estimated cost of the proposed work was Rs. 4,40,114/-. The proposal for the said work was initiated by the office of the Regional Director i.e. the office of the present applicant and the execution of the construction works was entrusted to the aforesaid WAPCOS which then invited the tenders etc.

On receipt of the Tenders, it was found that the most of the tenders quoted the rates much above the estimated cost and was exceeding by even as high as 80% of the estimated cost. The office of the Deputy Chief Engineer, WAPCOS compiled the comparative statement etc. of the Tenders received and forwarded the same to their Head office at New Delhi for approval etc.

4.6 That the Chief Engineer, WAPCOS vide his letter dated 20.2.2001 forwarded the evaluated tenders and detailed papers to the applicant requesting him to accord financial concurrence for the tendered amounts exceeding the limits of variation and arrange for

placing the funds from CGWB to WAPCOS for taking up the works. This was followed by another FAX message dated 23.3.01 from the Chief Engineer, WAPCOS requesting the applicant to concur in the tendered amounts.

A copy of letter dated 20.2.2001 is annexed herewith as Annexure-III.

- 4.7 That the tendered rates being unreasonably high and exceeding the acceptable/reasonable limits, the applicant was constrained to accord financial concurrence and as such he wrote back to the Chief Engineer, respondent no.8, WAPCOS vide his letter No. 44/RWH/CGWB/NER/2001-1975 dated 27.3.2001 requesting him to re-float the tenders with wide publicity so that a competitive quotations are received in order to limit the cost within the estimated/reasonable amount.

A copy of the letter dated 27.3.2001 is annexed herewith as Annexure-IV.

- 4.8 That the aforesaid action of the applicant was viewed seriously by the higher officials and the applicant was pressurised to accord financial concurrence. The member (SML) i.e. the Respondent No.6 made three successive telephone calls to the applicant and asked him to withdraw his letter dated 27.3.2001 so that the

tenders can be accepted for the reasons best known to him. The applicant vide his confidential letter bearing No. RD/SD/CGWB/NER/2001-174 dated 12.4.2001 addressed to the Respondent No. 6 explained the possible implications of the withdrawal of the aforesaid letter dated 27.3.2001 as demanded and instead suggested for a meeting to be arranged between the officers of CGWB and WAPCO for sorting out the matter and the recorded minutes of the meeting might be treated as a substitute for the letter of withdrawal. Alternatively, the applicant suggested that a letter may be issued to him instructing him to withdraw his letter dated 27.3.2001 which he would comply with instantly.

Copy of letter dated 12.4.2001 is annexed herewith as Annexure-V.

4.9 That since the applicant was constrained by the existing Treasury Rules and Financial Rules of Government of India to concur in the aforesaid tenders which exceeded the permissible limit, he had no other option but to act as stated above which seemingly displeased the superior officers and even the Chairman, CGWB who is the Supreme authority of CGWB also expressed his strong displeasure on the matter.

4.10 That it is stated that as per the existing practice, whenever the Hon'ble Minister of Water resources, Government of India, New Delhi, pays her visits, a vehicle is arranged for her visit. The PRO of

the Hon'ble Minister submitted a bill for Rs. 6800/- for the use of two Tata Sumo vehicles during the Minister's visit in January, 2001 and the bill submitted in June 2001 which as per the advice of the Respondent No.6, was forwarded to the Head quarter for clearance. In the meantime the Hon'ble Minister paid a visit in August 2001 when the P.A. of the Hon'ble Minister asked for a departmental vehicle with the junior officer attached to the applicant and since no such vehicle was instantly available, the said junior officer explained the position to the P.A. of the Hon'ble Minister. This matter was later brought to the notice of the applicant and the applicant was asked to arrange for a Tata Sumo vehicle. The applicant most humbly explained that in view of the previous bill of Tata Sumo vehicles remaining still unpaid, it would be difficult to arrange the Tata Sumo vehicle again since it is not within his power and firmly assured that the departmental vehicle would be arranged for their use in the next morning by any means. Accordingly, the vehicle was sent in the next morning which they had not used and instead they rebuffed the officer who went for the purpose.

- 4.11 That eventually, the applicant received one D.O. letter No.3-447/78-Sci.Estt-475 dated 28.09.2001 from Director (Administration) CGWB, i.e. Respondent No.4 alleging misbehaviour by the applicant with the P.A. of the Hon'ble Minister resting on vehicle.

The Applicant was shocked to have such a letter and immediately replied to the Director (Admn) vide his D.O. letter No. 239 dated 08.10.2001 explaining the position and all details of the event and denying the alleged misbehaviour of any kind. A copy of his reply dated 08.10.2001 to Director (Admn) and was also forwarded by the Applicant to the Member (SML), the Respondent No.6 for their consideration and necessary action.

Copy of the letters dated 08.10.2001 are annexed herewith as Annexure-VI Series.

4.12 That it is stated that in all the circumstances stated above, the applicant was asked to do certain acts viz., concurrence of tenders by violating the Treasury and Financial Rules of Govt. of India, and arranging vehicles instantly which was not within his power and since the applicant was unable to act in violation of the rules and procedure laid down by the Government, he was targeted by the Respondents for no fault of his.

4.13 That in a bid to fulfil their grudging motive on the applicant as stated above, the Respondents issued the impugned office order No. 769 of 2001 issued under No. 3-447/76-Sci. Estt. -8384 dated 12.10.2001 transferring the applicant from the post of Superintending Hydro geologist (Scientist-D), NER, Guwahati to the State Unit Office, Agartala along with the post and instructing him to hand over his charges of the Head of office to Shri G.C.Saha,

Senior Hydro geologist (Scientist-D), who is much junior to the applicant in rank and status in service, with a mala fide intention.

A copy of the impugned order dated 12.10.2001 is annexed herewith as Annexure-VII.

- 4.14 That pursuant to the order of transfer dated 12.10.2001 as stated above, the applicant was relieved of his duties from Regional office, Guwahati vide office order No. 378 of 2001 bearing No. 1206 dated 30.10.2001 and accordingly he took over at the State Unit Office, Agartala with effect from 31.10.2001 (F.N.) vide his joining report No. 3583 dated 31.10.2001.

Copy of the relieving order dated 30.10.2001 and joining report dated 31.10.2001 are annexed herewith as Annexure-VIII and IX respectively.

- 4.15 That the applicant begs to state that by the impugned order mentioned above, the applicant has been shifted from an office of higher status i.e. the Regional office to an office of lower status i.e. the State Unit office where there is no sanctioned post of Superintending Hydro geologist. It is evident from the statements of allocation of posts and statement of Staff position that there is only one post of Superintending Hydro geologist/Regional Director sanctioned for N.E. Region to be stationed at Regional Office,

Guwahati only and there is no such senior post for State Unit office, Agartala. But the Respondents acting in an Arbitrary manner and violating the allocated staffing structure, transferred the applicant to the State Unit Office, Agartala even by transferring the senior level post of the Superintending Hydro geologist from Guwahati to Agartala while this post is sanctioned for Regional office, Guwahati only. The order of this kind is an unprecedented one, and the same has adversely affected the rank and status of the applicant.

This apart, by the impugned order dated 12.10.2001 the applicant has been placed under one Sri G.C.Saha, Head of office, CGWB, NER, Guwahati who is junior to the applicant. It is evident from the Draft Seniority list published by the Respondent No.4 vide No. 14-14/2000-Sci.Estt.-5299 dated 26.07.2001 wherein the name of the applicant appears at Sl. No. 17 whereas the name of Sri G.C.Saha appears at Sl. No. 43.

Copy of statement of allocation of posts, statement of staff position and Draft Seniority List dated 27.7.2001 are annexed herewith as Annexure-X, XI and XII respectively.

- 4.16 That the applicant begs to state that the applicant being a disciplined officer and a man of integrity has complied with the impugned order of transfer duly and has assumed his office at Agartala immediately showing due respect to the order. Thereafter,

the applicant made a representation on 2.11.2001 to the Chairman, CGWB, Faridabad highlighting the injustice and humiliations meted to him by way of transfer to a State Unit Office, Agartala which tantamounts to his demotion and praying for his transfer from N.E. Region to Bangalore/Chennai. His representation could not yield any result as yet.

Copy of representation dated 2.11.2001 is annexed herewith as **Annexure-XIII.**

- 4.17 That the applicant most humbly states that the honest and disciplined gestures of the applicant in the cases stated above and his adherence to act as per the rules laid down by the Government of India, instead of being appreciated, have been viewed otherwise by the Respondents who in order to feed fat their personal whims and caprices, have acted in an arbitrary unjust, unfair manner and with mala fide intention transferring the applicant as stated above, violating all principles of natural justice and cannons of law and inflicting mental torture on the applicant. As such finding no other alternative, the applicant is approaching this Hon'ble Tribunal for protection of his legitimate rights and interests and it is a fit case for the Hon'ble Tribunal to interfere with and to protect the rights and interests of the applicant directing the respondents to quash their impugned order dated 12.10.2001, restoring him to his earlier

position i.e. to the post of the Head of Office, NER, Guwahati and to consider his prayer for transfer to Bangalore/Chennai.

4.18 That this application is made bonafide and for the cause of justice.

5. Grounds for relief(s) with legal provisions.

5.1 For that the applicant is the senior most officer in the N.E. Region.

5.2 For that the applicant being the senior most officer in rank and status in the Region is entitled to Head the Region.

5.3 For that the applicant had already been working as the Head of the Region at C.G.W.B., Guwahati.

5.4 For that the applicant has been posted in a State Unit Office, Agartala where there is no sanctioned post of Superintending Hydro geologist (Scientist-D) which as per the allocation, is positioned at Guwahati only in the NER.

5.5 For that the applicant has been placed to work under a junior which is against all principles of service jurisprudence.

5.6 For that the respondents by way of arbitrary transfer with mala fide intention have inflicted mental torture on the applicant.

- 5.7 For that the applicant submitted representation to the respondents which could not yield any result.
- 5.8 For that the post of Superintending Hydro geologist is not meant for State Unit Office in any region throughout the country as evident from allocation of posts.
- 5.9 For that there is no decision regarding upgradation of State Office at Agartala, at any point of time before or after, the passing of impugned order of transfer and posting of the applicant is therefore arbitrary, illegal and with a mala fide intention.
6. Details of remedies exhausted.

That the applicant states that he has no other alternative and other efficacious remedy than to file this application. Representation submitted by the applicant to the highest authority i.e. the Respondent No. 7 could not yield any result.

7. Matters not previously filed or pending with any other court.

The applicant further declares that he had not previously filed any application, Writ Petition or Suit regarding the matter in respect of which this application has been made before any court or any other

authority or any other Bench of the Tribunal nor any such application, Writ Petition or Suit is pending before any of them.

8. Reliefs sought for :

Under the facts and circumstances stated above, the applicant humbly prays that your Lordships be pleased to issue notice to the respondents to show cause as to why the reliefs sought for by the applicant shall not be granted, call for the records of the case and on perusal of the records and after hearing the parties on the cause or causes that may be shown, be pleased to grant the following reliefs :

2 8 8.1 That the Hon'ble Tribunal be pleased to set aside and quash the impugned order dated 12.10.2001 (Annexure-VII).

8.2 That the Respondents be directed to restore the applicant to his earlier position i.e. to the post of in-charge Regional Director/Head of office, NER, Guwahati.

8.3 That the Respondents be directed to consider the transfer of the applicant to Bangalore/Chennai as prayed for in the representation dated 2.11.2001.

8.4 Costs of the application.

With reference to your D.O. No. 3-447/73-Sci.Estt-475 dated 20.09.2001 I am herewith furnishing the following details for your kind consideration. Further, I bring to your kind consideration that injustice has been caused to me. Please rectify the same by posting me at Bangalore/Chennai. I hope I will not be given room for seeking justice from the court of law only.

I shall be grateful for the act of kindness in relieving me from this region and humiliation.

The Head of the Regional Directorate is designed as Regional Director, in the pay, scale of Rs. 14300-18300. The Regional Director, happens to be the Head of Office of the Region where as the other officers posted in the Region/ State Unit Officer Division are always lower in rank and pay scale. In the instant case the applicant (Shri K. Keerthiseelan) who is Scientist 'D' in the pay scale of Rs. 12000-16500 was nominated as the Head of Office of the Regional Directorate NER Guwahati as the post of Regional Director was lying vacant. However, due to effective implementation/monitoring officer was posted at Agartala. Consequent to his transfer, ~~an~~ another officer who was also Scientist 'D' in the same pay scale had to be nominated as Head of Office of Regional Office at Guwahati as the post of Regional Director was lying vacant. Declaring an officer as Head of the Office of the Region was a temporary arrangement in the absence of a Regular Regional Director and this officer was Head of the Office for the Regional Office only. This officer was not delegated with administrative and financial powers of the Regional Director.

Now another Senior officer namely Shri A.R. Bakshi has been posted in the Regional office at Guwahati. Thus in view of the above position, the allegation of the applicant that he ~~has~~ been

placed under a junior officer does not sustain.
As such the allegation is denied.

2. That with regard to para - 2 of O.A., the respondents beg to offer no comments.

3. That with regard to para - 3 of O.A., the respondent beg to offer no comments.

4. FACT OF THE CASE.

That with regard to para 4.1 & 4.2 of OA. the respondents beg to offer no comments. These are matter of records.

5. That with regard to para - 4.3 of O.A., the respondent beg to state that the Regional Director happens to be Head of office of the Region. However in the absence of the Regional Director, another senior most officer of the concerned Regiona is declared as Head of Office so that work of the Regional office may not suffer. Since no Regional Director is posted in the Regional Office at Guwahati, the applicant being senior most officer posted at Regional Office Guwahati was declared as Head of Office for Central Ground Water Board, NER till further orders(Annexure - 1 of the O.A.). As the applicant was transferred to SUO, A gartala, ^{next senior who was junior} another officer, senior to the applicant of the same rank was declared as Head of office and by doing so no order/ was issued to place the applicant under any other officer declared as Head of the office of the Regional Office, Guwahati.

6. That with regard to para - 4.4 of OA, the respondents beg to state that the applicant that ^{statement of the} he was promoted to the post of superintending Hydrogeologist, Sc. 'D' is misleading. It is submitted that a perusal of the office order 461/2001 (Annexure-2 of the O.A) would reveal that the applicant has been posted to a functional post of Superintending Hydrogeologist by virtue of this being a Senior officer in the Hydrogeology discipline. There is no change in the pay scale and status what he was having prior to his posting as Superintending Hydrogeologist.

7. That with regard to para - 4.5 to 4.7 of O.A. the respondents beg to offer no comments.

8. That with regard to para - 4.8. of O.A., the respondents beg to state that it is denied that applicant was pressurized to accord financial concurrence.

Shri Keerthi Seelan vide his letter No- 1806/44/CGWB/NER/RMII/2001 dated March 16 2001 requested the Member (SAM) Central Ground Water Board to accord ~~for~~ approval for the expenditure sanction of the approved proposal for construction of spring development in Assam state enclosing a comparative statement etc. indicating the price variation of estimated amount and the lowest tender value as received from the Chief Engineer, WAPCOS vide his confidential letter dated 20.2.2001. However, vide his letter dated 27.3.2001 Shri Keerthi Seelan again wrote a letter to Chief Engineer Water and Power Consultancy Services (WAPCOS) indicating that tender may be refloated with a wider publicity so that a competitive quotation received for finalizing

of construction of spring development. Since acceptance of tender, release of funds etc, is done by Member (SAM) and the proposal of Shri Keerthi Seelan vide his letter dated 16.3.2001 was under active consideration of the Competent authority, his letter dated 27.3.2001 in question was superfluous and not required as it was beyond his jurisdiction. The Member (SML) being his immediate supervisory officer pointed out that letter dated 27.3.2001 was contradictory to his earlier letter dated 16.3.2001 and since the whole matter was being considered by the higher authority, this letter was not required. Since Member Sustaining^{able} Management and Liason (SML) was not involved for giving financial concurrence of the project etc, the question of pressurizing by him on this issue did not arise.

9. That with regard to para - 4.9 of OA, the respondents beg to state that since the role of the applicant was merely the recommendory one, his recommendation in this case has been considered along with other matters brought out by the WAPCOS while finalizing financial concurrence by the competent authority. As such it is denied that superior officers and the Chairman, CGWB ~~xxxxx~~ were displeased with him on the matter and as such the allegation made by the applicant are contrary to the facts on record and the applicant has deliberately tried to mislead the Hon'ble Court for his own vested interest.

The respondent No- 4 has nowhere ~~mentioned~~ mentioned in the said letter about his misbehaviour with PS to IDS(WR), except calling a detailed report in the matter, as alleged by him in this para. Hence the intention of the applicant is totally wrong and misleading the Hon.ble Court.

12. That with regard to para - 4.12 of OA, the respondent beg to state that the submissions made against para - 4.8.4.9 & 4.11 above.

13. That with regard to para - 4.13 of OA, the respondents beg to state that for smooth functioning & for more effective implementation/monitoring of progress of the SUO, Agartala in public interest, he was therefore asked to hand over his charge of Head of Office, NER, Guwahati to Shri G.C.Saha

Scientist 'D' who was the next senior officer in the same grade available at Guwahati. Moreover, the competent authority of the Board has power to deploy any officer of the Board anywhere in India considering the need and suitability of the Office.

Meanwhile, Shri A.R. Bakshi Superintending Hydrogeologist, Sc. 'D' who is senior to the applicant joined at NER, Guwahati and he has been vested with the powers of HOO.

14. That with regard to para - 4.14 of OA, the respondents beg to offer no comments.

15. That with regard to para - 4.15 of OA, the respondents beg to state that it is submitted that the competent authority of the Board ^{has} Power to deploy the officers and staff anywhere in India depending on the requirement of work load and exigency in public interest. Since, there was no Senior Supervisory Officer at SUO, Agartala and the progress of SUO was slowing down day by day, due to non availability of a senior officer, therefore it was considered necessary to post the applicant at SUO Agartala being a senior supervisory officer for effective implementation of Field Season Program. Accordingly the post of Superintending Hydrogeologist was transferred to SUO, Agartala from ~~NER~~ NER, Guwahati to draw the pay and Allowance of the petitioner to avoid financial hardships. Hence there is no question of any arbitrary manner and violation of the government instruction being followed ~~the~~ by the Department with the transfer of the petitioner from NER, Guwahati to SUO Agartala.

it was absolutely necessary to position a HOO for NER Guwahati. Accordingly Shri G.C.Saha Sc.D (Of same rank) who was the next senior most officer available at NER Guwahati was declared as HOO for day to day functioning of the NER.

Here it is also pointed out that Shri A.R. Bakshi, Superintending Hydrogeologist who is senior to the applicant has joined NER, Guwahati with effect from 3.12.2001 and has been declared as HOO in place of Shri G.C.Saha.

16. That with regard to para - 4.16 of O.A. the respondents beg to state that the representation dated 2.11.2001 of the applicant was duly considered by the competent authority and he was replied vide letter dated 26.12.2001 (Annexure - II). 2

17. That with regard to para - 4.17 of O.A., the respondents beg to state that since the applicant has already joined his duty at SUC, Agartala on 31.10.2001 ^{officer} and an/senior to the applicant has been posted at NER Guwahati there is no question to quash the order dated 12.10.2001.

18. That with regard to para - 4.18 of O.A., the respondents beg to offer no comments.

19. That with regard to para - ~~5.1 to 5.9~~ 5.1 to 5.9 of O.A., the respondents beg to state that in view of the submission made by the answering respondents in the forgoing paragraphs, no grounds for relief sustain.

20. That with regard to para - 6 of OA, The

respondents beg to state that the applicant did not wait for a reply from the respondent regarding his representation and has filed this OA in hesitation.

21. That with regard to para- 7 of OA the respondents beg to offer no comments.

22. That with regard to para - 8 (Sub para 8.1 to 8.5) of O.A. the respondents beg to state that in view of the submission made by the respondents in reply to above paras of the OA, no relief admissible.

23. That with regard to para - 9(9,1)) of OA the respondents beg to state that as already submitted by the respondent in reply to para - 1 of the OA, since a senior officer, namely Shri A.R. Bakshi has already been posted at NER Guwahati as Head of the Office, therefore, interim relief sought by the applicant is not tenable.

24. That with regard to para - 10,11 & 12 of OA, the respondents beg to offer no comments.

The applicant above named most humbly and respectfully begs to state as under :

1. That the applicant categorically denies the statements made in paragraph 1 and 13 of the written statement and begs to state that the Regional Office, Guwahati of the Central Ground Water Board (CGWB) is the Controlling office for all the seven North Eastern States and there are three State Unit Offices under the said Regional Office which are located at Shillong (Meghalaya), Itanagar (Arunachal Pradesh) and Agartala (Tripura). These Unit Offices serve under the direct control and supervision of the Regional Director, NER, Guwahati and for all purposes, these State Unit Offices (SUO) are dependent on the Regional Office for allotment of fund etc. and even for the purpose of drawing salary. As such the State Unit Offices are not independent office but directly subordinate

to and dependent upon the Regional Office and hence "holding of independent charge of the State Unit Office, Agartala" by the applicant as stated by the Respondents are distortion of facts and misleading statements.

At the time of his transfer, the applicant was holding the charge of Regional Director and had been functioning as the Head of the entire N.E. Region. As such transferring the applicant who was the seniormost Officer in the N.E. Region, to an office of lower status (i.e. SUO, Agartala) on the pretext of implementation/monitoring of Programme of SUO, Agartala and placing a junior person in his place as the Head of the region is not only unfair but illegal and beyond any procedure known in the service jurisprudence. Under established procedures prescribed by law, it was prudent to post the next junior person to the SUO instead of the applicant and that junior person could also implement/monitor the programmes of SUO effectively, more so when he could be vested with even the higher responsibilities of Regional Director, however temporary the arrangement might be and the respondents have not explained any reason for such an unprecedented arrangement which can be sustained in the eye of law. It is a primary and cardinal principle that the senior most person will hold the senior most post (in the instant case the post of Regional Director is the seniormost post of the Region). In this context it is relevant to place the administrative set up of the Region under the CGWB before the Hon'ble Tribunal which is produced below :

State Unit Office	Division Office

From the above table it is clear that the Regional Director is the top position in the Regional Directorate followed by the Superintending Hydro geologist and both of them are positioned at Regional Directorate only and are not meant for any subordinate office i.e. unit office or Division Office. It is apparent from the manpower chart of even 2000-2003 of the N.E. Region, Guwahati that even after the posting of Shri A.R.Bakshi, a senior person in the post of Regional Director, the name of the applicant has been shown as the next senior most officer of NER, Guwahati (manpower chart annexed herewith).

This apart, as per the chart of status of Superintending Hydrogeologist under CGWB the Superintending Hydro Geologist in all other Regions have been posted in the Regional Directorate only and the applicant, as an isolated case has been transferred and posted from the Regional Directorate, NER, Guwahati to State Unit Office, Agartala. Further, no State Unit Office under the CGWB has been manned by an officer of the rank of Superintending Hydro geologist, except in the case of the applicant at SUO, Agartala which is indicated in the list showing the name of Officer in Charges of all the Unit Offices. The reason of such an

arrangement as an isolated case in respect of the applicant is neither explainable nor tenable.

Copy of manpower chart 2002-03 of N.E.R. Guwahati, status chart of Superintending Hydro geologists and list of Officer-in-charges of State Unit Offices are annexed hereto as **Annexure-I, II and III** respectively.

2. That the applicant categorically denies the statements made in paragraph 5 and 6 of the written statement and begs to submit that by posting the applicant at State Unit Office, the respondents already made him to work under a person junior to him who was placed as the Head of the Regional Directorate, Guwahati and it is immaterial whether a separate order was issued or not placing the applicant under the control of the Head of the Region which is automatic by operation of legal procedure.

Further, in the capacity of Superintending Hydro geologist, the applicant was shouldering higher responsibilities by taking over formal charges of the office and as such it was a functional promotion to a post of higher responsibilities and superior status for all practical purposes, no matter whether there was any promotion in respect of scale of pay or not and hence the contentions of the respondents are clearly aimed at misleading the Hon'ble Tribunal.

3. That with regard to the statements made in paragraph 8, 9, and 12 of the written statement, the applicant begs to reiterate that the applicant was pressurised over phone by the Respondent No.6 continuously for according financial concurrence and to withdraw his (applicants) letter

dated 27.3.2001 which the applicant was constrained to do in view of the Govt. rules and procedures.

The statement of the Respondents that the proposal of the applicant was under active consideration of the higher authorities is out and out a mis statement and suppression of facts. In fact, the unreasonable rates tendered by the WAPCOS were already accepted and approved by the respondents and even the funds were also released for the purpose which is evident from the letter issued under No. F.No. 13-1/CGWB/AR/NER/2001-1041 dated 20.4.2001 by the respondents to the CMD, WAPCOS.

Copy of letter dated 20.4.2001 is annexed hereto as **Annexure-IV.**

4. That with regard to the statement made in paragraph 10 of the written statement, the applicant begs to state that the bill sent in June, 2001 was processed by the Respondents in August, 2001 and meanwhile the PRO of the Hon'ble Minister and Member (SML) had been pressurising the applicant to pay the amount.
5. That the applicant categorically denies the statements made in paragraph 11 of the written statement and begs to state that the Respondent no.4 before issuing the D.O. letter under mention, talked over phone with the applicant when he alleged that the applicant had misbehaved with the staff of Hon'ble Minister and also informed that he was addressing a D.O. letter to the applicant on the matter which the applicant has to reply. Accordingly

the applicant received the D.O. letter dated 28.9.01 and sent his reply to the appropriate authorities, the contents of which pertain to the alleged mis behaviour as stated. The respondents in their statement under paragraph 11 has distorted the facts and has attempted to mislead the Hon'ble Tribunal with a different story. The fact that the D.O. letter was purely in connection with the false allegation of mis behaviour of the applicant with the staff of Hon'ble Minister and not merely a departmental issue as being pretended now by the respondents is quite evident from the fact that the respondents endorsed copy of each communication viz. transfer order, D.O. letter etc. to the P.S. to the Hon'ble Minister. Had the matter been simply a departmental issue and nothing else, then it is not understandable as to why it became necessary to endorse a copy of all those communications to the P.S. to Hon'ble Minister, which is a clear departure from the established normal procedure.

6. That the applicant categorically denies the statements made in paragraph 15 of the written statement and begs to submit that the Superintending Hydro geologist is posted only in the Regional Directorate in all the Regions under the C.G.W.B. and in none of the State Unit Offices elsewhere (even in N.E. Region) an officer of the rank of Superintending Hydro geologist has been posted and as such the posting of the applicant in a State Unit Office at Agartala is a lone and solitary instance which is a departure from the set pattern without any reason as has been stated and illustrated in para 1 above.

This apart, the contention of the respondents that a senior supervisory officer was required to be posted at Agartala for effective implementation of the programmes does not find any ground to stand since no work at all was carried out in State Unit Office, Agartala during the year 2001-2002 as evident from the cumulative progress report for the month of March, 2002 wherein no work has been shown against SUO, Agartala.

Copy of Progress Report is annexed hereto as **Annexure-V**.

7. That with regard to paragraph 16 and 20 of the written statement, the applicant begs to state that applicant did not receive any reply of his representation dated 2.11.01 even till 03.01.2002 and after waiting for long two months, the applicant had to approach this Hon'ble Tribunal for redressal of his grievance.
8. That the applicant emphatically denies the contentions made in paragraph 17 of the written statement and begs to state that the joining of the applicant at SUO, Agartala in compliance with the transfer order was only a disciplined gesture on the part of the applicant showing highest respect and loyalty to the official decorum and discipline which cannot be taken as a ground for regularising the misdeeds of the respondents. For every wrong, there is a remedy in law and in the instant case also the respondents illegal action is not without a remedy as pleaded by the respondents.

Further, the senior officer now posted at NER, Guwahati is the Head of the Region which is not a bar for posting the applicant as Superintending Hydro geologist as per the set pattern at NER, Guwahati and hence the impugned transfer and posting of the applicant at SUO, Agartala deserves to be quashed and the Hon'ble Tribunal be pleased to direct the respondents to transfer the applicant back to Guwahati as an immediate remedy and further to consider the transfer of the applicant to Bangalore/Chennai as prayed for.

9. That the applicant categorically denies the statements made in paragraphs 19,22 and 23 of the written statement and begs to state that in view of the facts and circumstances stated in the foregoing paragraphs, the releifs and interim relief sought for in the application are fully justified and sustainable and as such the application deserves to be allowed with costs.
