BHARAT BHUSHAN, MEMBER (J) :

Mr.A.Ahmed, learned proxy counsel on behalf of Mr.
S.Ali, learned Sr.counsel for the applicant and Mr.I.Choudhury,
learned counsel for the respondents were present.

1. The applicant, who was working in the office of the
Assam State Co-operative Marketing & Consumer Federation Ltd.,
Guwahati, had applied for appointment as Data Entry Operator
Grade-B on transfer on deputation basis for a period of one
year with the Director of Census Operations, Assam, Guwahati.
The applicant was selected and appointed on deputation basis
in the office of the Director of Census Operations,
Assam, Guwahati as Data Entry Operator in the scale of pay of
parent deptt. Rs.1065-2095/- p.m. plus deputation and other
allowances as admissible w.e.f. 22.1.2003 for a period of one
year vide Annexure-3, which reads as follows:-

O R D E R

Shri Nripendra Nath Talukdar in the o/o the Assam State Co-operative Marketing & Consumer Federation Ltd., Bhangagarh, Guwahati is hereby appointed as Data Entry Operator Grade 'B' on deputation basis in the o/o the D.C.O., Assam, Guwahati in the scale of pay of parent deptt. Rs. 1065-2095/- p.m. plus deputation and other allowances as admissible w.e.f. 22.1.2003 (A.N.) for a period of 1(one) year or until the post is filled up by direct recruitment whichever is earlier.

2. It is alleged by the applicant that though the period of his deputation was to expire only after one year i.e. on 21.1.2004, yet vide order dated 22.8.2003 passed by the Dy. Director of Census Operations, Assam, he was ordered to be reverted to his parent department w.e.f. 1.9.2003 (F.N.). He has challenged this order of his premature return to his parent department in this O.A. as illegal and violative of the principles of natural justice. However, vide interim order dated 28.8.2003 the petitioner had been allowed to continue on deputation with the office of the Dy. Director of Census Operations, Assam.

3. While refuting the arguments of the petitioner, Mr. I. Choudhury, learned counsel for the respondents, has contended that no legal right has accrued to the petitioner to remain on deputation for the complete period of one year. Referring to the Govt. of India instructions on premature reversion of a deputationist to his parent department, he contends that the deputationist could be reverted back to his parent department after giving an advance information. The said instructions are reproduced herein below:-

" 9. premature reversion of deputationist to parent cadre

Normally, when an employee is appointed on deputation/foreign service, his services are placed at the disposal of the parent Ministry/Department at the end of the tenure. However,

as and when a situation arises for premature reversion to the parent cadre of the deputationist, his services could be returned after giving advance intimation of reasonable period to the lending Ministry/Department and the employee concerned."

Hence, according to the respondents, when the Borrowing Department did not find the performance of the applicant satisfactory, they, naturally by virtue of the instructions referred to above, ordered the reversion of the applicant to his parent Department even before the expiry of period of one year.

4. Having regard to the rival contentions and the instructions of the Govt. of India, referred to above, we do not find any illegality in the order of the Borrowing Department to repatriate the applicant to the parent Department before expiry of the period of deputation. But even otherwise, now that since the applicant has already been able to complete the said period of one year of deputation on 21.1.2004 by continuing on the deputation post by virtue of the Interim Order dated 28.8.2003 of the Tribunal, the present O.A. does not survive. Hence, the same stands dismissed as satisfied.

3. PARTICULARS OF THE ORDER AGAINST WHICH THIS
APPEAL IS MADE:-

Order dated Guwahati the 22 nd August 2003 issued by the Director of Census Operation, Assam, Guwahati, communicated vide Memo No- DCO (E) 50/99/Pt-II/6089-99 dated 22/8/2003 issued to Shri Nripendra Nath Talukdar, the Applicant.

4. JURISDICTION:-

The applicant declares that the subject matter is within the jurisdiction of the Central Administrative Tribunal.

5. LIMITATION:-

The applicant further declares that the application is within the limitation period as prescribed under Section 21 of the Central Administrative Act, 1985.

6. FACTS OF THE CASE:-

6.1 That the Applicant is an Indian citizen and a permanent resident of Guwahati in the District of Kamrup, Assam, and as such he is entitled to all the rights and privileges guaranteed under the Constitution of India and various other laws framed there under.

6.2 That the Director of Census Operation, Assam, Guwahati vide circular dated 28 th February, 2002 proposed to fill up few post of Data Entry Operator,

Grade 'B' in the pay scale of Rs.4500-125 -7000 p.m in the Data Center of the Directorate of Census Operation Assam, G.S Road, Ulubari, Guwahati by appointing suitable official of Central/State government by transfer on deputation basis. The initial appointment will be for a period of 1(one) year or till such time the post are filled by direct recruitment subject to the approval of the Screening Committee whichever is earlier.

Annexure-1 is the photocopy of the circular issued by the Director of the Census Operation for the post of Data Entry Operator Grade 'B'.

- 6.3 That in response to the circular at Annexure-1 the applicant applied for the post of Data Entry Operator, Grade 'B' in the scale of pay Rs.4500-125-7000-p.m. in the Data Center of Directorate of Census Operation, Assam, G.S. Road, Ulubari, Guwahati.
- 6.4 That the Deputy Director of Census Operation, Assam, Guwahati vide letter dated 20 th January, 2003 informed the Managing Director, STATEFED, Bhangaghar, Guwahati that the applicant Shri Nripendra Nath Talukdar, Account Assistant of the STATEFED Organization have been selected for appointment on deputation basis as Data Entry Operation, Grade 'B' in the office of the Directorate of Census Operation, Assam, Guwahati.

Annexure-2 is the letter dated 20 th January, 2003 given by the Deputy Director of Census Operation, Assam, Guwahati to the Managing Director, STATEFED, Bhangaghar, Guwahati.

- 6.5 That vide Annexure-2 the Deputy Director of Census Operation has given 6(six) terms and conditions for the appointment as Data Entry Operator, Grade 'B' on deputation, which the applicant accepted.

- 6.6 That after acceptance of the terms and conditions laid down at Annexure -2 your applicant was appointed vide No- DCO (E) 120/ 2001 dated Guwahati the 21/1/2002 by the Deputy Director of Census Operation, Assam, Guwahati.

Annexure-3 is the photocopy of the appointment letter of the applicant issued by Deputy Director of Census Operation, Assam, Guwahati, vide No-DCO (E) 120/2001 dated guwahati the 21/1/2002.

- Gal* 6.7 That after appointment of the applicant vide Annexure-3 the applicant joined on ~~21~~22/1/2003 and he was working to the entire satisfaction of the authority without any blemish.

- 6.8 That as per advertisement Annexure -1 and as per letter at Annexure-3, the Period of appointment is for 1(one) year or until the post is filled up by direct recruitment whichever is earlier.

- 6.9 That your applicant begs to state that to his great surprise and astonishment the Deputy Director of Census Operation, Assam, Guwahati, vide his letter dated 22 August, 2003 released him from his service with a copy to him vide Memo No-DCO (E) 50/99/Pt.II/6101-II. In violation of the terms and conditions of the advertisement as well as the terms and conditions of the applicants appointment letter at Annexure-3. As per appointment letter his terms of service is for a period of 1 (one) year or until his post is filled up by direct recruitment whichever is earlier .But the authority in violation of the terms advertisement and the terms of appointment before completion of 1(one) year or before the post is filled up by direct recruitment. This is highly illegal.

Annexure-4 is the photocopy of the release order dated 22/8/2003 vide Memo No-DCO (E) 50/99/Pt.II/6101-II issued by the Deputy Director of Census Operation.

7. GROUNDS FOR RELIEF WITH LEGAL PROVISIONS:-

- 7.1 For that the impugned order at Annexure-4 is illegal, unjust and malafide and hence the same is liable to be quashed.
- 7.2 For that the impugned release order is bad in law, illegal, improper and violative of advertisement of appointment as well as violative of the terms and conditions of the appointment letter and hence the same is liable to be quashed.
- 7.3 For that the applicant as per the appointment letter at Annexure-3 his service cannot be terminated or release him from the post of Data Entry Operator till he completes 1(one) year of his service or till a direct recruitment is made to his post and hence the impugned order is illegal, unjust and improper and hence the same is liable to be quashed.
- 7.4 For that the release order is violative of terms and conditions and of the appointment as well as the advertisement made for the appointment of these applicants and hence is liable to be quashed.

8. DETAILS OF REMEDIES EXHAUSTED:-

As the applicant is going to be released on 1/9/03, the time being short, so he could not file any representation before the authorities.

9. WHETHER ANY CASE IS PENDING BEFORE ANY COURT OR TRIBUNAL:-

No case is pending before any court or tribunal.

10. RELIEF SOUGHT FOR:-

Under the facts and circumstances narrated above the applicant prays for the following relief:-

Not Permitted to be taken

1. The impugned order being violative of terms and conditions of advertisement for appointment and the terms and conditions of appointment is violative and as such the impugned order is liable to be set aside.
2. The impugned order is without issue of prior notice to the applicant and hence the same is liable to be quashed.
3. That they are having no direct recruitment against the post held by the applicant as per the terms and conditions of appointment, hence the impugned order is illegal, malafide, improper and without jurisdiction and hence the impugned order is liable to be set aside.
4. Any other relief/reliefs is entitled to be granted.
5. The cost of the case may also be granted to the applicant.

11. INTERIM RELIEF SOUGHT FOR:-

That as the applicant is going to be released by the respondent with effect from 1/9/2003 from service, hence it is necessary to stay the impugned order at Annexure-4.

I, Shri B.L. Sarmah, S/O Late Makerdhwass Sarmah aged about 58 years presently serving as the Deputy Director of Census Operations, Assam, Guwahati - 7, resident of Hengerabari, Guwahati in the district of Kamrup, Assam do hereby solemnly affirm and state as follows:

1. That I am posted as Deputy Director of Census Operations, Assam and I have been impleaded as the Respondent No.3 in the aforesaid Original Application. As such, I am fully conversant and fully acquainted with the facts and circumstances of the instant case. I am duly authorized to swear this affidavit on behalf of the Respondent Nos. 1 and 2.
2. That I have gone through a copy of the Original Application and I have understood the contents thereof. The statements made in the Original Application which are not specifically admitted herein below shall be deemed to have been denied by the deponent.
3. That with regard to the statement made in paragraph 6.1 of the Original Application the deponent has no comments to offer.

4. That prior to giving a parawise reply to the statements made in the subsequent paragraphs of the Application, the deponent humbly begs to place the facts in the right perspective and in its entirety before this Hon'ble Tribunal:-

- (i) The Registrar General of India, New Delhi had sanctioned a few temporary posts to the Assam Directorate in connection with the 2001 Census with effect from 01.02.2000 initially for a period upto 28.02.2001 (i.e. one year). Accordingly, this Directorate had filled up the said temporary posts either by way of promotion from eligible incumbents of this Directorate or by filling up the vacancies through other State/Central Government Employees on deputation basis.
- (ii) The Applicant Shri Nripendra Nath Talukdar working as Accounts Assistant in the Assam Co-operative Marketing and Consumer's Fed Ltd., Guwahati who had applied for the post of Computer was also selected and appointed with effect from 27.04.2001 against the 2001 Census vacancy. Be it stated herein that the term of sanction of these temporary posts had been extended/continued by the Govt. of India for further periods beyond 28.02.2001 from time to time in accordance with the volume of works relating to the 2001 Census. The Temporary posts of Computer, which had been sanctioned for the 2001 Census was discontinued from May 2002 and accordingly the applicant was repatriated to his parent organisation (STATFED) with effect from 31.05.2002.
- (iii) In the meantime this Directorate had issued a circular for filling up of 5 Nos. vacancies of Data Entry Operators Grade-B on deputation basis from the officials of Central/State Government temporarily till the posts are filled up by direct recruitment. The Applicant who had applied for the post was also considered against one of the vacancy. It is pertinent to state herein that the applicant who was engaged as

Computer/Compiler against the 2001 Census post and was repatriated to his parent Deptt. w.e.f. 31.05.2002 on discontinuation of the Census post could not have been appointed in the same organisation prior to the expiry of the cooling period as per the relevant rules (i.e. one year). However, inadvertently the application of this rule escaped the attention of the authorities and the applicant was considered and appointed on deputation basis against one of the five vacancies of Data Entry Operators Grade-B as per the Circular dated 20.02.2002 (Annexure 1 to the Original Application).

5. That with regard to the statements made in paragraph 6.2 of the Application the deponent states that the said appointments as well as eligibility conditions so referred to in the circular dated 20.02.2002 for a period of one year, would have been applicable in the case of suitable officials/employees who were brought in on deputation basis for the first time. As such, the said eligibility conditions so envisaged in the circular dated 20.02.2002 would ipso-facto be inapplicable in the case of the applicant since he was not a fresh deputationists and was infact under the 'cooling period'.
6. That with regard to statements made in paragraph 6.3 of the Application, the deponent has no comments to offer.
7. That with regard to statements made in paragraph 6.4, 6.5 and 6.6 deponent reiterates the statement made in paragraph 5 herein above and further states that the appointment of the official cannot be made again in the same organisation prior to expiry of the cooling period. The said fact having escaped the attention of the authorities concerned due to inadvertent lapses, the applicant was appointed on deputation basis as Data Entry Operator Grade-B in the office of the Directorate of Census Operations, Assam.
8. That while denying the statements made in paragraph 6.7 of the Original Application, the deponent states that the applicant belongs to a Commercial Organisation like STATFED and does not possess a statistical background. His appointment as Data Entry Operator Grade-B has resulted in a serious

error in Data Entry work as he failed to put appropriate codes against certain important socio-economic data which resulted in a distorted picture of 2001 Census data. These defects are being rectified by redoing the relevant entries for the second time. Phase III of Data Entry involves Computer Assisted Coding and the Deptt. cannot afford to continue who do not possess the necessary and requisite knowledge of statistics or the statistical implication of such wrong Data Entry.

9. That with regard to the statements made in paragraph 6.8 and 6.9 of the Original Application, the deponent states that although the applicant was initially appointed for a period of one year but for various reasons his performance has not been found satisfactory during the said period. Moreover, in view of the Government of India's instructions on the pre-mature reversion/repatriation of deputationists to his parent department, the authorities considered it fit and proper to repatriate the applicant to his parent department with effect from 01.09.2003. Further as stated above the Govt. of India's instruction on pre-mature reversion of a deputationists to his parent cadre are as under:-

"Normally, when an employee is appointed on deputation/foreign service, his services are placed at the disposal of the parent Ministry/Department at the end of the tenure. However, as and when a situation arises for pre-mature reversion to the parent cadre of the deputationists, his services could be so returned after giving advance intimation of reasonable period to the lending Ministry/Department and the employee concerned."

Accordingly, the applicant as well as his parent organisation have been given intimation well in advance so as to enable the parent organisation (STATFED) to accommodate the official on repatriation.

A copy of the relevant portion of the applicable Rules are annexed herewith and marked as ANNEXURE - A.

10. That in view of the statements made herein above the deponent humbly states that the applicant has been repatriated to his parent department due to his inability to render services to the satisfaction of the authorities concerned. Further in view of the fact of the terms and conditions as envisaged in the appointment Order dated 21.12.2002 ipso-facto do not apply to the applicant, since he was under the 'cooling period' and his appointment was due to administrative lapses. Moreover, on a review of the workload of the Department, it has been found that the service of the applicant is no longer required. As such, in terms of the powers vested on the answering respondents as per the relevant Government of India Circulars for the time being in force, it has been decided to repatriate the applicant to his parent department. Therefore, the Borrowing Department has not acted illegally by repatriating him to his parent department, since the applicant has been found unsuitable for the work assigned to him, the authorities have repatriated the applicant and as such the application is liable to be rejected. In fact, the said Order of repatriation has been passed by taking into consideration relevant and bonafide factors and in the best interest of the Borrowing Department.
11. That none of the grounds averred in the Original Application, are valid grounds and no rights of the applicant has been infringed in any way. The answering respondents humbly beg to submit that the law with regard to the rights of a deputationist and his repatriation and also the powers of the Borrowing Department have been laid down by the Apex Court in a catena of judgements in clear, unequivocal and unambiguous terms. Under the facts and circumstances as have been narrated above, it is submitted that the instant Application is devoid of any merit and the same is liable to be rejected.

Chapter 50

DEPUTATION (DUTY) ALLOWANCE

749

8.4 In cases where extension is beyond the fifth year or second year in excess of the period prescribed in the Recruitment Rules, the same would be allowed only after obtaining the approval of the Department of Personnel and Training, whether Central Government is the lending organization or the borrowing organization, proposal in this regard should reach this Department with the approval of the Ministry of the borrowing Department at least three months before the expiry of the extended tenure with full particulars. A check-list for such particulars is annexed.

8.5 When extension of period of deputation/foreign service for the first and the second year in excess of period prescribed in the Recruitment Rules is considered by the borrowing organization under powers delegated to them, the period for extension may be so decided upon so as to ensure that officer concerned is allowed to continue on deputation till the completion of academic year in cases where the officer has school/college going children. No proposal for further extension beyond the second year in excess of period prescribed in the Recruitment Rules shall be forwarded to this Department on the consideration that the Officer has school/college going children. Extension beyond this period will be considered only if it is strictly in public interest.

8.6 For computing the total period of deputation/foreign service, the period of deputation/foreign service in another ex-cadre post(s) held preceding the current appointment without break in the same or some other organization shall also be taken into account.

8.7 If during the period of deputation/foreign service, the basic pay of an employee exceeds the maximum of the scale of pay of the post or the fixed pay of the post, on account of pro forma promotion in his cadre under the Next Below Rule or otherwise, the deputation/foreign service of the employee should be restricted to a maximum period of six months from the date on which his pay exceeds such maximum and he should be reverted to his parent department within the said period.

8.8 If during the period of deputation, on account of pro forma promotion in the parent cadre under the Next below Rule, the employee becomes entitled to a scale of pay higher than the scale of pay attached to the ex-cadre post, he may be allowed to complete the normal tenure of deputation subject to 8.7 above but no further extension of the period of deputation should be allowed in such cases.

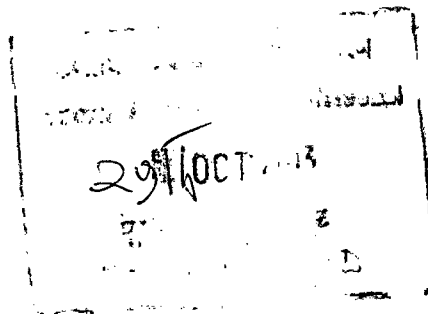

by the Director of Census Operation, Assam that "the initial

to the approval from the Screening Committee which ever is
earlier" and as such the applicant has right to continue
on deputation basis after completion of one year from the
date of appointment of the applicant and as such the applicant
will continue till the post is filled up by direct

recruitment. That apart it is also stated in the circular at Annexure-I in para 2 "the period of deputation shall not exceed 3(three) years. So the argument advanced by the learned Counsel for the respondent is not correct. In fact he has got the right to continue on deputation for 3(three) years.

2. That when the Counsel of the applicant submitted that the respondents have already issued Circular dated 21.8.03, has been published on Notice Board on 29.8.2003 immediately after filing of the O.A. by the applicant before the Hon'ble Tribunal for the same post instead of extending the period of service of the applicant as per earlier advertisement. In this circular application has been called for 5(five) posts of Data Entry, Operator Grade-B in which applicant is working at present.

Annexure-A is the photocopy of the circular dated 21.8.2003 published on 29.8.2002 in the office notice Board.

3. That in this circular at Annexure-A it has been clearly and categorically stated that the initial appointment shall be made for a period of one year but that may also be continued beyond that period.

4. That service records of the applicant very much satisfactory and no complaint is there against his performance of duty.

5. That in para 1 at Annexure-2 it has been clearly stated that the applicant will be repatriated as soon as the post is filled up by direct recruitment. 10. That it is worth mentioning that to ^{Group} ~~Lent~~ with ^{Sec} the work load Director of Census Operation, Assam has engaged 20(twenty) persons brought from Arm/ ^{town} Company with ^{C. Sel} effect from 15.10.03 at a fixed pay of Rs.4500'00 per head.

11. That the applicant is willing to serve as Data Entry Operator Grade-B in pay scale of Rs.4500-7000/- if absorbed on permanent basis.

Therefore, in view of facts and circumstances above it is prayed that the application of the applicant may be allowed to continue in service as deputationist for a maximum period or he may be permanently absorbed in service.

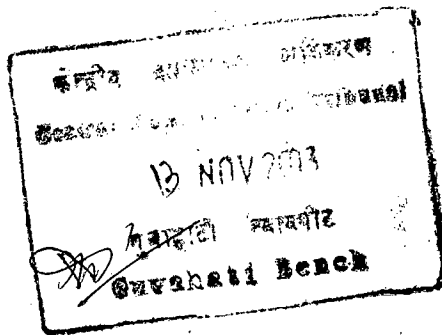

Hazarika, Director of Census Operation appreciating the services rendered to the Census Operation in Assam disapproves the allegations brought against the applicant by the deponent. This certificate has been issued by the Director of Census Operation, Assam on 13.7.2001 categorically disapproving the serious allegations brought against the applicant.

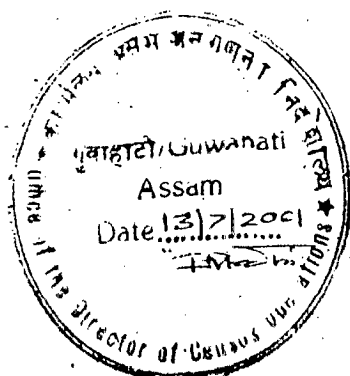
