

ORDER

K.V.SACHIDANANDAN (V.C)

The applicant is a Post Graduate Teacher (PGT) working in Kendriya Vidyalaya, Manipur. He submitted that he is qualified and has gained 10 years experience in recognized schools for the post of PGT as per recruitment rules. He fulfills all the terms and conditions for the post of Vice-Principal as per amended rules for recruitment of Vice Principals. The requirement for Vice Principal was also made 50% marks. However, by letter dated 10.9.2003



while calling for particulars of eligible PGTs it was only mentioned a Master Degree in one of the subjects is the eligibility criteria. Since the applicant fulfills all the eligibility criteria for the post of Vice Principal his name was appeared at sl.No. 2292 but his case was not considered. He also submitted representation which was not considered. Aggrieved by the said action the applicant has filed this O.A seeking the following reliefs.

"It is, therefore, prayed that Your Lordship would be pleased to admit this application, call for the entire records of the case, ask the respondents to show cause as to why the impugned order dated 3.3.2004 (Annexure-VII) so far as it related to promoting the post graduate Teachers junior to the applicant to the post of Vice-Principal superseding the claim of the applicant should not be set aside and as to why a direction should not be issued to promote the applicant to the post of Vice Principal and after perusing the cause shown, if any, and hearing the parties set aside the impugned order as prayed for and direct that the applicant be promoted to the post of Vice Principal from the date his juniors were so promoted and or pass such order/orders as Your Lordships may deem fit and proper."

2. The respondents have filed a detailed written statement contending that the name of the applicant was not forwarded for the post of Vice Principal in 2003-04 since he does not have the required marks. However, the subsequent DPC meeting held on 9.2.05 his name was considered and he was found unfit and therefore he was not promoted as Vice Principal. This is because there was a penalty imposed against the applicant on 16.3.99 and 4.11.03. Therefore, there is no merit in the claim of the applicant. As a consequence of the disciplinary action penalty was imposed against the applicant which is justified as per law.

3. Heard Mr G.K.Bhattacharyya, learned senior counsel for the applicant and Mr M.K.Mazumdar, learned counsel for the respondents. Learned counsel for the applicant submitted that though two penalties were already imposed against the applicant i.e. in the year 1999 and 2003, the first one came to an end on 2003 (reduction of pay). Penalty imposed on 2003 was only censure, which has no consequences as far as the promotion is concerned. The counsel for the respondents further submitted that since the committee which evaluated the case of the applicant had rejected the claim of the applicant there is no scope for any further consideration. However, when the matter came up for hearing, we have given due consideration to the arguments advanced by the counsel for the parties, evidence and the materials placed on record. Now the crux point centered round on the issue whether the applicant is fit for promotion to the post of Vice Principal or not. The respondents counsel was good enough to produce the record relating to the minutes of the selection committee and the ACRs of the applicant. In the minutes of the committee which was held on 9.2.04 many candidates have been evaluated by the committee. The applicant has no dispute with regard to the competency of the committee who made the assessment. While assessing the qualification, ACRs and other details regarding the fitness of the Vice Principal is concerned, the applicant's name also has been considered which is at sl.No.42 in the list and serial No.2292 mentioned therein. Admittedly the bench marks for that Vice Principals gradation is 'Good'. The committee assessed the 4 years

previous record and the ACRs which are Good in all the years as far as the applicant is concerned but the only reason that has been given for declaring him unfit in the last column is the minor penalty of censure issued on 4.11.03. Learned counsel for the applicant submitted that censure cannot be a reason for rejecting the promotional prospects of a candidate. It is also well settled position of law that "the censure cannot be a reason for rejecting the case of promotion."

4. We are of the considered view that reason of censure to be considered for declaring the applicant as unfit is illegal and for that reason denying of promotion to the applicant is not justified and therefore, we set aside the finding of the Committee that the applicant is unfit and declare that the applicant is entitled to be promoted as Vice Principal. However, since he has not actually taken charge as Vice Principal and discharging the duties of the Vice Principal till now he will be entitled for the notional benefit. In the facts and circumstances he is entitled to get promotion as Vice Principal on the date the other candidates are promoted (notionally). We also direct the respondents to promote the applicant as Vice Principal forthwith since he is retiring in the month of October 2006.

The Original Application is allowed. In the circumstances no order as to cost.

1. PARTICULAR OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE.

- i. Order No. F.7-8/2004-KVS (Estt-I) dated 03.03.2004 issued by the Deputy Commissioner (Personal) for Joint Commissioner (Administrative) whereby more than 95 Post Graduate Teachers were promoted to the post of Vice-Principal including teachers who were junior to the applicant so far as it relates to the applicants juniors.
- ii. Letter No. F.4-9/2003 KVS (Bho.Po.Bo) dated 12.05.2004 issued by the Respondent No.2 addressed to the Respondent No.3 whereby the representation/ appeal dated 16.03.2004 of the applicant was rejected arbitrarily.

2. JURISDICTION OF THE TRIBUNAL:

The applicant declares that the subject matter of the order against which he wants redressal is within the jurisdiction of this Tribunal.

3. LIMITATION :

The applicant further declares that this original application is being filed within the time

limit as prescribed U/S 21 of the Administrative Tribunal Act, 1985.

4. FACTS OF THE CASE :

1. That the applicant was appointed by the respondent Kendriya Vidyalaya Sangathan (here-in-after called KVS) on regular basis on 22.10.1982 as Post Graduate Teacher - Geography (PGT-Geography) and at present he is posted at Kendriya Vidyalaya Loktak, N.H.P.C., Manipur. At the time of appointment of the applicant as PGT-Geography the qualifications/experience for the post of PGT as per recruitment rules, were as follows -

- i. At least second class Master's degree (45% marks and above considered as equivalent) in one of the subjects taught in Kendriya Vidyalayas.
- ii. Degree or diploma in Education/Teaching.
- iii. At least 10 years experience as PGT in a recognized High/Higher Secondary School of which at least 3 years should be in a Kendriya Vidyalaya.

Note :

- i. PGT's who have secured less than 45% marks in Master's degree examination and have rendered at least 12 years service as PGT in a

High/Higher Secondary School of which at least 5 years should be as PGT in Kendriya Vidyalaya are also eligible for promotion.

- ii. PGT's who refuse promotion to the post of Vice-Principal consecutively for two years will not be considered again for promotion for next two years. The applicant had secured 49.6% in Geography which was his subject in M.Sc.

A copy of the ^{relevant portion of the} recruitment rules is annexed herewith as Annexure-I.

2. That, the applicant begs to state that the aforesaid requirement was subsequently amended and the requirement for Post Graduate Teacher was a Master's degree from a recognized University with all at least 50% marks. The requirement for Vice-Principal was also made 50% marks. However, by letter dated 10.9.2003 while calling for particulars of eligible PGTs it was only mentioned a Masters degree in one of the subjects was the eligibility criteria.

3. That, the Sr. Admn. Officer of KVS sent at circular dated 18.11.2002 to all Assistant Commissioners of KVS regarding consideration of promotion from PGTs to the post of Vice-Principal during 2003-2004 and requested to furnish full

particulars of PGTs upto All India Seniority No.2500 in the proforma attached. Seniority No. of the applicant at that time was 2292.

A copy of the said circular dated 18.11.2002 is annexed herewith and marked as Annexure-II.

4. That in compliance of the above-said circular dated 18.11.2002 Admn. Officer of KVS Regional Office Silchar sent circular letter dated 29.11.2002 to all the Principals of KVS to furnish the particulars of eligible PGTs for promotion to the post of Vice-Principal latest by 18.12.2002.

A copy of the said circular dated 29.11.2002 is annexed herewith and marked as Annexure-III.

5. That, as the applicant fulfilled all the requirements for promotion to the post of vice principal and his name was at Serial No. 2292, his name was forwarded by the principal vide letter No. F-2-1/KVJ/2002-2003/712 dated 10.12.2002 to the Assistant Commissioner KVS Silchar for onward transmission.

6. That the applicant, however, came to know that he was not promoted to the post of Vice-



Principal although the persons upto the seniority No.2497 were promoted. In order to draw the attention of the authority the applicant wrote a letter/ representation dated 8.9.2003 to the Commissioner of KVS pointing out that persons upto Sl. No.2497 had been promoted as Vice-Principal disregard to his due claim when his seniority position as PGT is at Sl. No.2292 for promotion to the post of Vice-Principal and the applicant prayed to consider his case for promotion to the post of Vice-Principal.

A copy of the letter dated 8.9.2003 is annexed herewith and marked as Annexure-IV.

7. That thereafter again on 10.9.2003 Sr. Admn. Officer of KVS sent circular No.F.4-9/2003 KVS (RPS) to all Assistant Commissioners regarding considerations of promotion of PGTs to the post of Vice-Principal for the year 2004-2005 and requested to furnish full particulars of eligible PGTs upto All India Seniority No.2700 (old). Relevant portion of letter dated 10.9.2003 regarding qualification/ experience etc. is reproduced as follows -

"In accordance with the Kendriya Vidyalaya Sangathan (Appointment, Promotion, Seniority etc.) Rule, 1971 as amended from time to time, 100% of Vice-Principals are filled by promotion on the basis




of seniority-cum-merit, from amongst PGTs serving in Kendriya Vidyalayas possessing the following qualifications :

- i) At least Master's Degree in one of the subject taught in Kendriya Vidyalaya.
- ii) University Degree/Diploma in Education/Teaching.
- iii) At least 10 years experience as PGT in a recognized High/Higher Secondary School of which at least 3 years should be in Kendriya Vidyalaya".

As the applicant fulfills all the above eligibility conditions for promotion to the post of Vice-Principal and was at Sl. No.2292 in All India Seniority List.

A copy of the said letter dated 10.9.2003 is annexed herewith and marked as Annexure-V.

8. That, in compliance of the abovesaid letter dated 10.9.2003, Admn. Officer of KVS Regional Office Silchar sent a circular dated 16.9.2003 to all the Principals of KVS to send the particulars of eligible PGTs for promotion to the post of Vice-Principal and the applicant's name was also forwarded.



A copy of the letter dated 16.9.2003 is annexed herewith and marked as Annexure-VI.

9. That, the respondent No.2 has now issued order No.F7-8/2004-KVS(ESH-I) dated 3.3.04, whereby more than 95 Post-graduate Teachers were promoted to the post of Vice-Principal, but to the utter surprise of the applicant, his name was not shown in the said list, while the names of several persons junior to him appeared in the said list. As per the information of the applicant following junior persons to him were promoted according to the said list dated 3.3.2004.

10. That on 16.3.2004 applicant sent a letter/
representation to the Central Grievance Officer KVS
through proper channel pointing out, that being at
Seniority No.2292 (Old) and 04 new as per the
seniority list prepared by the KVS he was entitled
to be promoted Vice-Principal, but he was not
promoted to the same.

11. That on 7.4.2004 Respondent No.3 wrote a letter to the Deputy Commissioner (Pers) and Central Grievance Officer KVS (HQ) regarding the case of the applicant for promotion to the post of Vice-Principal. It was also stated in this letter that proposal for promotion in respect of the applicant had already been sent to Sr. Admn. Officer vide letter of even number dated 29/30.10.2003 with the photocopies of the ACRs.

A copy of the letter dated 7.4.2004 is annexed herewith and marked as Annexure-IX.

12. That the applicant wrote another letter dated 3.5.2004 to the Grievance Officer of KVS to do the needful on the representations dated 8.9.2003 and 16.3.2004.

A copy of the letter dated 3.5.2004 is annexed herewith and marked as Annexure-X.

13. That the applicant wrote another letter dated 12.5.2004 to the Central Grievance Officer KVS giving the reference of his letter dated 16.3.2004 and letter dated 7.4.2004 of the Assistant

Commissioner Silchar and requested to do the needful so that he also may be promoted as Vice-Principal alongwith the persons promoted vide list dated 3.3.2004 (Annexure-VII) by which the promotees have been asked to join the new posts between 21.6.2004 and 2.7.2004.

A copy of the said reminder dated 12.5.2004 is annexed herewith and marked as Annexure-XI.

14. That the applicant begs to state that at no point of time during his service period any adverse remark in his service record was ever communicated to him and the applicant was never informed about the shortcomings if any, in his performance. A proceeding was drawn up against the applicant during 1999 and by order dated 16.4.99 the applicant was penalized reduction to a lower stage in time scale of pay for a period of 3 years w.e.f. 16.4.99 and the same was over on 15.4.02. By another order dated 4.11.03, the applicant was imposed the minor penalty of censure and the applicant submits that the aforesaid two penalties cannot stand in the way of the applicant being promoted to the post of Vice-Principal.

15. That the applicant has now received letter No.F.4-9/2003-KVS (Bho.po.Bo) dated 12.5.04 issued

by the Assistant Commissioner (Admn) from the office of the Respondent No.2 addressed to the respondent No.3 informing that the applicant was considered by the D.P.C. but he was not found fit thereby rejecting the applicant's representation/appeal dated 16.3.04.

16. That the applicant begs to state that he is left with no other alternative remedy but to approach the Hon'ble Tribunal for justice, which is otherwise due to him and unless some interim orders are passed, protecting his interests, he will suffer irreparable loss and injury.

5. GROUND FOR RELIEF WITH LEGAL PROVISIONS :

- I. For that, the action of the authorities in depriving the applicant of his due promotion to the post of Vice-President without any reason is bad in law and is liable to be quashed and set aside.
- II. For that, the authority, while considering the case of the applicant did not make a fair assessment and the conclusion arrived at by taking into consideration extraneous

matters, not related to the performance of the applicant in his services and as such the impugned action is bad in law and is liable to be set aside.

III. For that, the action of the authorities in promoting persons junior to the applicant is violative of principle of equal opportunity and as such the same is bad in law and is liable to be set aside.

IV. For that, the action of the authorities in rejecting the applicant's representation dated 16.3.04 arbitrarily and mechanically without giving any reasons is bad in law and liable to be set aside.

V. For that, in any view of the matter the impugned action of the authorities in denying the legitimate and just claim of the applicant for promotion is bad in law and is liable to be set aside.

6. DETAILS OF REMEDIES EXHAUSTED:

The applicant had submitted a representation dated 16.3.04 through proper channel and the same was rejected by letter dated 12.5.2004.

7. MATTERS NOT PREVIOUSLY FILED OR PENDING WITH
ANY OTHER COURT :

The applicant further declares that he has not previously filed any application, writ petition or suit regarding the matter in respect of which this application has been made before any Court or any other authority or any other Bench of the Tribunal nor any such application, Writ petition or suit is pending before any of them.

8. PRAYER:

It is, therefore, prayed that Your Lordships would be pleased to admit this application, call for the entire records of the case, ask the Respondents to show cause as to why the impugned order dated 3.3.2004 (Annexure-VII) so far as it related to promoting the post graduate Teachers junior to the applicant to the post of Vice-Principal superseding the claim of the applicant should not be set aside and as to ^{why} a direction should not be issued to promote the applicant to the post of Vice-Principal and after

perusing the causes shown, if any, and hearing the parties set aside the impugned order as prayed for and direct that the applicant be promoted to the post of Vice-Principal from the date his juniors were so promoted and/or pass such order/order as Your Lordships may deem fit and proper.

And for this act of kindness, the applicant as in duty bound shall ever pray.

9. INTERIM ORDER:

It is, further prayed that pending disposal of the application Your Lordships would be pleased to direct the Respondents to keep one post of Vice-Principal vacant for the applicant and/or pass such ^{other} ~~interim~~ ^{orders} order/ as may be deemed fit and proper.

And for this act of your kindness the applicant as in duty bound shall ever pray.

With due respect and humble submission, I the undersigned have the honour to state the following few lines for your kind consideration and favourable action thereof.

1. That, I have been serving on regular basis as PGT (Geog) in the K.V.S. N.E.P. 22.10, 1982 till date. My seniority position as PGT is at Sl No 3292 which is the feeder post for promotion to the post of Vice-Principal. It is learnt from reliable sources that the seniority list of PGTs upto Sl No 2497 had been promoted to the higher post of Vice- Principal.

2. That, my name has been also sent by the Principal K.V. Loktak vide his letter No F 2-4/KVL/2002-03/712 dated 10.12.2002 to the A.G. K.V.S. (SE) for onward transmission to the higher authority for consideration of my case in the current session of 2003-04 for promotion to the post of Vice- Principal.

3. That, it is pertinent to mention here that in the past occasions, my case was not considered by the MPC on the ground that I did not obtain 50% marks in the Master's degree as per amended recruitment Rule; and as such on this wrong calculation I have been superseded by many juniors. As a matter of fact I obtained 49.44 marks in the Master's degree (rounded up mark is 50%). However, the rounded up theory has been denied to me by the authority concerned. In other words, I am possessing the requisite qualifications for promotion to the post of Vice-Principal as per provisions of the amended Recruitment Rules.

A copy of my Bio-dat is enclosed herewith as ANNEXURE-A for kind perusal.

The Supreme Court of India has deprecated the absence promotional prospects in public service due to defective promotional policy and non-consideration by the authority. reported in AIR 1989 SC 1972 (OIER-Vrs-K.G.S. Bhatt & another).

In the case of Ajit Singh & Others -Vrs. The State of Punjab & Ors. reported in (1999) 7 SCC 209 (B), Supreme Court has held that employment provides a fundamental right to be considered for promotion. Article 16 (1) provides to every employee otherwise eligible for promotion who comes with in the line of consideration, a fundamental right to be "considered" for promotion. Equal opportunity means the right to be "considered" for promotion. If a person satisfies the eligibility and some criteria but is not considered for promotion that there will be a clear infraction of his fundamental right to be "considered" for promotion, which is his personal right.

In the above facts and circumstances stated above, it is requested that my case for promotion to the post of Vice-Principal may kindly be considered at an early date v.s.f. the date on which junior to me were promoted i.e. retrospectively for the ends of justice.

For this act of kindness, I shall ever remain grateful.

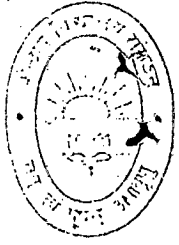

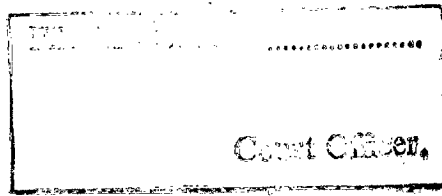

2). That the deponent states the allegations / averments which is not borne out by records are denied and not admitted. Any averments / allegations which are not specifically admitted hereinafter is deemed to be denied.

3). That the deponent begs to apprise that the grievance of the applicant is that he has not been promoted from the post of PGT to the post of Vice-Principal during the academic years 2003-04 and 2004-05. In this connection it is submitted that w.e.f. 05-07-2001 one of the conditions for promotion to the post of Vice-Principal was that the Post Graduate Teacher should have at least second class Master's Degree (50% marks and above considered as equivalent) in one of the subjects taught in Kendriya Vidyalaya. The applicant himself has stated in his representation dated 08-09-2003 (Annexure IV of O.A) that he possesses Master Degree in Geography with 49.6% marks. Therefore, the Assistant Commissioner, KVS, Silchar Region did not forward the applicant's case for promotion to the post of Vice-Principal for the 2003-04 to KVS(Head Quarter) in response to circular dated 18-11-2002 (Annexure II of O.A). The contention of the applicant that 49.6% marks should be rounded off to 50% cannot be accepted.

The recruitment Rules for the post of Vice-Principal were amended on 22-08-2003 vide which the requirement of percentage of marks in Master Degree was done away with. The case of the applicant for promotion to the post of Vice-Principal for the year 2004-05 was considered by the DPC in its meeting held on 09-02-2004 but the DPC found him 'UNFIT' based on his service records. The applicant has himself stated in Para 4 (14) of O.A that he was imposed penalties on 16-04-1999 and 04-11-2003.

Therefore there is no merit in the applicant's case which may be dismissed. The para-wise comments of the O.A are submitted as under:

Para-wise Comments

4). That the respondent states that with regard to statement made under the heading "Particulars of the order against which the application is made", the respondent at the outset denies the correctness of the same and submits the following facts of correct position i.e. the recruitment rules for the post of Vice-Principal were amended on 22-08-2003 vide which the requirement of percentage of marks in Master Degree was done away with and during the academic year 2004-05 the case of the applicant for promotion was considered by the D.P.C in its meeting held on 09-02-2004 and was found unfit basing on his service record.

5). That with regard to the statements made in paragraphs 2 and 3 the respondent says that these are law points and does not forward any comment.

6). That with regard to the statement made in paragraph 4.1 it is stated that the recruitment rules referred to by the applicant are for the post of Vice-Principal and not for the post of P.G.T (Annexure I, Page 18 of O.A).

7). That with regard to the statements made in paragraphs 4.2, 4.3 and 4.4, the respondent states that the recruitment rules for various teaching and non-teaching posts were amended on 05-07-2001 according to which 100% posts of Vice-Principal were to be filled on the basis of seniority-cum-merit from amongst PGTs serving in the Kendriya Vidyalaya possessing the following qualifications:

(i). At least second class Master's Degree (50% marks and above considered as equivalent) in one of the subjects taught in Kendriya Vidyalaya.

(ii). University Degree / Diploma in Education / Teaching.

(iii). At least 10 years experience as PGT in a recognised High / Higher Secondary School of which at least 3 years should be in Kendriya Vidyalaya.

The recruitment Rules for the post of Vice-Principal were further amended on 22-08-2003 vide which the requirement of percentage of marks in

Master Degree was done away with. Therefore in circular letter dated 10-09-2003 (Annexure-V of O.A) while calling for particulars of eligible PGTs for promotion to the post of Vice-Principal, a Master Degree in one of the subjects taught in Kendriya Vidyalaya was indicated as one of the requirements.

Copies of the amended rules are annexed herewith and marked as ANNEXURES R/1 and R/2 respectively.

8). That with regard to the statements made in paragraphs 4.5, 4.6, 4.7 and 4.8, the respondent states that the case of the applicant for promotion during 2003-04 to the post of Vice-Principal was not forwarded by the Assistant Commissioner, KVS, Silchar Region to KVS (HQ) in response to circular dated 18-11-2002 (Annexure-II of OA) because the applicant do not possess Master Degree with 50% marks. The applicant himself has admitted in his representation dated 08-09-2003 (Annexure-IV of OA) that he obtained 49.6% marks in the Master Degree.

It is further submitted that the recruitment rules for the post of Vice-Principal were further amended by Office Memorandum No.12-1/2003-KVS(RPS) dated 22-08-2003 vide which the requirement of percentage of marks in Master Degree was done away with.

9). That with regard to the statements made in paragraphs 4.9, 4.10, 4.12, 4.13 and 4.15, the

respondent states that the name of the applicant was considered by DPC in its meeting held on 09-02-2004 for promotion to the post of Vice-Principal but the DPC found him 'UNFIT' based on his service records. The applicant has himself stated in para 4(14) of O.A that he was imposed penalties on 16-04-1999 and 04-11-2003.

A copy of the minutes of the said meeting is enclosed herewith and marked as ANNEXURE R/3.

10). That with regard to the statements made in paragraph 4.11, the respondent states that the averment made by the applicant is misleading. Infact, the representation made by the applicant for promotion to the post of Vice-Principal which was addressed to the Central Grievance Officer of KVS was only forwarded vide letter dated 07-04-2004 for necessary action by the Respondent No.3 to the Dy. Commissioner (Per) being Central Grievance Officer.

11). That with regard to the statements made in paragraph 4.14, the respondent states that the averment made by the applicant that at one point of time during his service period any adverse remark in his service record was ever communicated to him, is not correct. The applicant has himself admitted that the disciplinary proceedings were initiated against him and penalty was imposed upon him vide order dated 16-04-1999 and 04-11-2003. hence the contention made by the applicant is confusing and misleading.

The penalty was imposed upon the applicant as a consequence of disciplinary action and on the date of DPC the penalty was operative. The action of the Respondent(s) is justified and as per law.

12). That with regard to the statements made in paragraph 4.16, the respondent states that since the name of the applicant was considered by the DPC in its meeting held on 09-02-2004 for promotion to the post of Vice Principal but the DPC found him 'UNFIT' based on his service records. The Hon'ble Tribunal may be pleased to dismiss the instant OA with exemplary cost to meet the end of justice.

13). That with regard to the grounds made in the application the respondent states that these are not good grounds for considering the case of applicant.

14). That with regard to the prayer made in the application the respondent submits that since the name of the applicant was considered by the DPC in its meeting held on 09-02-2004 for promotion to the post of Vice Principal but the DPC found the applicant unfit based in his service records, therefore this Hon'ble Tribunal may be pleased to dismiss this O.A with cost.

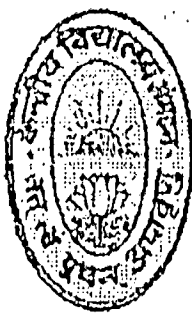


