

ORDER (ORAL)

SIVARAJAN, J. (V.C.) :


The applicant has retired from the services under the respondents as a Selection Grade Sr. Medical Superintendent on 28.2.2002. His grievance is that though one of his juniors (according to him) — Dr. P. K. Bora was promoted retrospectively from 1.4.1994 to the Selection Grade and further promoted as SA Grade w.e.f. 28.7.2000, the applicant who was senior to said Dr. P. K. Bora was not given the said promotions. The applicant had made a representation before the Railway Board on 10.8.2004 which was disposed of by the Railway Board as per communication dated 7.3.2005 which is produced as enclosure to the communication dated 15.3.2005 issued from the office of the General Manager (P), Maligaon (Annexure-IV). It is stated in the said order that the representation of the applicant had been examined; none of the juniors of the applicant have been promoted to Selection Grade till date; as per the revised seniority, applicant's turn for promotion to SA Grade did not come till his retirement on 28.2.2002; therefore, the question for his promotion (non-promotion) to SA Grade does not arise.

2. Mr. G. K. Bhattacharyya, learned senior counsel appearing for the applicant submits that the applicant was promoted to the post of Selection Grade in the pay scale of Rs.14,300-18,300/- w.e.f. 1.9.1997 whereas Dr. P.K.Bora was promoted to the said grade only on 1.11.1997. Counsel



submits that the statement made in the impugned order is factually incorrect.

3. We have also heard Dr. M. C. Sharma, learned Railway counsel appearing for the respondents. We find that the Railway Board has asserted that none of the juniors to the applicant have been promoted to the SA Grade till date and that as per the revised seniority the applicant's turn to SA Grade did not come till his retirement on 28.2.2002. The applicant has produced a copy of the order dated 6/8.5.1998 which would show that the applicant was promoted to the Selection Grade on 1.9.1997 and Dr. P. K. Bora was promoted to the said grade only on 1.11.1997. The Government of India order dated 10.4.2002 (Annexure-I) was passed after the retirement of the applicant on 28.2.2002. However, by the said order retrospective promotions were given in the post of Selection Grade on the basis of Supreme Court decision. On the date when Dr. P. K. Bora was retrospectively promoted on 1.4.1994, if, as a matter of fact, the applicant was senior to Dr. P. K. Bora in the lower post, certainly, notwithstanding his retirement in February, 2002 he would have been promoted to the post of Selection Grade on the date when Dr. P. K. Bora was promoted as Selection Grade. Based on such promotion when further promotion to the post of SA Grade was made on 12.4.2002 (Annexure-II), notwithstanding the retirement of the applicant in February, 2002, he should have been promoted to the post of SA Grade on the date when Dr. P. K. Bora was promoted to that post on 28.7.2000. If such




promotions were given to the applicant even though no arrears of pay based on such notional promotions were given, the applicant would have been entitled to some other retiral benefits.


4. Now the question is as to whether Dr. P. K. Bora about whom the applicant has mentioned as junior to the applicant as per the seniority list/revised seniority list in the lower post including the Selection Grade post. The respondents have already stated that none of the juniors to the applicant have been promoted as SA Grade as per the revised seniority. Of course, nothing is mentioned about the retrospective promotion to the post of Selection Grade. If, according to the applicant, the factual details stated in the Railway Board letter is incorrect, the appropriate course for the applicant was to file further representation/review application before the Railway Board itself pointing out the correct facts. Admittedly, this has not been done and instead the applicant has chosen to file this application before this Tribunal in respect of the disputed question of facts. This Tribunal is not the proper forum to resolve any disputed question of facts. If the applicant makes further representation before the Railway Board pointing out the incorrectness of the statement made in the Railway Board order dated 7.3.2005 touching the merits of the matter, certainly the Railway Board will consider the same and pass appropriate orders in accordance with law on merits. Accordingly, the applicant is directed to file representation before the respondents settling out

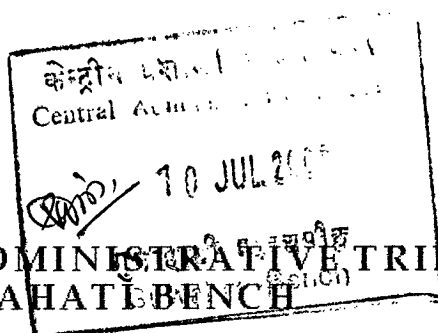
all the factual details within one month from today and if any such representation is filed the respondents will dispose of the same within three months thereafter.

Year 1988 and year 1989 :

He was promoted as Divisional Medical Officer in the year 1988 and then as Sr. Medical Officer in the year 1989.

- 01.09.97 : On 01.09.97 the applicant got Selection Grade.
- 28.02.02 : The applicant retired from service as Senior Medical Superintendent, Maligaon in the Selection Grade.
- 10.04.02 : Revision of seniority list in compliance to Hon'ble Supreme Court judgement dated 10.04.01 was published vide letter No. E(O) 1/2001/SR-6/4 dated 04.02.02, by the Board by its wireless message No. E(O) 111-2002/PM/42 dated 10.04.2002 addressed to all General Manager of Indian Railways Published a list, whereby 195 Officer's of IRMS were given proforma placement in Selection Grade.

- 12.04.02 : On 12.04.02 the Railways Board, vide its wireless message No. E(O) 111-2002/PM/44 addressed to all General Manager of Indian Railways Published another list consisting 66 Officers of IRMS were appointed to officiate in S.A. Grade.

- 10.08.04 : An appeal/representation was filed by the applicant through proper channel before the Railway Board.
- 06/08.05.98 : Railways Board's letter XXR No. E(O) Pt. 1 dated 6/8.05.98, the applicant was placed in selection Grade w.e.f. 01.09.97 and Dr. P.K. Bora w.e.f. 01.11.97, this fact shows that the applicant is senior.

1. PARTICULARS OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE :

- (i) Illegal and arbitrary action of the respondent authorities in not including the name of the applicant or assigning his correct position in the revised seniority list and thereby depriving him his subsequent promotion.
- (ii) Action of the respondent authorities in meting out arbitrary treatment to the applicant with regard to his promotion to Senior Administrative Grade and promoting officers junior to him.

2. JURISDICTION OF THE TRIBUNAL :

The applicant declares that the subject matter of the order against which he wants redressal is within the jurisdiction of this Tribunal.

3. LIMITATION :

The applicant further declares that the application is within the limitation prescribed under section 21 of the Administrative Tribunals Act., 1985.

4. FACTS OF THE CASE :

- (i) That the applicant begs to state that after completing his MBBS examination he applied for and was appointed as Assistant Medical Officer on ad-hoc basis under the N.F. Railway against an existing vacancy and was posted at Katihar Divisional Railway Hospital, where he joined on 27.10.67.
- (ii) That after joining the applicant continuously discharged his duties sincerely and to the best of his abilities. As the applicant continued for a long time on ad-hoc basis without any break he was hoping that he would be regularised as per existing rule and procedure that if an ad-hoc employee continue in service beyond 90 days, his service should be regularised. But all of a sudden the applicant received a 14 days

notice from respondent No. 1 whereby his service was discontinued from 05.01.72 i.e. after he has rendered more than 4 (Four) years of ad-hoc service in the department.

- (iii) That thereafter, on the basis of examination conducted by the U.P.S.C. for Indian Railways in the year 1975 and his qualification the applicant was selected and appointed as Assistant Medical Officer vide Railway Board's letter No. 72/E(GR)I/7/27 dated 18.04.1973. Owing to his dedicated and effecient service he was promoted as Divisional Medical Officer in the year 1988 and then as Sr. Medical Officer in the year 1989. On 01.09.97 the applicant got Selection Grade and he retired from service on 28.02.02 as Senior Medical Superintendent, Maligaon in the Selection Grade.
- (iv). That the appliant begs to state that as per Railway Board's letter No. 22/E(GR) II/9/4 dated 16.09.93 ad-hoc doctors who later qualifies through the UPSC examinations should be treated as on regular continuous service from the date of their initial ad-hoc appointments.
- (v). That the Railway Board in compliance to Hon'ble Supreme Court's Judgement dated 10.04.2001 in Civil Appeal No. 2478-2479 of 2000 and consequent upon revision of seniority vide its letter No. E(O)I/2001/SR-6/14 dated 04.02.02, the Board by its wireless message No. E(O) 111-2002/PM/42 dated 10.04.02 addressed to all General Manager of Indian Railways published a list whereby 195 officers of IRMS were given proforma placement in Selection Grade with effect from the date mentioned against their names till the date of their actual placement in Selection Grade.

On 12.04.02 the Railway Board vide its wireless message No. E(O) 111-2002/PM/44 addressed to all General Manager of Indian published another list whereby 66 officers of IRMS were appointed to officiate in SA Grade with immediate effect on their railway itself by

Copies of the list dated 10.04.02 and 12.04.02 are annexed herewith and marked as **ANNEXURE I & II** respectively.

- (vi). That on coming over the above two lists, the applicant on perusal was shocked and surprised to find that his name was not shown in the list while the name of officers who were much junior to him appeared in the two lists, particularly Dr. P.K. Bora whose name appeared at Serial No. 74 in the list dated 10.04.2002 whereby he was given proforma placement in Selection Grade w.e.f. 01.04.94 and at serial No. 44 in the list dated 12.04.02 whereby he was given proforma promotion in S.A. Grade w.e.f. 28.07.2000.

In point of fact, the applicant states that as per Railway Board's letter XXR No. ~~E(0) III/38/PM/3441-22-498~~ ^{communicated vide letter no E/41/III/236-1(0) Pt-1 dt: 6/8/59} the applicant was placed in Selection Grade w.e.f. 01.09.97 and Dr. P.K. Bora w.e.f. 01.11.97 this fact shows that the applicant is senior.

Copy of the letter dated 6/8.05.98 is annexed herewith and marked as ANNEXURE-III.

- (vii). That thereafter on 10.08.04 the applicant filed an appeal/representation before the Railway Board through proper channel stating the above facts as to how an officer who is otherwise junior to him has superseded him to S.A. Grade till his retirement and prayed that his seniority in the list dated 10.04.04 (Annexure - I) be assigned correctly and thereafter he be placed in S.A. Grade from the date Dr. P.K. Bora has been given proforma promotion to S.A. Grade.

- (viii) That now the applicant has received a letter No. E/41/III/236-1(O) Pt. II dated 15.03.05 from the General Manager(P), Maligaon forwarding Railway Board's letter dated 07.03.05 to him in response to his appeal dated 10.08.04 wherein it was stated that move of the medical officers junior to the applicant have been promoted to S.A. Grade till date.

Copies of the letter dated 15.03.05 is annexed herewith and marked as ANNEXURE - IV.

- (ix). That the applicant begs to state that he is left with no other alternative remedy but to approach this Hon'ble Tribunal for appropriate relief which is otherwise due to him.

5. GROUND FOR RELIEF WITH LEGAL PROVISIONS :

- (i) For that the action of the authorities in omitting the name of the applicant in the list dated 10.04.04 (Annexure - I) is highly illegal, arbitrary, discriminatory and in violation of principle of natural justice and as such the impugned action of the authorities is bad in law and is liable to be set aside.
- (ii) For that the action of the respondents in not promoting the applicant but promoting officers who are junior to the applicant to the S.A. Grade superseding the appellant is illegal, arbitrary violative of laid down procedures and as such the impugned order is bad in law and is liable to be set aside.
- (iii) For that it will be apparent from letter dated 6/8.05.98 (Annexure - III) that Dr. P.K. Bora is junior to the applicant and as such the action of the authorities in rejecting his appeal mechanically and arbitrarily is bad in law and liable to be set aside.
- (iv) For that in pursuance to the Judgement of the Hon'ble Supreme Court all the doctors in the list were given proforma promotion to the Selection Grade from an earlier date and the consequential promotion

to S.A. Grade and the applicant would also have been so promoted but for his retirement on 28.02.02. However, since the promotion were given with retrospective effect, the applicant is also entitled to the promotion and to get the other financial and consequential benefits not withstanding the fact that he retired from service w.e.f. 28.02.02.

- (v) For that in any view of the matter the impugned action of the authorities in denying the applicant his due promotion for no apparent reason is bad in law and liable to be set aside.

6. DETAILS OF REMEDIES EXHAUSTED :

That applicant had filed a representaion/appeal dated 10.08.04 before the Railway Board but the same was rejected by letter dated 15.03.05.

7. MATTERS NOT PREVIOUSLY FILED OR PENDING WITH ANY OTHER COURT :

That the applicant further declares that he has not previously filed any application, writ petition or suit regarding the matter in respect of which this application has been made before any court or any other authority or any other bench of the Tribunal nor any such application, writ petition or suit is pending before any of them.

8. PRAYER :

It is therefore, prayed that Your Lordships would be pleased to admit this application, call for the entire records of the case, ask the respondents to showcourse as to why the name of the applicant should not be included in the revised seniority list dated 10.04.02 (Annexure - I) at his correct position and thereafter promote him to Senior Administrative Grade from the date when his junior i.e. Dr. P.K. Bora as shown

in promotion list dated 12.04.02 (Annexure - II) was promoted and after perusing the causes shown, if any and hearing the parties direct the respondents to include the name of the applicant in the revised seniority list dated 10.04.02 (Annexure - I) and thereafter promote him to Senior Administrative Grade from the date when his juniors were so promoted with all consequential benefits and/or pass any other order/orders as Your Lordship may deem fit and proper.

And for this act of kindness, the applicant as in duty bound shall ever pray.




