pursuant to an advertisement made in the Employment News for the period commencing from 13.10.2001 to 19.10.2001 the applicant applied for the post of Trackman. According to the applicant, he had succeeded in the written test and also in the physical efficiency test. It is stated that the results of the said physical test were declared vide communication dated 19.1.2005 (Annexure-IV) whereby the names of 8 persons who have failed in the said test were shown. The applicant's name was not there among the 8 candidates. The grievance of the applicant in this case is that 4th respondent issued an order dated 1.2.2005 displaying in its notice board a list of 69 SC and 110 ST empanelled candidates for Group 'D' posts of Trackman/Khalashi and the applicant's name was not included in the said list. The applicant therefore made a representation dated 9.2.2005 (Annexure-VI) but so far no orders have been passed thereon. This application is filed with the averment that the respondents have fixed the date of medical fitness test to be conducted on 18.3.2005 to April, 2005 and that if the applicant is not included in the list of persons for medical fitness test he will lose the chance for getting appointment even if he had succeeded in the test.

We have heard Mr. G.K. Bhattacharyya, learned Sr. counsel for the applicant and also Mr. M.C. Sharma, learned counsel for the Railways. On the previous occasion we gave an opportunity to the learned counsel for the Railways to get instruction from the respondents regarding the fate of the appeal. Today the

learned counsel for the respondents has not been able to furnish any reply. In the circumstances we are of the view that this application can be disposed of by directing the 3rd respondent to pass orders on ^{the} representation dated 9.2.2005 (Annexure-VI) within a period of one month from the date of receipt of this order. The 3rd respondents will afford an opportunity of personal hearing to the applicant before passing orders on the representation (Annexure-VI). Respondents will keep a post of Trackman/Khalasi vacant till a decision is taken on the representation.

The application is disposed of as above. Learned counsel for the Railways will produce a copy of this order before the 3rd respondent for compliance.

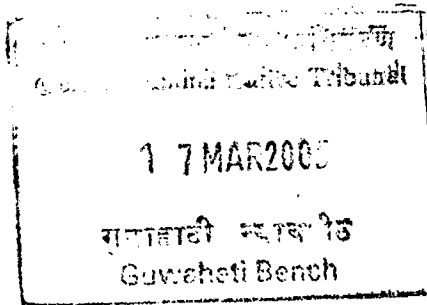

1. PARTICULARS OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE.

- i. Office Order No. E/227/Roctx./Misc./LM dated 01.02.2005 issued by the Respondent No. 4 declaring the result of the recruitment of Group-D posts of Trackman/ Khalasi (SC/ST).
- ii. Action of the authorities in declaring/ publishing Result Sheet of 69(SC) and 110 candidates (ST) for recruitment to Group-D posts of Trackman/ Khalasi in a pick and choose manner and candidates below the applicant were empanelled thereby depriving the applicant from right to be considered for appointment.
- iii. Appeal dated 09.02.2005 filed before the Respondent No. 3 stating the irregularities in the selection process of selecting the 110 (ST) candidates in a pick and choose manner with the prayer to do proper justice in the matter.

2. JURISDICTION OF THE TRIBUNAL:

Rij

The applicant declares that the subject matter of the order against which he wants redressal/relief is within the jurisdiction of this Hon'ble Tribunal.

3. LIMITATION :

The applicant further declares that the application is within the limitation prescribed under Section 21 of the Administrative Tribunals Act, 1985.

4. FACTS OF THE CASE :

1. That the applicant is a citizen of India and he belongs to the Schedule Tribes community and as such he is entitled to the protection as enshrined in the Constitution of India.

2. That the applicant begs to state that he belongs to a very poor family and due to financial constraints in the family he started looking for employment since the time he was continuing with his studies at the High School.

3. That the applicant states that in the issue of "The Employment News" of the week commencing from 13.10.2001-19.10.2001 an advertisement was issued by the Deputy Chief Personal Officer (Gaz) & Controller of Recruitment inviting applications from eligible SC and ST candidates for filling up Group-D posts of

Ryly

Trackman/ Khalasi in the four divisions of the N.F. Railway.

A copy of the advertisement is annexed herewith and marked as ANNEXURE-I.

4. That the applicant on coming across the advertisement, having the requisite qualifications, applied for the post of Trackman giving all particulars in details and he opted for Lumding Division. The applicant states that at the time of applying for the said post he was studying in Class-X.

5. That the applicant begs to state that as per the advertisement the recruitment process would consist of three stages (i) Objective type written examination (Preliminary Test), (ii) Objective type written examination (Final Test) and (iii) Physical Efficiency Test. Successful candidates who have come through the two stages of written test will be called for physical efficiency test.

The applicant after submitting his application, was called for the Preliminary Test and on being successful the applicant appeared in the Final Test on 21.11.2004. The applicant states that his Roll No. was 21708112.

6. That on 15.12.2004 the respondent authorities, in the local Assamese newspaper "Asomiya Pratidin", declared the result of the final test according to merit and the applicant's name appeared in the result list of Lumding Division.

The translated typed relevant extract of the newspaper showing the result is annexed herewith and marked as ANNEXURE-II.

7. That thereafter the applicant received a Admit Card/ Call Letter for Physical Efficiency Test and Verification of Original Certificates whereby he was asked to report/ appear on 19.01.2005 at 9:00 A.M. in the office of the Divisional Personal Officer, i.e. respondent No.4, Lumding for the test and verification. The applicant states that alongwith the call letter an instruction annexure was issued wherein, among others, it was stated that no marks would be awarded for the physical efficiency test but that the candidates would have to qualify for final selection and that the results of the physical efficiency test will be displayed on the same day of the test.

Copy of the call letter is annexed herewith and marked as ANNEXURE-III.

8. That accordingly, the applicant appeared before the Divisional Personal Officer, Lumding on the appointed date and participated in the test.

After completion of the test the Respondent no.4 displayed a notice issued under Memo No. E/227/Rectt./Misc./LM dated 19.01.2005 declaring the names of 8 candidates who had not passed the physical test. Since the applicant's name was not in the notice, the applicant had passed the physical test as no other list was published. A copy of the said notice was collected by the applicant and compared with the same with original hung on the Notice Board.

Typed copy of the notice dated 19.01.2005 is annexed herewith and marked as ANNEXURE-IV.

9. That the applicant begs to state that his performance in the entire recruitment process was very good and the applicant, in view of his performance and qualification, was confident that he would be selected and called for the medical test. But the applicant was shocked and surprised when he came across office Memo No.

E/227/rectt./Misc./LM dated 01.02.2005 issued by the respondent No.4 and displayed in its notice board whereby a list of 69 SC and 110 ST candidates were empanelled for Group-D posts of Trackman/Khalasi. On perusal of the list the applicant found that candidates who were below him in the merit list (Annexure-II) i.e Roll Nos. had been empanelled for recruitment to group-D posts of Khalasi/ Trackman. The applicant has collected a copy of the list of 110 ST candidates and compared to the same with the list in the Notice Board.

The applicant states that after the Physical Efficiency Test no other test was held and as such the applicant is surprised as to under what basis the respondent authorities has selected the candidates in a pick and choose manner and prepared the list.

The typed relevant portion of the list of 110 (ST) candidates are annexed herewith and marked as ANNEXURE-V.

10. That, thereafter the applicant along with such other candidates submitted an appeal/representation dated 09.02.2005 before the Respondent No.3 stating the above facts with the prayer to look into matter as to how the list dated

1.2.05 was prepared and to give justice to them, but till date there has been no response.

11. That the applicant states that now he has come to know that the respondent authorities has started calling candidates in batches from the list dated 1.2.05 (Annexure-V) for medical fitness test from 18.3.05 which will continue to April' 2005 and since his appeal/representation has not been disposed off till date, the applicant is convinced that no useful purpose will be served by waiting any longer and as such he is approaching this Hon'ble Tribunal for the redressal of his grievance.

5. GROUND FOR RELIEF WITH LEGAL PROVISIONS :

- I. For that, in the given facts and circumstances of the case, the action of the respondent authorities is highly illegal and bad in law and is liable to be quashed and set aside.
- II. For that the applicant had passed the written test and his name appeared in the final test result (Annexure-II) in order of

merit. The physical efficiency test did not carry any marks and since he had qualified in the physical test, the merit list ought to have been followed and that not having been done and by including persons who were shown lower in the list, the impugned action and orders are bad in law and liable to be set aside.

III. For that, in spite of the good performance by the applicant in the various tests of the recruitment process, leaving the applicant in lurch and selecting persons who were below the applicant's position in the merit list (Annexure-II) without showing any reason is illegal, arbitrary and in violation of principle of natural justice and therefore such action of the respondent authorities is liable to be quashed and set aside.

IV. For that, the action of the authorities in not disposing of the appeal/representation dated 9.2.05 shows that the appellate authorities has not exercised the jurisdiction vested in it and as such the same is bad in law and liable to be set aside.

V. For that, in any view of the matter the impugned action of the authorities is bad in law and is liable to be set aside.

6. DETAILS OF REMEDIES EXHAUSTED:

The applicant had submitted a representation/appeal dated 9.2.05 (Annexure-VI) before the Respondent No.3 but till date there has been no response.

7. MATTERS NOT PREVIOUSLY FILED OR PENDING WITH ANY OTHER COURT :

The applicant further declares that he has not previously filed any application, writ petition or suit regarding the matter in respect of which this application has been made before any Court or any other authority or any other Bench of the Tribunal nor any such application, Writ petition or suit is pending before any of them.

8. PRAYER:

It is, therefore, prayed that Your Lordships would be pleased to admit this application, call for the entire records of the case, ask the Respondents to show cause as to why the applicant's name should not be

empanelled in the list of ST candidates published vide Memo No. E/227/Rectt./Misc./ LM dated 01.02.2005 issued by the Respondent No.4 and as to why the applicant should also not be called for the medical test for appointment and after perusing the causes shown, if any and hearing the parties direct the Respondents to empanel the Respondents and sent him for the medical test for appointment and/or pass such order/order as Your Lordships may deem fit and proper.
