ORDER(ORAL)

K.V.SACHIDANANDAN,V.C:

The applicant was appointed to the post of Helper in the All India Radio in the year 1984. Thereafter, the applicant was promoted as Diesel Engine Driver in the Office of the Superintendent Engineer (HPT), All India Radio, Guwahati. The next promotion from Diesel Engine Driver is Diesel Technician. The posts of Diesel Technicians are filled up through 100% promotion on seniority/fitness basis failing which by direct recruitment. The Diesel Engine Drivers with three years service experience are eligible for promotion to the post of Diesel Technician. The Respondent No.5 informed all the Heads of All India Radio Stations Tawang, Tura, Agartala, Dibrugarh, Shillong, Guwahati, Gangtok, Kohima Imphal, Passighat, Silchar, Aizwal and the Chief Engineer East zone,(AIR & T.V) Calcutta about filling up the two posts of Diesel Technicians at All India Radio, Itanagar. But the Respondents No.6, 7,8 and 9 were promoted to the said post at Itanagar although they are junior to the applicant.

I have heard Mr.A.Ahmed learned counsel for the applicant and Mr. G. Baishya, Sr.C.G.S.C. for the Respondents. When the matter came up for consideration, the learned counsel for the applicant has

submitted that he will be satisfied if direction is given to the Respondent No.2 to consider the applicant and promote him to the post of Diesel Technician either at All India Radio, Guwahati, Kohima, Tawang and Aizwal where the aforesaid posts are lying vacant. The learned counsel for the respondents has submitted that he has no objection if such direction is given to the respondent.

Considering the facts and circumstances of this case, this Court directs the applicant to file comprehensive representation before the 2nd respondent within one month from to-day. If such representation is filed by the applicant, the Respondent No.2 shall consider and dispose of the same within three months and pass appropriate orders thereon.

O.A. is accordingly, disposed of. There shall be no order as to costs.

The Deputy Director of (Admn.) All India Radio on behalf of the Director General All India Radio vide letter No. 4/1/2001-S-IV (A) 216, requested the Chief Engineer to appraise the latest position of the case of the applicant to the post of Diesel Technician.

01-05-2001

The Deputy Director Engineering for the Chief Engineer (East Zone) vide his letter No. 1(35)/2001-S(D-Tech), appraised the Director General All India Radio, that the case of the Applicant could not be considered for promotion to the post of Diesel Technician, because the Diesel Engine Driver and Diesel Technicians are of local cadre and promotion from Diesel Engine Driver to Diesel technicians is dealt at Station level.

29/31-05-2001

The Assistant Station Director on behalf of the Station Director vide his memorandum, informed the Applicant that he has not been considered eligible for promotion to the post of Diesel Technician at All India Radio, Itanagar.

The posts of Diesel Technician are now lying vacant at AIR, Guwahati, Kohima & Aizwal. The applicant being the senior most person amongst the Diesel Engine Drivers can easily be accommodated by the Respondents. However, no steps has been taken for appointment of the applicant as Diesel Technician.

Hence this Original Application filed before this Hon'ble Tribunal for seeking justice in to this matter.

1) DETAILS OF THE APPLICATION PARTICULARS OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE:

The Application is not made against any particular order but against the discriminatory treatment made by the Respondents to the Applicant by not promoting him to the post of Diesel Technician whereas junior persons were promoted to the post of Diesel Technicians.

2) JURISDICTION OF THE TRIBUNAL

The Applicant declares that the subject matter of the instant application is within the jurisdiction of the Hon'ble Tribunal.

3) LIMITATION

The Applicant further declares that the subject matter of the instant application is within the limitation prescribed under Section 21 of the Administrative Tribunal Act 1985.

4) FACTS OF THE CASE:

Facts of the case in brief are given below:

4.1) That your humble Applicant is a citizen of India and as such he is entitled to all rights and privileges guaranteed under the Constitution of India and the laws framed thereunder from time to time.

4.2) That your Applicant begs to state that he was appointed to the post of Helper in All India Radio at Guwahati vide Order No. 21(6)/84-S dated 23/24 April 1984 w.e.f. 17-4-1984. He was appointed as Diesel Engine Driver vide Order No. 1(11)/90-S/2495 dated 12/ 15.09.1990. Since then he is working as Diesel Engine Driver. Now he is working as Diesel Engine Driver in the Office of the Superintendent Engineer (HPT), All India Radio, Guwahati-14.

Photocopy of the Order No. 21(6)/84-S dated 23/24-4-1984 is annexed hereunto and marked as **ANNEXURE-A.**

Photocopy of Order No. 1/(11)/90-S/2495 dated 12/15-09-1990 is annexed hereunto and marked as **ANNEXURE-B.**

4.3) That your Applicant begs to state that the next promotion from Diesel Engine Driver is Diesel Technician. The Diesel Technician is a Group 'C' post (Non-Gazetted) Non-Ministerial post. The posts of Diesel Technicians are filled through 100 % promotion on seniority / fitness basis failing which by direct recruitment. The Diesel Engine Drivers with three years service experience are eligible for promotion to the post of Diesel Technician.

Photocopy of the relevant portion of Recruitment Rules for Diesel Technician in All India Radio is annexed hereunto and marked as **ANNEXURE-C.**

4.4) That your Applicant begs to state that the Respondent No. 6 Shri M. Zirido was appointed as Diesel Engine Driver under the Respondents on 29-9-1994, the Respondent No.7 Shri K.N. Das was appointed as Diesel Engine Driver under the Respondents on 29-4-1994. The Respondent No. 8 Shri B. Borah was appointed as Diesel Engine Driver under the Respondents on 19-10-1994 and the Respondent No.9 Shri Tomi Riba was appointed as Diesel Engine Driver under the Respondents on 15-2-1995. It is to be stated that the Applicant is senior to the Respondent Nos. 6 to 9 in the post of Diesel Engine Driver.

4.5) That your Applicant begs to state that he got an information in the last part of December 1999 that two vacant posts of Diesel Technicians are going to be filled up through Departmental candidate at All India Radio, Itanagar and he offered himself as a candidate to the post of Diesel Technician at AIR, Itanagar through his willingness letter dated 13-12-1999 before the Chief Engineer All India Radio East Zone Calcutta. The Office of the Respondent No.5 vide their Circular No. Ita-1 (9)/2000-S/4126 dated 9-2-2000 informed all the Heads of All India Radio Stations Tawang, Tura, Agartala, Dibrugarh, Shillong, Guwahati, Gangtok, Kohima, Imphal, Pasighat, Silchar, Aizwal and the Chief Engineer East Zone (AIR & T.V.) Calcutta, about filling up of two vacant posts of Diesel Technicians at All India Radio, Itanagar.

Photocopy of the Applicant's willingness letter dated 13-12-1999 is annexed hereunto and marked as **ANNEXURE-D.**

Photocopy of Circular No. Ita-1(9)/2000-S/4126 dated 9-2-2000 is annexed hereunto and marked as **ANNEXURE- E.**

4.6) That your Applicant begs to state that even though his submission of willingness letter dated 13-12-1999 before the



Respondents for consideration of his case to the post of Diesel Technician in All India Radio at Itanagar, the Respondents had selected two persons namely, Shri Shri M. Zirdo i.e. Respondent No.6 and Shri Khagen Das i.e Respondent No.7 to the post of Diesel Technician, who were juniors to the applicant. Being aggrieved by this injustice applicant filed representations dated 22-05-2000 and 20-06-2000 before the Chief Engineer (East Zone), Kolkata.

Photocopy of representation dated 22-05-2000 is annexed hereunto and marked as ANNEXURE- F.

Photocopy of representation dated 20-06-2000 is annexed hereunto and marked as ANNEXURE- G.

4.7) That your Applicant begs to state that the Deputy Director of (Admn.) All India Radio on behalf of the Director General All India Radio vide his letter No. 4/1/2001-S-IV (A) 216 dated 26-3-2001, requested the Chief Engineer to apprise the latest position of the case for promotion of the applicant to the post of Diesel Technician. Accordingly, the Deputy Director Engineering, for Chief Engineer (East Zone) vide his letter No. 1(35)/2001-S(D-Tech) dated 1-5-2001 has appraised the Director General, All India Radio, that the case of the Applicant could not be considered for promotion to the post of Diesel Technician, because the Diesel Engine Driver and Diesel Technicians are of local cadre and promotion from Diesel Engine Driver to Diesel Technicians is dealt at Station level. Accordingly, the Assistant Station Director on behalf of the Station Director vide his memorandum dated 29/31-05-2001 informed your applicant that he has not been considered eligible for promotion to the post of Diesel Technician at All India Radio, Itanagar. It is worth to mention here that the other related Group 'C' Cadre promotions in All India Radio are made on Zonal Seniority basis by the Respondents.

4.8) That your Applicant begs to state that the Respondent No.8 Shri B. Borah and the Respondent No.9 Shri Tomi Riba were also promoted to the post of Diesel Technician from Diesel Engine Driver in the year 2001 without issuing any Office Memorandum or Circular by the Respondents.

4.9) That your Applicant begs to state that the posts of Diesel Technicians are lying-vacant in All India Radio, Guwahati, Kohima, Tawang and Aizwal. In the aforesaid post of Diesel Technician, the Applicant can be easily accommodated, as he is the one of the senior most persons among the Diesel Engine Driver. Now your Applicant apprehends that the Respondents may again promote the junior persons to the post of Diesel Technician by depriving the Applicant. Hence finding no other alternative your Applicant is compelled to approach this Hon'ble Tribunal for seeking justice in this matter.

4.10) That your Applicant submits that the Respondents have acted in whimsical manner with a mala fide intention only to deprive him from his legal rights.



4.11) That your Applicant submits that the action of the Respondents is violative of the Article 14, 16 and 21 of the Constitution of India as well as the principles of Natural Justice.

4.12) That your Applicant submits that the action of the Respondents is highly illegal, improper, colourable exercise of power and also against the fair play of Administrative justice.

4.13) That your application submits that he demanded justice and the same has been denied to him by the Respondents.

4.14) That this application is filed bonafide and for the interest of justice.

5) GROUNDS FOR RELIEF WITH LEGAL PROVISION:

5.1) For that, due to the above reasons narrated in detail the action of the Respondents are in prima facie illegal, malafide, arbitrary and without jurisdiction.

5.2) For that, the recruitment rules for Diesel Technician in All India Radio provides that these posts are 100 % filled through promotion by the Departmental Candidates on the basis of seniority / fitness and failing which by the direct recruitment. As such non-consideration of the Applicant's case is illegal, improper and not sustainable in the eye of law.

5.3) For that, the action of the respondents is arbitrary, mala-fide and discriminatory with an ill motive.

5.4) For that the Applicant being a senior person in the Grade of Diesel Engine Driver should be promoted to the post of Diesel Technician. However, in the instant case junior persons were promoted to the post of Diesel Technician from Diesel Engine Driver by depriving the Applicant.



5.5) For that, other similarly situated Group 'C' posts in All India Radio are generally filled on the basis of Zonal seniority list. However, in the instant case the Respondents without considering the Zonal seniority have promoted the Diesel Engine Driver to the post of Diesel Technician only on local station seniority basis. As such the action of the Respondents are illegal, whimsical, mala-fide and arbitrary.

5.6) For that, the Applicant has submitted his willingness to serve at Itanagar before filling up those posts. But the Respondents in a whimsical manner did not consider the case of the Applicant and promoted junior persons to the said post.

5.7) For that, there are sufficient posts of Diesel technician are lying vacant at All India Radio, Guwahati, Kohima, Tawang and Aizwal where the Applicant can be easily accommodated.

5.8) For that the Respondents have violated the Article 14, 16 & 21 of the Fundamental rights guaranteed under the Constitution of India as well as the principles of Natural Justice.

5.9) For that being a model employer the Respondents cannot deny the benefit to the Applicant, which he is legally entitled to.

5.10) For that due to non-consideration of his case of promotion to the post of Diesel Technician, the Applicant is suffering from mental anxiety and frustration.

5.11) For that the Applicant is running from pillar to post for consideration of his case but the same has not been considered by the respondents.

5.12) For that in any view of the matter the action of the respondents is not sustainable in the eye of law as well as of facts.



The Applicant craves leave of this Hon'ble Tribunal advance further grounds the time of hearing of this instant application.

6) DETAILS OF REMEDIES EXHAUSTED:

That there is no other alternative and efficacious and remedy available to the Applicant except the invoking the jurisdiction of this Hon'ble Tribunal under Section 19 of the Administrative Tribunal Act, 1985.

7) MATTERS NOT PREVIOUSLY FILED OR PENDING IN ANY OTHER COURT:

That the Applicant further declares that he has not filed any application, writ petition or suit in respect of the subject matter of the instant application before any other court, authority, nor any such application, writ petition of suit is pending before any of them.

8) RELIEF SOUGHT FOR:

Under the facts and circumstances stated above the applicant most respectfully prayed that Your Lordship may be pleased to admit this application, call for the records of the case, issue notices to the Respondents as to why the relief and relieves sought for the applicant may not be granted and after hearing the parties may be pleased to direct the Respondents to give the following relieves.

- 8.1) That the Hon'ble Tribunal may be pleased to direct the Respondents to consider the case of the Applicant and promote him to the post of Diesel Technician either at



All India Radio, Guwahati, Kohima, Tawang and Aizwal.

8.2) To Pass any other relief or relieves to which the applicant may be entitled and as may be deem fit and proper by the Hon'ble Tribunal.

8.3) To pay the cost of the application.

9) INTERIM ORDER PRAYED FOR:

Pending final decision of this application the Applicant seek an interim order from the Hon'ble Tribunal:

9.1 That the Respondents may be directed by this Hon'ble Tribunal to keep one post of Diesel Technician vacant for the Applicant till the final disposal of this Original Application.




