

ORDER (ORAL)

SACHIDANANDAN,V.C:

The applicant has applied for Group D Post As per advertisement in the N.F. Railway. On 5.12.04 the applicant appeared in the written test and he passed the written test on 7.4.05. The applicant has also qualified in the physical Efficiency Test. On



17.06.05 the applicant appeared Railway Recruitment Board, Guwahati for verification of the original documents. Thereafter, the applicant was treated as under aged. His age limit is in between 18 to 33 years and he was not empanelled. Being aggrieved the applicant has filed this O.A. seeking for the following reliefs:-

"To direct the respondent authorities to consider the case and select and appoint the applicant in the Group-D posts lying vacant in the N.F.Railway."

2. I have heard Mr. H. Rahman, learned counsel for the applicant and Dr.J.L.Sarkar, learned Standing counsel for the Railways. When the matter came up for consideration, the learned counsel for the applicant has submitted that he will be satisfied if direction is given to the 2nd respondent to consider the representation dated 21.9.05 (Annexures 6 (A),(B) and pass appropriate orders. Counsel for the respondents has submitted that he has no objection if such direction is given. For the ends of justice Court directs the 2nd Respondent or any other competent authority to consider his representation within a time framed of three months from the date of receipt of this order.

O.A. is disposed of accordingly. There will be no order as to costs.

III. LIMITATION.

The application further declares that the application is within the limitation period prescribed under the Act.

IV. FACT OF THE CASE.

1. That the applicant is a citizen of India and is the resident of New Colony, P.O. Lumding, P.S. Lumding, Dist- Nagaon, Assam.

2. The applicant has passed the H.S.L.C Examination and is constantly looking for a job in order to mitigate the poor economic condition of his family.

3. That while the applicant was in search of a suitable job he came across an advertisement published on 10.07.03 in the local English news paper "Assam Tribunal" for recruitment of group D post lying vacant in the N.F. 11. That the applicant begs to state that at the time of written examination he had completed 18 years age and also successful in all the stages of examination without any objection of respondents authority.

12. That the applicant begs to state that the applicant submitted a representation on 21.9.05 to the General Manager, N.F. Railway and the Chairman, Railway Recruitment Board, Guwahati to consider/relaxation of the applicant's age. However the case of the applicant was not considered for the reasons best known to them. It may be mentioned here that the General Manager, N.F. Railway is the competent under the rules to grant relaxation of age of a candidate in such circumstances, so that the candidate may not be required to suffer due to no fault on his part in this regard.

13. That the applicant begs to state that the respondent authority did not consider the case of the

(2) For that the humble applicant duly filed his application form along with all necessary testimonials and after due scrutiny of his form by the respondent authority and issued a written call letter (an admission certificate) to your humble applicant bearing Roll No. 14534352 for appearing in the written test which was conducted on 05.12.2006 and your humble applicant duly appeared in the said examination without any objection by the respondent authority.

(3) For that after due scrutiny of the application form by the Railway Recruitment Board, then issued a written call letter to the humble applicant. It was not fault the humble applicant, because respondent authority has after completed all scrutiny then issued a written called letter.

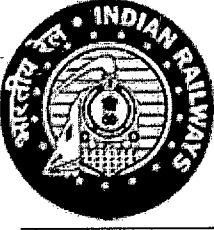


