The Applicant is a Category I

employee of the Jawahar Nagar Vidyalaya

(JNV in short). He was appointed as PGT (Bio)

in 2001. Applicant opted for posting in the

Shillong Region for mandatory period of three

years and therefore he is entitled for his

choice place of posting. After serving for

mandatory period presently he is serving in

JNV, East Imphal. Applicant contended that

during his last six years of service he has

been subjected to six transfers in different

schools thereby unsettling his personal life.

Moreover, his wife is undergoing medical

treatment at Imphal for suspected breast

cancer. The frequent transfers have not only

caused unstability to his service career but

also brought great prejudice to his minor son.

On 13.06.2007 he was again served with an

order dated 06.06.2007 transferring him to JNV, Morigaon on public interest. By the same order private Respondent is transferred in Applicant's place. Applicant submits that his transfer is done purported to be in public interest only to accommodate the private Respondent. According to the information private Respondent has not joined in her new place till this time.

A perusal of the impugned order will show that the Applicant is sought to be transferred during the mid-academic period acting on the request made by the private Respondent to accommodate her in his post, for which, according to the Applicant, he has been put to great hardship. Hence, this O.A.

Heard Mr.M.G.Singh, learned counsel for the Applicant. He submitted that the impugned transfer order is not passed on public interest but only to accommodate the private Respondent in total violation of the guidelines (Annexure-C). The relevant guidelines at page 26 of the O.A. is quoted below:-

"2.GENERAL POLICY OF TRANSFERS"

The Samiti does not transfer any teacher except under administrative exigencies. Only the requests for transfer are considered against available vacancies.

There is no fixed tenure of stay at a particular place (except mandatory tenure of three years in North East Region and other hard and

difficult stations notified by the Samiti). As such there is no question of displacement of any teacher to accommodate some other teacher. Thus no teacher can be posted to a place by removing another teacher."

Considering the above, pleadings and the submissions advanced by the learned counsel for the Applicant I direct the Respondents to keep the impugned order dated 6.6.2007 (Annexure-A) at abeyance till the next date and the Applicant will be permitted to continue in his present post if he is not already released and the private Respondent has not taken charge. In other words, status quo shall be maintained till the next date. Respondents will inform the private Respondent accordingly.

Since no notice could not be served due to the emergent situation I direct the Applicant to issue emergent notice ^{to} the Respondents including private Respondent for which he will take appropriate steps and pay the process.

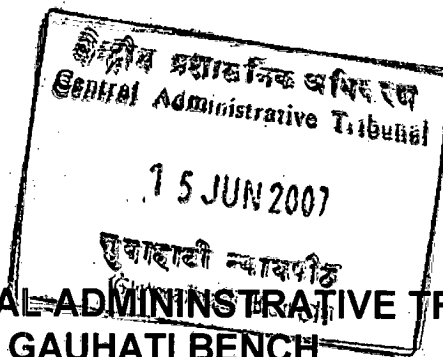

DETAILS OF THE APPLICATION

1. PARTICULARS OF THE ORDER AGAINST WHICH THE APPLICATION IS MADE :

This application is directed against the impugned transfer order dated 06/06/07 vide Memo. No. F.2-8/06- NVS (SHR) /Pers/951 issued by the Deputy Commissioner, Navaodaya Samiti, Regional Office, transferring the applicant from Jawahar Navodaya Vidyalaya , Imphal East to Jawahar Navodaya Vidyalaya, Morigaon and transferring the private respondent from Jawahar Navodaya Vidyalaya, Morigaon to Jawahar Navodaya Vidyalaya , Imphal East in place of the applicant.

2. JURISDICTION OF THE TRIBUNAL :

The applicant declares that the subject matter of the instant application is within the jurisdiction of this Tribunal.

3. LIMITATION:

The applicant declares that the instant application is filed within the limitation period prescribed under the Section 21 of the Administrative Tribunal Act, 1985.

4. FACTS OF THE CASE :

4.1 That the applicant is a citizen of India and a permanent resident of the State of Manipur in the district of Imphal West, and such he is entitled to all the rights, protection and privileges guaranteed under the Constitution of India and the laws framed thereunder.

4.2 That the respondent No.3 vide order dated 06/06/07 vide Memo. No. F.2-8/06- NVS (SHR) /Pers/951 transferred the applicant from Jawahar Navodaya Vidyalaya , Imphal East to Jawahar Navodaya Vidyalaya, Morigaon.

A copy of the impugned transfer order is annexed herewith and marked as **ANNEXURE – A**.

4.3 That the applicant begs to state that he is a Category I employee of the Jawahar Navodaya Vidyalaya having opted for posting in the Shillong Region for mandatory period of three years. As such he is entitled for posting at the ^A School of his choice.

A copy indicating posting in the Shillong Region for mandatory period of three years is annexed herewith and marked as **ANNEXURE – B**.

4.4 That the applicant since joining in the Jawahar Navodaya Vidyalaya as a PGT (Bio) in the year 2001, in the entire six years of service career in the Jawahar Navodaya Vidyalaya he has been subjected to frequent transfers altogether he was transferred six times in different schools thereby unsettling his personal life. Moreover, the wife of the applicant is presently undergoing medical treatment at Imphal for suspected breast cancer and the dependant brother of the applicant is bed ridden and paralytic. It is pertinent to mention herein that the applicant is the only earning member in the family apart from financial dependence the entire family members depend on him in other walks of life. The frequent transfer has not only caused instability to the service career of the applicant it has also brought grave prejudice to the minor son of the applicant in his education as well to the personal life of the applicant. However, the applicant respectfully begs to state that as a Government Employee he has to abide by the conditions of service but at

the same time the action of the respondent authorities has to be justifiable in the eye of law

4.5 That the applicant is presently serving as the PGT (Bio) in the Jawahar Navodaya Vidyalaya, Imphal East, on 13/06/07 he was served again with a purported transfer order wherein he was again transferred to Jawahar Navodaya Vidyalaya, Morigaon on purported public interest in lieu of the request made by the private respondent. *That till date at the time of filing this application the private respondent has not joined at Jawahar Navodaya, Imphal East.*

4.6 That the applicant begs to state that the private respondent is a permanent resident of Imphal East and as per the guidelines of the Jawahar Navodaya Vidyalaya, Samaiti an employee cannot be transferred and posted in the district where is a permanent resident.

A copy of the guidelines governing the transfer is annexed herewith and marked as **ANNEXURE - C.**

4.7 That the applicant begs to state that the private respondent being a resident of Imphal East she cannot be given posting at Jawahar Navodaya Vidyalaya, Imphal East as per the guidelines governing the transfer of an employee of the Samiti.

4.8 For that in any view of the matter, the impugned transfer dated 06/06/07 is not sustainable in the eye of law and as such it is liable to be set aside.

5. GROUNDS WITH LEGAL PROVISIONS

5.1 For that the action/inaction on the part of the respondent authorities in transferring the applicant is not sustainable in the eye of law and is liable to be set aside and quashed.

5.2 For that the transfer the applicant being made on extraneous consideration and ulterior motive to favour the private respondent is prima facie unconstitutional, illegal, arbitrary and malafide and as such is not sustainable in the eye of law and is liable to be set aside and quashed.

5.3 For that the transfer and posting of the private respondent being contrary to the guidelines governing the transfer and posting of the employee of the Samiti in as much as she cannot be posted in the district from where she hails is prima facie unconstitutional, illegal, arbitrary and malafide and as such is not sustainable in the eye of law and is liable to be set aside and quashed.

5.4 For that the transfer of the private respondent being made on request she could not have been posted at the School where there is no vacancy as provided in the guidelines governing the transfer and the same being done in contrary to the guidelines the impugned transfer order dated 06/06/07 is not sustainable in the eye of law and is liable to be set aside and quashed.

5.5 For that the transfer of teachers of the Samiti is done before the starting of the academic sessions and the same being done with vested interest to favour an individual employee at the cost of another employee, the impugned transfer order dated 06/06/07 is coupled favoritism and arbitrariness and as such is not sustainable in the eye of law and is liable to be set aside and quashed.

5.6 For that the applicant being a Category I employee having completed the mandatory period of three years he is to be posted at the school of his choice but in the case the same being done in contrary to the guidelines to

favour particular employee within the establishment, the impugned transfer order dated 06/06/07 is liable to be set aside and quashed.

6. DETAILS OF THE REMEDY EXHAUSTED

That the applicant declares that he has availed all the remedies available to him under the rules and guidelines.

7. MATTERS NOT PENDING WITH ANY OTHER COURT OR TRIBUNAL

That the applicant further declares that the matter regarding which this application has been made is not pending before any Court of Law or any other Bench of the Tribunal.

8. RELIEF SOUGHT FOR:

Under the facts and circumstances as stated above, it is most respectfully prayed that the Hon'ble Tribunal may be pleased to admit this application, call for the records of the case and upon hearing of the parties on cause or causes that may be shown and on perusal of the records be pleased to grant the following reliefs to the applicant :-

8.1 To set aside and quashed the impugned transfer order dated 06/06/07 vide Memo. No. F.2-8/06- NVS (SHR) /Pers/951 issued by the Deputy Commissioner, Navaodaya Samiti, Regional Office, transferring the applicant from Jawahar Navodaya Vidyalaya, Imphal East to Jawahar Navodaya Vidyalaya, Morigaon and transferring the private respondent from Jawahar Navodaya Vidyalaya, Morigaon to Jawahar Navodaya Vidyalaya , Imphal East in place of the applicant.

8.2 To direct the respondent authorities to rescind, cancel and forbear from taking any further action in consequence of the impugned transfer order dated 06/06/07 vide Memo. No. F.2-8/06- NVS (SHR) /Pers/951 issued by the Deputy Commissioner, Navaodaya Samiti, Regional Office and transferring the private respondent from Jawahar Navodaya Vidyalaya, Morigaon to Jawahar Navodaya Vidyalaya , Imphal East in place of the applicant .

8.3 To pas such further order or orders as Your Lordships may deem fit and proper.

9. INTERIM RELIEF PRAYED FOR

During the pendency of the application Your Lordships may be pleased to stay the impugned transfer order dated 06/06/07 vide Memo. No. F.2-8/06- NVS (SHR) /Pers/951 issued by the Deputy Commissioner, Navaodaya Samiti, Regional Office, transferring the applicant from Jawahar Navodaya Vidyalaya , Imphal East to Jawahar Navodaya Vidyalaya, Morigaon and transferring the private respondent from Jawahar Navodaya Vidyalaya, Morigaon to Jawahar Navodaya Vidyalaya , Imphal East in place of the applicant.

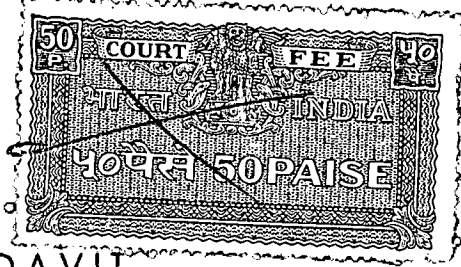
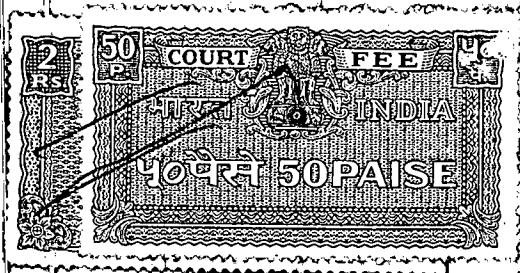

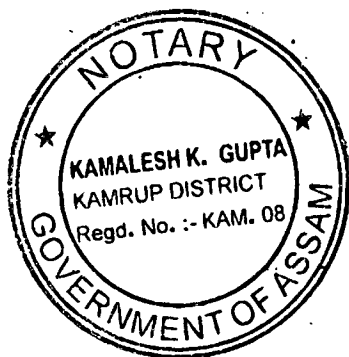
