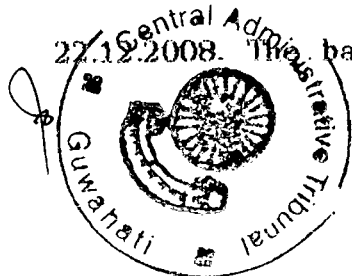

**ORDER (ORAL)**

**MUKESH KUMAR GUPTA, JUDICIAL MEMBER**

Issue raised in both these O.A.s being similar and common in nature, the same are dealt with by present common order. For sake of convenience, facts are delineated from O.A.No.27/2009.

2. Respondents vide circular dated 09.02.2007 decided to conduct departmental competitive examination to the post of Sub Divisional Engineer (Telecom) to fill up the vacancies for the vacancy years 2001-2002 to 2005-2006, and later on determined the eligibility list. Vide circular dated 27.06.2007, a list of eligible candidates as well as ineligible candidates was circulated. Both the applicants' names appeared in the list of ineligible candidates. No representation was preferred against it. It was only after more than a year when result of said examination was declared, they happened to prefer representation on identical basis on 12.07.2008 followed by reminders dated 25.07.2008. Further representation was also made on 22.12.2008. The basic plank of applicants had been that marks



obtained in Phase-1 Training when they were appointed to the post of Junior Telecom Officer, is the determining factor for deciding seniority list of said grade. It is contended that Shri Waryao Sareo as well as Shri Sarihaddu Seshagirirao obtained lesser marks than applicant in O.A.No.26/2009 and, therefore, they ought to have been treated as junior in the select list/seniority list of said grade of JTO. Recruitment to the next post of SDE is governed by the Recruitment Rules known as, "Sub-Divisional Engineer (Telecom), Recruitment Rules, 2002", notified on 28.02.2002. As per Schedule appended thereto, 75% posts are to be filled by promotion on the basis of seniority-cum-fitness and 25% by Limited Departmental Competitive Examination. As per column 12 of the said Schedule, JTOs who have rendered not less than "three years regular service in the grade as on 1<sup>st</sup> July of the year of Examination" is made eligible for applying for said post. Said column contains five notes. Note No.5 provides that: "where juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of requisite qualifying/eligibility service by not more than one year". Applicants' grievance is that they are not short of more than one year on the date of examination and as such, they are entitled to participate in the examination held for the vacancy of various years namely, 2001-02, 2002-03, 2003-04, 2004-05 as well as 2005-06.

3. It is not in dispute that Sarihaddu Seshagirirao joined the post of JTO on 24.06.2002 while Waryao Sareo joined said post on 08.07.2002. Both the applicants joined the said post on the same date namely, 26.10.2003.



4. Question which arises for consideration is whether Note 5 could be operated or not as contention raised by the respondents is that applicants being not eligible having not satisfied three years regular service in the grade were declared ineligible vide communication dated 27.06.2007 and thus there is no scope for judicial interference by this Tribunal.

5. We have heard Mr B. Sarma, learned counsel for the applicants in both O.A.s, Mr M.R. Das, learned counsel for respondents in O.A.No.27/2009 and Mrs M. Das, learned counsel for respondents in O.A.No.26/2009, and also perused the pleadings and other material placed on record.

6. In order to appreciate whether applicants can take recourse to Note 5 of column 12, it would be expedient to notice said clause, which reads as under:

"Where juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of requisite qualifying/eligibility service by more than one year."

(emphasis supplied)

7. We may also note that vide circular dated 16.04.2007, the date of eligibility with respect to vacancy year had been made known to all concerned. The relevant excerpts reads thus:

"Vacancy Yr"

Eligible Candidates

2001-02

Completed 3 yrs as on 1.7.2001

2002-03

Completed 3 yrs as on 1.7.2002

2003-04

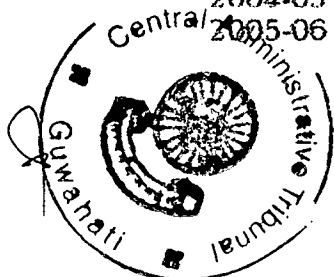
Completed 3 yrs as on 1.7.2003

2004-05

Completed 3 yrs as on 1.7.2004

2005-06

Completed 3 yrs as on 1.7.2005"



7. Perusal of the above would show that applicants were appointed as JTO on 26.05.2003. It is contended that certain alleged juniors namely, Sarihaddu Seshagirirao and Waryao Sareo were lower in seniority list, thus they could invoke said clause. In our considered view said clause Note 5 could be invoked only when they are short of requisite qualifying/eligibility service by not more than one year. The date of eligibility vacancy year 2005-06 as described vide circular dated 09.02.2007 was 01.07.2005. Applicants had joined said service only on 26.05.2003. Counting this date from 26.05.2003, it would be seen that on 01.07.2005 applicants would be short of more than one year service, namely one year one month and five days to be precise. In such circumstance their contention that said officials are juniors or otherwise has no relevance. Hence applicants' case is totally misconceived and misleading and, therefore, there is no justification in their claim.

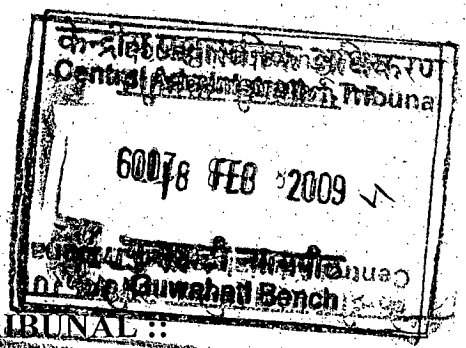
8. O.A.s being bereft of merits are accordingly dismissed. No costs.

**SYNOPSIS**

Being aggrieved by the deprivation and the discrimination meted out to the applicant in not allowing him to appear in the Limited Departmental Competitive Examination held for promotion of the Junior Telecom Officers to the post of Sub Divisional Engineer for vacancies pertaining to the year 2005-2006, he has come under the protective hands of Your Lordship's for redressal of his genuine and bonafide grievances.

The applicant was selected for appointment against the post of Junior Telecom Officer in the year 2001. Thereafter the respondent corporation sent him for the mandatory Orientation Training Programme w.e.f .17.02.2003 to 13.03.2003 in the Regional Telecom Training Centre, Nagpur on completion of which, he was engaged in field training in his division and was again sent for the Junior Telecom Officers Training (Phase-1) at the Regional Telecom Training Centre, Gachibowli, Hyderabad, w.e.f. 06.10.2003 to 12.12.2003, which the applicant completed successfully and consequently he was posted as a Junior Telecom Officer (OCB) in the BSNL office at Jorhat wherein the applicant is still continuing.

The next promotional avenue for the post of Junior Telecom Officer is the post of Sub Division Engineer. The promotion to the said post is governed by a set of Rules called the Recruitment Rules Of Sub Divisional Engineer (Telecom). Column 5 to 11 of the schedule to the said Rules deals with the method of recruitment, age limit, qualification and other matters relating to the said post. Column 5 of the schedule declares that the criteria for selection to the said post is Selection-cum-Seniority. Column 11 states that 75% of the posts are to be filled by way of promoting the eligible candidates on the basis of seniority cum fitness and the remaining 25% of the posts are to be filled by way of conducting a Limited Departmental Competitive Examination. Column 12 further declares that in case of incumbents aspiring to participate in the Limited Departmental Competitive Examination, a concerned Junior Telecom Officer has to render not less than 3 years of regular service in the grade on the 1<sup>st</sup> day of July of the year in which the examination is held, the crucial date for determining the eligibility of the incumbent being the 1<sup>st</sup> day of July of the year to which the vacancies pertain. Therein it is further stated that in case juniors in service who have completed their qualifying eligibility service and considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than one year.

In terms of a communication bearing letter No. 5-4/2005-DE dated 09.02.2007, the applicant applied for appearing in the Limited Departmental Competitive Examination that was to be held for selecting candidates for appointment against the posts of Sub Division Engineer pertaining to the year 2005-2006. As he was waiting in anticipation that he would be allowed to appear in the said Departmental Examination, the applicant was shocked and surprised to come across a communication bearing No. Rectt-1/57/2007/29 dated 27.06.2007 whereby he was declared to be ineligible for participation in the said Departmental Examination on the ground that he had not rendered 3 years of continuous service in the Grade of Junior Telecom Officer, which according to the respondent corporation is the requirement of the Rules of 2002.

It is pertinent to mention here that seniority in the cadre of Junior Telecom Officer is determined on the basis of the marks secured by an



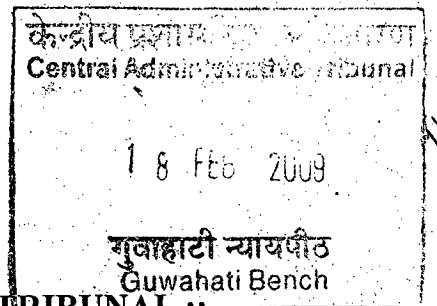
incumbent in the Phase-I training and Junior Telecom Officers who were junior to the applicant on the basis of the marks obtained in the said training, but have completed 3 years of continuous service in the cadre were allowed to participate in the said Departmental Examination, which fact automatically renders the applicant eligible to appear in the selection process initiated for promotion to the post of Sub Divisional Engineer in terms of the provisions contained in Column 12 of the Schedule to the Rules of 2002.

Highlighting the said aspect of the matter, the applicant preferred series of representation praying for ameliorating his genuine and bonafide grievance in not permitting him to appear in the said Departmental Examination, but his effort towards ameliorating his grievance was rendered in fructuous with the issue of a communication bearing No. Rectt-1/57/2007/63 dated 05.11.2008 by which the Assistant General Manager (Admn) communicating the rejection of his prayers to the General Manager Telecom, BSNL, Jorhat. As such, this application praying for urgent and immediate relief/ relief's.

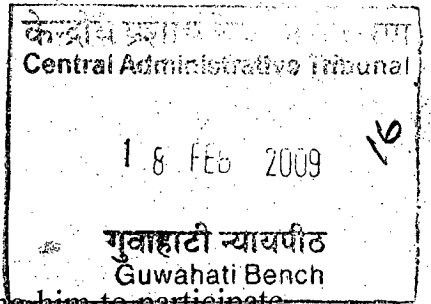


6. 16.04.07:- The respondent corporation extends the time for receipt of applications from incumbents aspiring to participate in the Limited Departmental Competitive Examination.

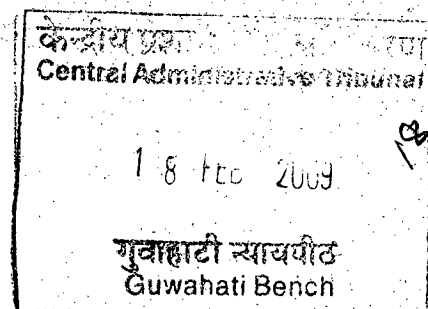

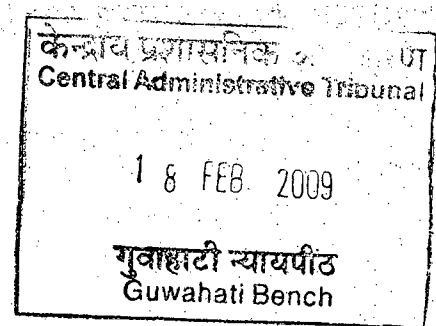
1. **PARTICULARS OF THE ORDER AGAINST WHICH THIS APPLICATION IS MADE:**

This original application has been preferred against the order bearing No. Rectt-1/57/2007/29 dated 27.06.2007 depriving the applicant to appear in the Limited Departmental Competitive Examination held for selection of candidates for the posts of Sub Divisional Engineer from amongst the Junior Telecom Officers (Telecom) for the vacancies pertaining to the years 2001-2002, 2002-2003, 2003-2004, 2004-2005 and 2005-2006 on the ground that the applicant does not fulfill the eligibility criteria of rendering 3 (three) years regular service in the Grade of Junior Telecom Officer on the 1<sup>st</sup> day of July of the year in which the examination was held. This application is further directed against the arbitrary, illegal and malafide action on the part of the respondent authorities in rejecting the prayer made by the applicant vide his representations dated 12.07.2008, 25.07.2008, 27.08.2008 and 29.12.2008 to mitigate his grievance as regards not allowing him to appear in the said Limited Departmental Competitive Examination held for the purpose of selecting candidates for the posts of Sub Divisional Engineer.

2. **JURISDICTION:**

The applicant further declares that the subject matter of the case is within the jurisdiction of the Administrative Tribunal.

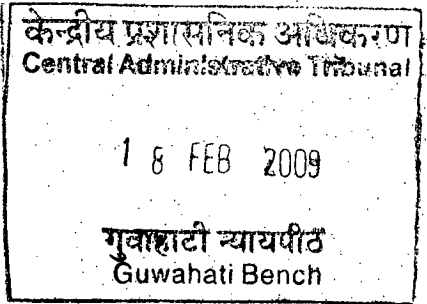
4.2. That the applicant states that pursuant to a process of selection, he was selected for appointment against the post of Junior Telecom Officer and was thereafter sent for the JTO orientation training programme w.e.f. 17.02.2003 to 13.03.2003 in the Regional Telecom Training Centre, Nagpur. On completion of the said training, the applicant along with the other candidates were relieved from the said center with instructions to report to their Divisions. During the period of training the applicant was paid stipend w.e.f. 17.02.2003 to 13.03.2003.

A copy of the order dated 13.03.2003 relieving the applicant from the Telecom Training Centre is annexed as Annexure- 1.

4.3. That the applicant states that after reporting in his Division in terms of the order dated 13.03.2003, he was engaged in field training and was again sent for the Junior Telecom Officers Training (Phase-1) at the Regional Telecom Training Centre, Gachibowli, Hyderabad, w.e.f. 06.10.2003 to 12.12.2003, which the applicant completed successfully and was thereafter relieved from the said Centre with instructions to report at GMTD, Jorhat.

A copy of the order dated 12.12.2003 relieving the applicant from the said Center is annexed as Annexure - 2.

4.4. That your applicant states that presently he is posted as a Junior Telecom Officer (OCB) in the BSNL office at Jorhat and has been discharging the duties and responsibilities entrusted to him to the best of his abilities and without any blemish to any quarter. The applicant for his hard work, dedication and sincerity towards his service has earned the praise of all concerned and never has he been communicated with any adverse remark in the matter of discharge of his official duties till date.

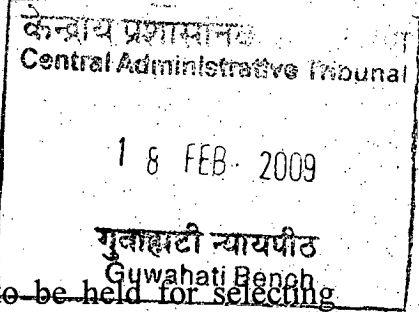
4.5. That your applicant states that the next promotional avenue for the post of Junior Telecom Officer is the post of Sub Division Engineer. The promotion to the said post is governed by a set of Rules called the Recruitment Rules Of Sub Divisional Engineer (Telecom). Column 5 to 11 of the schedule to the said Rules deals with the method of recruitment, age limit, qualification and other matters relating to the said post. Column 5 of the schedule declares that the criteria for selection to the said post is Selection-cum-Seniority. Column 11 states that 75% of the posts are to be filled by way of promoting the eligible candidates on the basis of seniority cum fitness and the remaining 25% of the posts are to be filled by way of conducting a Limited Departmental Competitive Examination. Column 12 further declares that in case of incumbents aspiring to participate in the Limited Departmental Competitive Examination, a concerned Junior Telecom Officer has to render not less than 3 years of regular service in the grade on the 1<sup>st</sup> day of July of the year in which the examination is held, the crucial date for determining the eligibility of the incumbent being the 1<sup>st</sup> day of July of the year to which the vacancies pertain. Therein it is further stated that in case juniors in service who have completed their qualifying eligibility service and considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than one year.

A copy of the recruitment Rule along with the schedule is annexed as Annexure – 3.

4.6. That your applicant states that in terms of a communication bearing letter No. 5-4/2005-DE dated 09.02.2007 he applied for appearing in

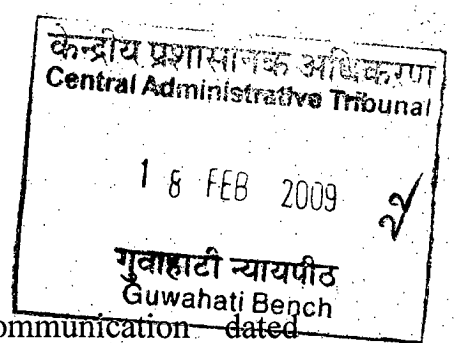


the Limited Departmental Competitive Examination to be held for selecting candidates for appointment against the post of Sub Division Engineer pertaining to the year 2005-2006. It is pertinent to mention here that the respondent corporation through its Personnel-II Section vide its communication bearing No. 2-29/2005-Pres.II dated 16.04.2007 intimated all concerned regarding extending the last date of receipt of applications for appearing in the said examination to 25.04.2007. Vide the said communication dated 16.04.2007, the respondent corporation also clarified the doubts as regards the eligibility of the incumbents with regard to fulfilling the requirement of rendering 3 years service in the grade of Junior Telecom Officer. The doubt mentioned at Serial No. 1 of the said communication clarified the date on which an incumbent should have to complete 3 years of continuous service. At serial no.2 it stated that the period spent on training for appointment as Junior Telecom Officer is to be reckoned towards counting the 3 years regular service period in terms of the Office Memorandum dated 08.03.1983. At serial no. 3 it was further reiterated that in case juniors in service who have completed their qualifying eligibility service and considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than one year.

A copy of the communication dated 16.04.2007 is annexed as Annexure- 4.

4.7. That your applicant states that as he was waiting in anticipation that he would be permitted to appear in the abovementioned Departmental Examination, he was shocked and surprised to come across the communication bearing No. Rectt-1/57/2007/29 dated 27.06.2007 whereby a list of candidates was enclosed who were found not eligible to appear in the abovementioned examination in terms of the provisions of the Recruitment Rules of 2002 and the amendments thereof effected from time to time. The name of the applicant appeared in the said list at serial no. 5 and he was declared ineligible to appear in the said Departmental Examination.

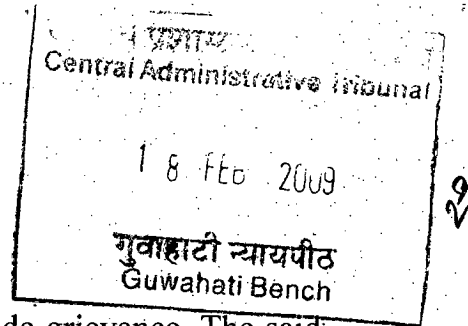

4.8. That your applicant states that on rejection of his candidature for appearing in the Limited Departmental Competitive Examination, he enquired in the office of the respondents as regards the ground for rejection of his candidature and he could learn from his office sources that he did not fulfill the eligibility criteria of rendering 3 years of continuous service in the grade of Junior Telecom Officer. It is pertinent to mention here that recruitment to the post of Junior Telecom Officer is made on an All India Basis, but the seniority in the cadre is determined on the basis of the marks obtained in the Orientation Training/Phase-I training imparted to these recruits.

4.9. That your applicant states that on further enquiry he could learn that his juniors in the cadre of Junior Telecom Officer, but who have completed the requirement of putting in 3 years of continuous service in the cadre namely Sri Sarihaddu Seshagirirao, Assam Circle and Sri Waryao Sareo, Assam Circle and had obtained lesser marks than the applicant in the Orientation Training/Phase-I training were permitted to appear in the said Departmental Examination, which fact makes him eligible to appear in the said examination in view of the provisions contained in Column 12 of the Schedule to the Rules of 2002 and also the clarification given to the doubts raised at Serial No.3 of the communication dated 16.04.2007. The abovementioned provisions clearly states that in case juniors in service who have completed their qualifying eligibility service and considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than one year. The juniors of the appellant who were recruited through the same recruitment process and belong to the 2001 Batch of the Junior Telecom Officers having been allowed to appear in the said Departmental Examination, automatically renders applicant eligible to appear in the said examination inasmuch as he does not fall short of the requisite qualification/eligibility service by more than one year for the vacancies of Sub Divisional Engineer pertaining to the year 2005-2006 and highlighting the said aspect of the matter, he preferred a representation dated

12.07.2008 towards redressal of his genuine and bonafide grievance. The said representation was forwarded to the concerned authority by the office of the Divisional Engineer (D-TAX, Mobile), Malowali, Jorhat vide his letter dated 15.07.2008. Thereafter the appellant preferred another representation dated 25.07.2008 reiterating the claims and prayers made by him vide the representation dated 12.07.2008.

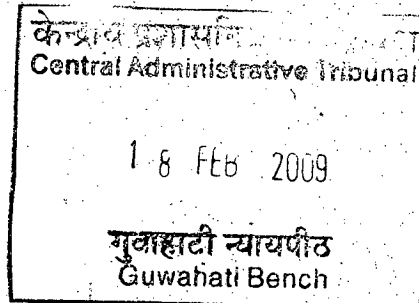

4.10. That your applicant states that in the meantime the respondent corporation conducted the said Limited Departmental Competitive Examination on 15.07.2008 and also declared the result thereof publishing a merit list of candidates who were successful in the said Examination under the 25% quota vide its communication bearing No. 5-3/2007-DE dated 08.07.2008.

A copy of the communication dated 08.07.2008 is annexed as Annexure – 9.

4.11. That your applicant states that finding no response to his representations dated 12.07.2008 and 25.07.2008, he once again reiterating his earlier claim preferred another representation dated 27.08.2008 and the said representation was once again forwarded to the office of the DE (Admn & Opn), GMTD, BSNL, Jorhat on the same date. In response to the abovementioned representations, the office of the Assistant General Manager (Admn) communicated to the office of the General Manager Telecom, BSNL, Jorhat vide the communication bearing No. Rectt-1/57/2007/63 dated 05.11.2008 the decision towards rejection of the prayer made by him on the ground that he had not raised his objections before the commencement of the examination. The rejection of the prayer of the applicant was communicated to him vide the communication bearing No. E-7/Group-B/Exam/2008-09/21 dated 06.01.2009.

4.12. That the applicant states that in the meantime, ignorant of the fact that his prayers for redressing his grievance towards not allowing him to appear in the Limited Departmental Competitive Examination has been rejected, he preferred another representation before the Chairman and Managing Director, BSNL on 29.12.2008 and the same was forwarded to the office of the DE ( Admn & Opn ) on the same day for onward submission, but no response has been received by the applicant till date on his said representation dated 29.12.2008.

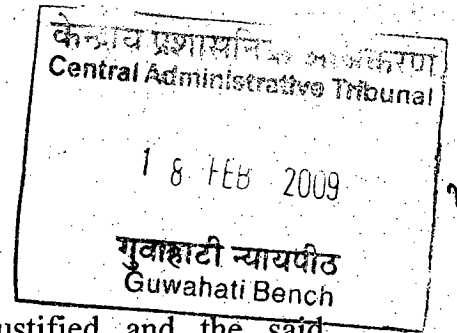

4.13. That the applicant states that the office of the Chief General Manager, BSNL, Assam Telecom Circle had in the meanwhile vide an order bearing No. STES-5/2/Pt-VII/89 dated 26.11.2008 directed for promoting the candidates selected for appointment against the posts of Sub Divisional Engineer and consequent thereupon the selected candidates have been appointed against the said posts, wherein persons junior to the applicant in the cadre of Junior Telecom Officer are also included.

A copy of the order dated 26.11.2008 is annexed as Annexure – 16.

4.14. That the applicant states that the ground of rejection of his candidature for appearing in the Limited Departmental Competitive Examination that he has not rendered 3 years of continuous service in the grade

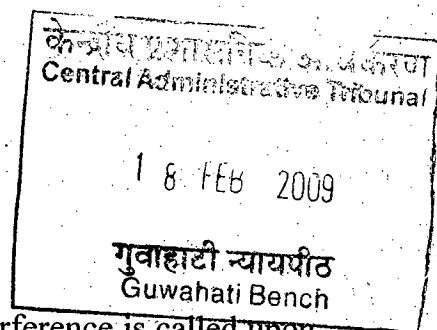
of Junior Telecom Officer is untenable, and unjustified and the said requirement automatically got waived in respect of the applicant when his juniors in the said grade were permitted to appear in the said examination, consequently making him eligible to appear in the said examination under the provisions of Column 12 of the Schedule to the Rules of 2002.

4.15. That your applicant states that the contention of the BSNL authorities in the communication dated 05.11.2008 that no objection/appeal was preferred before commencement of the Limited Departmental Competitive Examination regarding rejection of his candidature is uncalled for on their part. The duty is cast upon the respondent authorities to ensure that no anomaly occurs in the short listing of the candidates resulting in deprivation to others and not on the applicant to pursue his case before his masters, which seems to be a "Sine Qua Non" in case of the respondent authorities. The applicant came to know regarding the anomaly committed in short listing the candidates only after declaration of the results of the examination wherein the names of their juniors figured in the list of successful candidates.

4.16. That your applicant states that persons junior to him in service in the cadre of Junior Telecom Officer and recruited in service by the same recruitment process having been allowed to appear in the Limited Departmental Competitive Examination held on 15.07.2007 for selecting candidates for the post of Sub Divisional Engineer, the applicant was also required to be permitted to appear in the said selection process and denial of opportunity to him to appear in the said examination has highly prejudice the applicant and violated the mandate of Article 14 and 16 of the Constitution of India and renders the entire selection process to be illegal and a nullity in the eyes of law.

4.17. That your applicant states the action on the part of the respondent authorities in not allowing him to appear in the Limited Departmental Competitive Examination is highly illegal and arbitrary and has resulted in meting out the applicant with hostile discrimination, which is not based on any "Intelligible Differentia" and the said action of the respondent authorities is

uncalled for on the part of a "Model Employer" and interference is called upon from this Hon'ble Tribunal towards redressal of the grievance of the applicant.

4.18. That the applicant states that the discrimination meted out to him in not permitting him to appear in the Limited Departmental Competitive Examination has resulted in a perpetual/continuous grievance for the applicant inasmuch as he ranks junior in service to his erstwhile juniors in the cadre of Junior Telecom Officer and the scale of pay received by him at present against is much lower than the scale of pay received by his erstwhile juniors now in the cadre of Sub Divisional Engineer resulting in continuous deprivation and discrimination being meted out to him.

4.19. That the applicant states that inaction and the wanton attitude of the BSNL authorities have violated the principles of Natural Justice, Administrative Fair Play and the set of Rules established by law in not extending to the applicant his just and legitimate claim and thereby infringes upon the mandate of Articles 14, 16(1), 39(a) & 309 of the Constitution of India.

4.20. That the applicant states that he has no other appropriate, equally efficacious alternative remedy available to him and the remedy sought for herein when granted would be just, adequate, proper and effective.

4.21. That the applicant demanded justice, but the same has been denied to him.

4.22. That this application has been filed bonafide for securing the ends of justice.

## 5. GROUND FOR RELIEF WITH LEGAL PROVISIONS:

5.1 For that the action on the part of the respondent authorities in not permitting him to appear in the Limited Departmental Competitive Examination for selection of candidates for vacancies pertaining to the year

2005-2006 in the cadre of Sub Divisional Engineer is bad in law as well as in facts.

5.2 For that the ground of rejection of his candidature for appearing in the Limited Departmental Competitive Examination that he has not rendered 3 years of continuous service in the grade of Junior Telecom Officer is untenable, and unjustified and the said requirement automatically got waived in respect of the applicant when his juniors in the grade were permitted to appear in the said examination, consequently making him eligible to appear in the said examination under the provisions of Column 12 of the Schedule to the Rules of 2002.

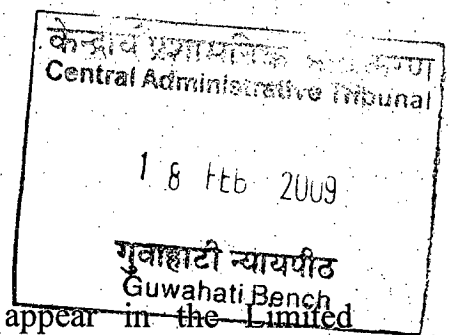
5.3 For that the BSNL Administration has not followed the cardinal principles of "Equality Before Law" and "Equal Protection of the Law" and thereby invited discrimination amongst employees and infringed the Constitutional mandate guaranteed under Article 14 and 16.

5.4 For that the BSNL Administration have flouted their own set of Rules and violated their own policy decisions on recruitment of incumbents to the cadre of Sub Divisional Engineer.

5.5 For that the BSNL Administration's stand towards not permitting the applicant to appear in the Limited Departmental Competitive Examination was absolutely unjustified and in violation of its own policies and rules and resulted in blatant discrimination and the infringement of Constitutional safeguards for the Right to Equality and Right to Employment and thereby hits the Article-14, 16(1) of the Indian Constitution.

5.6 For that the BSNL Administration turned down all the representations/ appeals preferred by the applicant to examine his case on merits as per law/ rules and consider permitting him to appear in the Limited Departmental Competitive Examination in true perspective of dealing with the case of employees in a welfare state and not according to its whims and caprices.

5.7 For that permitting his juniors to appear in the Limited Departmental Competitive Examination and their subsequent promotion to the cadre of Sub Divisional Engineer has resulted in great injustice to the applicant and caused irreparable loss any injury to his service career for no fault of his own.

5.8 For that in any view of the matter the impugned action on the part of the respondent authorities in denying the applicant to appear in the Limited Departmental Competitive Examination is unsustainable in the eye of law.

6. **DETAILS OF THE REMDIES EXHAUSTED:**

The applicant declares that he has no other alternative and efficacious remedy except by way of filing this application. As such he is seeking urgent and immediate relief.

7. **MATTERS NOT PREVIOUSLY FILED OR PENDING BEFORE ANY OTHER COURT:**

The applicant further declares that no other application, writ petition or suit in respect of the subject matter of the instant application is filed before any other court, authority or any other bench of the Hon'ble Tribunal nor any such application, writ petition or suit is pending before any of them.

8. **RELIEF SOUGHT FOR:**

Under the facts and circumstances stated above, the applicant prays that this application be admitted, records be called for and notice be issued to the respondents to show cause as to why the relief's sought for in this application should not be granted and upon hearing the parties and on perusal of the records, be pleased to grant the following relief's.

6. The leave, if any requested by the officers, who has been posted on promotion to a different circles should not be allowed. If any officer desires leave, he / she can apply for leave to new competent Authority under whom he / she has been posted only after joining the new post and the competent Authority will sanction leave, if it is considered justified in the normal course.

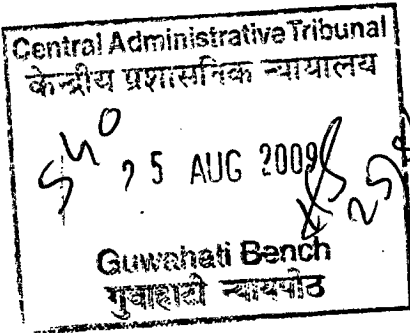

**REPLY TO THE FACTS OF THE CASE**

- 3.1 That with regard to the statement made in paragraph 1 of the O.A., the humble answering respondent begs to state that the Departmental Competitive Examination for promotion of Grade of Sub – Divisional Engineer (Telecom) under 25% quota against R/R of SDE was received from the BSNL Corporate Office , New Delhi vide No. 5-4/2005-DE dated 09.02.2007. The said letter was circulated to all the SSA Heads / Units vide letter No. Rectt.-1/57/2007/9 dated 23.02.2007 , so that the officials who were found eligible with the eligibility condition and desired to appear in the said examination could submit their application in prescribed format.

**Two copies of examination notices Issued vide No. 5-4/2005-DE dated 09.02.2007 & vide No. Rectt.-1/57/2007 dated 23.02.2007 & R/R of SDE (T) is annexed as Annexure – I,II & III respectively.**

- 3.2 That with regard to the statement made in paragraph 2 and 3 in the original application humble respondent has no comments to be made.
- 3.3 That with regard to the statement made in paragraph 4.1, 4.2, 4.3 of O.A. the humble answering respondents has no comments to be made and as the statements made are from the record.
- 3.4 That with regard to the statement made in paragraph 4.4 and 4.5 the humble answering respondent has no comments being the facts matter of record.
- 3.5 That with regard to the statements made in paragraph 4.6 of the O.A., the humble answering respondent begs to state that as already stated in previous paragraphs the promotion to Grade of SDE (Telecom) under 25% quota was received from BSNL Corporate Office and as such the officials who were eligible and desired to appear in the said examination may submit the application. The BSNL Corporate Office , New Delhi vide letter No. 2-29/2005- Pers.-II dated 16.04.2007 had intimated the date for reckoning 3 years of regular service along with other guideline as stated below :-

2001-2002	Completed 3 years as on 01.07.2001
2002-2003	Completed 3 years as on 01.07.2002
2003-2004	Completed 3 years as on 01.07.2003
2004-2005	Completed 3 years as on 01.07.2004

The applicant had submitted his application showing his date of joining in the J.T.O. Cadre on 26.05.2003 and the said application after necessary verification by the Divisional Engineer (Admn & Opn.) O/o the GMTD, Jorhat forwarded to the Circle Office, Guwahati.

A copy of the letter dated 16.04.2007 and a copy of application form of the applicant is annexed herewith and marked as Annexure – IV and V respectively.

3.6 That with regard to the statement made in paragraph 4.7 of the OA, the humble answering respondent begs to state the date of joining of applicant in J.T.O. Cadre is on 26.05.2003. As per the guidelines vide Corporate Office letter No. 2-29/2005-Pers.-II dated 16.04.2007, the applicant was not eligible for appearing in the Departmental Examination as he had not completed 3 years of regular service as on 01.07.2005 for the vacancy year 2004-2005 and 2005-2006. The applicant himself stated in the application that he had joined in the J.T.O. Cadre on 26.05.2003.

3.7 That with regard to the statements made in paragraph 4.8 of the OA, the humble answering respondent begs to state that the statements made are false and misleading. No enquiries were made by the applicant in the Circle Office, Guwahati regarding his candidature before the examination. In fact, the list of eligible candidates was issued on 27.06.2007 and further posted in the Circle web site. The list of non- eligible candidates was issued to all SSA Heads to inform the candidates under their control. This was done in a systematic manner so that if any discrepancy is found by any eligible / ineligible



candidate, the same could be brought to the notice of the competent authority for rectification of errors made in the list.

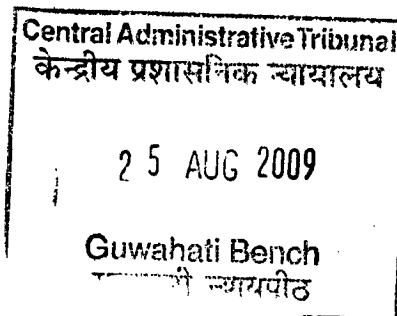
**Copies of the letter No. Rectt.-1/57/2007/28 dated 27.06.2007 and [redacted] are enclosed herewith as Annexure- VI and VII).**

- 3.8 That with regard to the statements made in paragraph 4.9 and 4.10 of the OA, the humble answering respondents begs to state that the submissions have been made in Para 4.8 above already.

It is further submitted that the applicant neither made any complaint that his juniors had found place in the eligible list of candidates nor he brought it to the notice of the authorities that he is senior to Shri S. Seshagiri Rao and Shri Woryao Sareo. The applicant submitted the representation only after the announcement of the result. The complaint of other officials on the same issue received earlier was acted upon by the authorities promptly. It is further submitted that Shri S. Seshagiri Rao and Shri Woryao Sareo completed 3 years of regular service as stated in their application forms of examination. Thus the complaint lodged by the applicant is found to be without any base.

**Copies of applications filed by Shri S. Rao and W. Sareo are enclosed as Annexure- VIII & IX).**

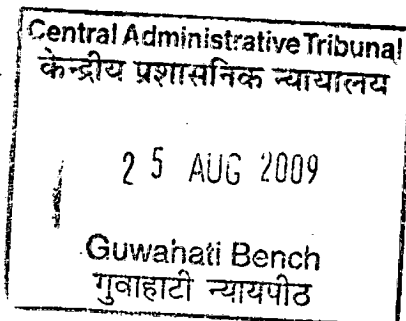
- 3.9 That with regard to the statements made in Para 4.11 & 4.12 of the application the answering respondent respectfully begs to state that in pursuance to the letter dated 12<sup>th</sup> July, 2008 filed by the applicant regarding eligibility to appear in Limited Departmental Competitive Examination for promotion held on 15<sup>th</sup> July, 2007, the Respondent No. 5 vide its letter No. Rectt.-1/57/2007/63 dated 05.11.2008 stated the reasons for rejection of the candidature of the applicant who had not completed the requisite 3 years of regular service as on 01.07.2005. The Respondent further stated vide its letter No. Rectt.-1/57/2007/29 dated 27.06.2007, list of candidates who were found not eligible to appear in the examination had been sent to all Heads



of SSA / Units and also list of eligible candidates for appearing in the examination was posted in the Circle web site before commencement of the examination. The respondent had not receive any objection from the applicant for rejection of his candidature.

**Copies of letter No. Rectt.-1/57/2007/63 dated 05.11.2008 and letter No. E-7/Grp.B/Exam./08-09/15 dated 25.07.2008 are enclosed as Annexure – X & XI respectively.**

- 3.10 That with regard to the statements made in Para 4.13 the respondent begs to state that it is not a fact that person junior to the applicant in the Cadre J.T.O. has been appointed in the promotional post of Sub-Divisional Engineer. The eligible officials who appeared in the competitive examination and qualified themselves on the basis of merit in the examination were promoted and all these are matter of records only.
- 3.11 That with regard to the statement made in Para 4.14 , 4.15 , 4.16 and 4.17 the humble answering respondent most respectfully begs to draw the attention that the applicant has submitted his application showing his date of joining in the JTO Cadre on 26.05.2003 and he did not complete 3 years of regular service as on 01.07.2005 for the vacancy year 2004-05 and 2005-06 and as such his candidature for appearance in the examination was rejected. Shri S. Seshagiri Rao and Shri W. Sareo were found completing 3 years of regular service and were eligible to appear in the examination. The applicant did not submit any representations that his juniors was placed in the eligibility list before the commencement of the examination and the respondent was not aware of the said fact and as such the statement made by the applicant "Sine Qua Non" does not apply.
- 3.12 That with regard to the statements made in Para 4.18 , 4.19 the humble respondent begs to state that the applicant got enough time to communicate his grievances before the respondent authority but he did not do so. The Department after completion of all the procedures regarding the examination declared the result and then only the applicant started to file objection.



- 3.13 That with regard to the statements made in Para 4.20 the humble answering respondent begs to state that the applicant may appear in the next examination which will be announced in due course of time.
- 3.14 That with regard to the statements made in Para 4.21 the humble answering respondent begs to state that the representations dated 12.07.2008, 25.07.2008, 27.08.2008 & 29.12.2008 made by the applicant are in no way possible for consideration of his case. The applicant did not file any objection regarding the eligibility of his candidature before the examination. The result of said examination had been declared long back and the officials who passed were promoted to the next higher post. Thus the OA filed by the applicant has no merit.
- 3.15 That with regard to the statements made in Para 5.1 to Para 5.8 the humble answering respondent begs to state that the submissions already made in preceding Paras, the OA is misleading and vexatious and is liable to be dismissed with costs.

That the deponent states that he had approached this Hon'ble Tribunal by way of filing the above mentioned Original Application raising a grievance against the arbitrary and illegal action on the part of the respondent authorities in not permitting him to appear in the Limited Departmental Competitive Examination held for promotion of the Junior Telecom Officer's to the post of Sub-Divisional Engineer for vacancies pertaining to the year 2005-06 on the ground of having not fulfilled the eligibility criteria for appearing in the said examination.

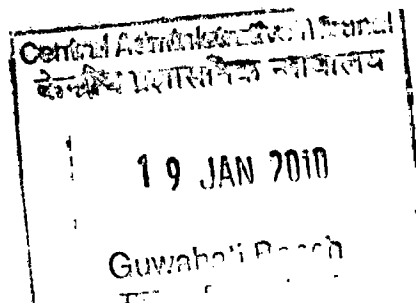
3. That the deponent states that the above mentioned Original Application was taken up for hearing on 12.01.10 and on the said date certain queries were raised by this Hon'ble Tribunal as regards the factual aspects of the matter and directed the deponent vide the order dated 12.01.10 to file an affidavit clarifying the said factual aspects. In terms of the order dated 12.01.10 the deponent begs to lay before your Honour the said factual aspects in the form of the present affidavit.

4. That the deponent states that the list dated 26.07.07 of the ineligible and eligible candidates were prepared by the respondent authorities after complying with the provisions of Column - 12 and Note - 5 of the Recruitment Rules of 2002. Further, the training period spent by an incumbent Junior Telecom Officer was also counted towards computing the eligibility criteria of having rendered three years of service in the grade of Junior Telecom Officer. The deponent had no role to play in the short-listing of candidates found ineligible and eligible to appear in the Limited Departmental Competitive Examination held by the respondent authorities. The deponent had no reasons to doubt the process of short listing of candidates when the highest authorities in the corporation carried out such exercise. It is pertinent to mention here that the authorities of the BSNL have prepared no seniority list of the incumbents in the cadre of Junior Telecom Officer on the date of filing of the Original Application before this Hon'ble Tribunal.

5. That the deponent states that seniority in the cadre of Junior Telecom Officer is determined on the basis of the marks secured by an incumbent in the Orientation Training/ Phase - I training imparted to the newly

recruited Junior Telecom Officer. The Junior Telecom Officers namely Sri Sarihaddu Seshagirirao, Assam Circle and Sri Waryao Sareo, Assam Circle who are junior to the deponent owing to securing lesser marks in the above mentioned training were allowed to appear in the Limited Departmental Competitive Examination held for the purpose of promotion of the Junior Telecom Officers to the grade of Sub-Divisional Engineers. Consequently, in terms of Column – 12 and Note – 5 of the Recruitment Rules of 2002, the deponent also became eligible to appear in the said Limited Departmental Competitive Examination, but due to the fault committed in short listing of the incumbent Junior Telecom Officers, the deponent was debarred from appearing in the above mentioned Examination.

6. That the deponent states that the fact that the above mentioned juniors of the deponent had secured lesser marks in the Orientation Training/ Phase – I training was not known to the deponent. The deponent and the above mentioned juniors had completed their Phase – I training in different batches and at different times. Had the respondent authorities prepared a seniority list of the incumbents in the cadre of Junior Telecom Officer, the deponent could have known about his seniority position in the cadre of Junior Telecom Officer vis-à-vis the above mentioned juniors namely, Sri Sarihaddu Seshagirirao and Sri Waryao Sareo. The respondent authorities having not prepared the seniority list of the incumbents in the cadre of Junior Telecom Officer, the deponent could not have known at the time of publishing the list of eligible and ineligible Junior Telecom Officers on 26.07.07, his seniority position vis-à-vis the above mentioned persons let alone the marks obtained by the said persons in the Phase – I training. As such, no fault can be attributed to the deponent for approaching the respondent authorities for amelioration of his grievances after the Limited Departmental Competitive Examination was over.

7. That this affidavit has been filed to bring on record the facts narrated herein above.

8. That this affidavit has been filed bonafide for securing the ends of justice.
