O R D E R (Oral)

By A.K. Gaur, Judicial Member -

After filing of the aforesaid Original Application the Registry has reported certain defects of limitation, jurisdiction and that no affidavit has been filed. When the case was called today, no one appeared for the applicant. Since the applicant is not present in the Court, we are constrained to ~~to~~ decide the case under Rule ¹⁵⁽¹⁾ ~~16(1)~~ of CAT (Procedure) Rules.

2. Having seen the record of the case, we are of the considered opinion that this Original Application is grossly time barred and the same is liable to be dismissed on the ground of delay and laches. Apart from delay, the applicant appears to be a member of the Armed Forces working in C.I.S.F. as a Constable and this Tribunal has no jurisdiction to decide the cases of ^{members of} Armed Forces. Hence, the OA is also not maintainable on the ground of jurisdiction.

3. In view of the above observations the Original Application is dismissed on the ground of delay and laches as well as on jurisdiction, in the admission stage itself.
