This Original Application has been filed against alleged supersession of the applicant in the matter of promotion to the post of Director (Engineering) (JAG). The applicant's case is that officers

junior to him have been promoted but he has been overlooked ~~although~~ ^{although} ~~as~~ ^{as} no adverse remark has ever been communicated to him. The applicant has submitted a representation to the Ministry of Information & Broadcasting on 14.6.06 (A-3), which has not yet been replied to.

2. Learned counsel for the applicant submitted that the applicant would feel satisfied if the respondent No.1 is directed to consider his representation and decide it within a specified period by a detailed and reasoned order and if any relief is due to him, that may also be given.

3. Accordingly we accept this prayer and direct the respondent No.1 to consider the representation of the applicant (A-3) and pass a detailed and reasoned order within a period of two months from the date of receipt of this order and if any relief is due to him, that may also be given to him within this period.

4. With these directions, the OA is disposed of.
