the light of the circulars, rules and notifications issued by respondent No. 1 from time to time, within a period of three months from the date of receipt of copy of the order by passing a reasoned and speaking order. Be it noted that while passing this order we had no occasion to go into the merits of the case. It is open to the respondents to take their own decision.
