By filing this Original Application, the applicant has sought the following main reliefs :-

- “1. ...to quash/set aside the order of removal from service dated 1.10.2001 and to grant the wages of the interim period.”
2. None is present on behalf of the applicant. Since it is an old matter of the year 2004, we are disposing of this OA by invoking the provisions of Rule 15 of Central Administrative Rules, 1987. Heard the learned counsel for the respondents and carefully perused the records.



3. The learned counsel for the respondents has submitted that the applicant has only challenged the order of removal dated 1.10.2001 (Annexure-A-1) passed by the disciplinary authority and he has not challenged the order passed by the appellate authority dated 18.1.2002 (Annexure-R-2) and also not challenged the order passed by the revisional authority dated 31.5.2002 (Annexure-R-1). Hence, this OA is not maintainable. We have perused the OA and we find that the applicant has only challenged the order of disciplinary authority dated 1.10.2001 and not challenged the order of appellate authority and revisional authority. Hence, this OA is not maintainable. Accordingly, the same is dismissed. However, the applicant is at liberty to file a fresh OA, if he still feels aggrieved and so advised. No costs.
