Heard the learned counsel for the parties.

2. The learned counsel for the respondents in this case has filed the short reply admitting the fact that due procedure has not been followed by them before passing the order of repatriation of the applicant. They have submitted that they be allowed to pass fresh orders after following the due procedure and the OA be disposed of accordingly. The learned counsel for

the applicant has no objection if fresh order of repatriation is passed after quashing the impugned order dated 2.12.2004 (Annexure A-1) and after following the due procedures.

3. Accordingly, we quash and set aside the order dated 2.12.2004 (Annexure A-1) with liberty to the respondents to pass fresh orders after following the due procedures which are laid down in the rules and instructions issued by the Government of India from time to time.

4. In view of the above, the Original Application stands disposed.
