in O.A.No.239/03. The order concerned is a detailed and speaking one wherein all the aspects have been duly considered. The present attempt by the review applicant is to have the matter reargued, which does not fall within the purview of Section 22(3)(f) of the Administrative Tribunals Act, 1985. The legal position is well settled that review is not an appeal in disguise.

3. There is no error apparent on the face of the record and we do not find any good ground for interference by way of review. The review application is accordingly rejected, being bereft of any merit.
