**ORDER (in circulation)**

**By M.P. Singh, Vice Chairman -**

This review application has been filed to review the order passed by the Tribunal on 5.11.2004 in OA No. 495/2004.

2. In the present RA, no clerical error or glaring mistake has been pointed out by the applicant. It is settled legal position that the review proceedings are to be strictly confined to ambit and scope of Order 47 Rule 1 of CPC. In exercise of the jurisdiction under order 47 Rule 1 of CPC it is not permissible for an erroneous decision to be reheard and



corrected. It must be remembered that a review petition has a limited purpose and cannot be allowed to be an appeal in disguise. The Hon'ble Supreme Court in the case of Union of India Vs. Tarit Ranjan Das, 2004 SCC(L&S) 160 has held that the Tribunal cannot act as an appellate court while reviewing the original order.

3. In view of the foregoing, we do not find any merit in this Review Application and accordingly, the same is rejected at the circulation stage itself. However, the applicant will be at liberty to approach this Tribunal if he still feels aggrieved and so advised, by the order so communicated by the respondents to him in compliance with the order passed by the Tribunal in O.A.
