

Common O R D E R (Oral)


The learned counsel for the respondents states that the facts, law and relief claimed by the applicants in all the aforesaid OAs are identical, therefore, we proceed to dispose of all these OAs by passing a common order.

2. By filing the aforesaid OAs the applicants have sought the following main relief :-

“(i) The order impugned dated 29.8.2003, passed by the respondents (Vice Ann.A/1) may kindly be set aside.

3. None is present on behalf of the applicants. We proceed to disposed of this OA by invoking the provisions of Rule 15 of Central Administrative Tribunal (Procedures) Rules, 1987. Heard the learned counsel for the respondents and perused the records carefully.

4. The learned counsel for the respondents have stated that the applicants in all the OAs are ~~to be~~ proposed to be allocated from Postal Accounts Office, Madhya Pradesh Circle Bhopal to newly created Postal Accounts Office, Chhattisgarh Circle at Raipur.



They have further stated that the issue involved in these OAs has already been decided by this Tribunal vide order dated 6.5.2005 in the case of Vivek Munje & Ors. Vs. UOI & Ors. in OA No 835/2004. They have² also submitted vide letter dated 20.4.2005, all the allocations made under order dated 29.8.2003 have been dropped and the transfers/identifications made vide order dated 9.8.03/29.8.03 does not apply. They have produced a copy of the order dated 20.4.2005 which is taken on records. We find that all these applicants have been allocated to newly created Postal Accounts Office, Chhattisgarh Circle at Raipur vide order dated 29.8.2003. Since the respondents have dropped the said list prepared by them for allocation to Chhattisgarh vide letter dated 20.4.2005, the present OAs have become infructuous. Accordingly, the OAs are dismissed as infructuous. No costs.
