2. The applicant, who is the son of Shri Afzal and Hussain, who had been retired on medical ground on the 23rd June 2001, and who has been paid the necessary retirement benefits, has approached this Tribunal for giving directions to the respondents to appoint him on compassionate ground. The details of his prayers have been submitted in paragraph 8 of the original Application. It is observed that he has submitted a representation in the matter to the respondents vide his letter placed at Annexure A-7. The respondents have not as yet replied to this representation of the applicant.

3. Under the circumstances the appropriate course

at this stage is to dispose of this original Application with directions to the respondents to consider the representation of the applicant placed at Annexure A-7 and dispose it of by issuing a reasoned and speaking order as per law and with reference to the scheme of appointment on compassionate ground given to the dependants of the Government servant within a period of 3 months from the date of receipt of this order. With this, this Original Application stands disposed of in terms of the above directions.
