As per the representation, two posts of PGT (Bio) at Dhana are lying vacant and the two teachers who have been promoted and posted at Dhana, listed at Sr. No. 41, Smt. U. Srivastava and Sr. No. 45, Smt. Alice Mathew in the KVS order dated 1.5.2003 (Annexure A-1) have probably foregone their promotion and have not joined.

Under the circumstances, the OA is decided at the admission stage with a direction to the respondent No. 1 to decide the representation of the applicant dated 25.6.2003 (Annexure A-9) within a period of one month from the communication of this order. Till the representation is decided by the appropriate authority, the applicant shall not be compelled to join at the new place of posting.
