By this OA, the applicants have challenged the order dated 30-5-2003 (Annexure A-1) by which the applicants have been regularised on the post of Khalasi from a back date. The claim is that the applicants were already promoted to higher grade. Against the impugned order, the applicants have made a representation (copy Annexure A-8). Their representation has not yet been decided. Learned counsel for the respondents, Shri M.N.Banerjee submits that DRB is ceased of the matter and is going to decide all the issues. The representation is still under consideration. Learned counsel for the applicant submits that he has no objection in case, the said



representation is decided by the respondents, but the applicants be given liberty to file a detailed representation because issue involves some legal points. Under the circumstances, we give liberty to the applicants to make a detailed representation within a period of seven days from the date of receipt of a copy of this order. Respondents shall decide the said representation within a reasonable time. Till the representation is decided, the impugned order shall not be given effect with respect to the applicants.

The OA stands decided accordingly. Costs easy.
