Heard learned counsel for both the parties.


The grievance of the applicant is that after  
the pay scale was revised as per recommendation of Vth


Pay Commission, the salary was fixed in the pay scale of Rs. 4500-7000, whereas his salary should have been fixed at Rs.5000-8000, in view of the fact that earlier pay scale drawn by him was Rs.1400-2300. The applicant made a request to his Controlling Officer at Raipur and who had in turn recommended it to D.G.H.S. This order of recommendation dated 26-5-2000 is annexed as Annexure A-3 of this OA. However, as per the applicant, no decision has been taken on this representation, which has been duly forwarded by his Controlling Officer. Equivalence of the old scale of Rs.1400-2300 to the revised scale of Rs.5000-9000 is mentioned in Annexure A-1.

For respondents, Mr. Om Namdeo states that the application is under consideration of the appropriate authority.

After hearing both the parties, we direct the respondents (appropriate authority) to take a decision in the matter within a period of four months from the date of communication of this order. Decision so taken, shall be communicated to the applicant.
