ORDER (ORAL)

Mr. Shanker Raju, Member (J):

As identical issue is raised having common questions of fact and law, these OAs are disposed of by this common order.

2. In all these OAs applicants who are working as Senior Auditors seek parity in their pay scale with the Assistants in Central Secretariat and Stenographers in various Departments/Ministries and claim benefit of various pronouncements of this Court. They have sought grant of pay scale of Rs.1640-2900 (unrevised) w.e.f. 1.1.1986 and also pay scale of Rs.5500-9000 w.e.f. 1.1.1996 with all consequential benefits.
3. Heard the parties. It is not disputed that different Benches of this Tribunal have allowed pay scale to Senior Auditors, including the Bench at Jabalpur in OA-785/96 in C.S. Chauhan & Others v. Union of India & Others decided on 13.2.2002 as well as the decision in OA-469/2000 decided on 30.7.2002 in Sushil Kumar Saloria and Others v. Union of India, wherein relying upon the decision of Madras and Guwhati Benches of this Tribunal, but in view of the pendency of appeal in High Court at Guwhati, the decision regarding arrears has been kept in abeyance. The Guwhati High Court in WP (C) No.7598/2001 by an order dated 28.9.2002 dismissed the Writ Petition against the decision of the Guwhati Bench of this Tribunal.
4. However, the decision of the Jabalpur Bench of this Tribunal in OA-469/2000 was assailed in WP-5910 of 2002 and by an order dated 12.12.2002 subject to

hearing the other side, operation of the order was stayed to the extent that respondents are not liable to pay arrears to applicants therein. However, pay from the month of January, 2003 onwards be paid as per the directions of the Court and pay scale assigned. It is stated by the learned counsel of applicants that the applicants be extended the benefits of these pronouncements with regard to grant of pay scale of Rs.1640-2900 w.e.f. 1.1.86 and Rs.5500-9000 w.e.f. 1.1.96 with all arrears. It is on the strength of the fact that Guwhati Bench decision has attained finality by rejection of the Writ Petition supra. It is further contended that applicants who are identically situated cannot be deprived of the benefit which has been accorded to similarly circumstance, which violates the enshrined principles under Articles 14 and 16 of the Constitution of India.


5. On the other hand, respondents vehemently opposed the contentions and contended that as the arrears have been stayed by the High Court of adjudicature at Jabalpur applicants' case if is identically situated would be considered if they prefer a representation to this effect to the respondents. However, it is stated that applicants are otherwise not entitled for the benefit.


6. We have carefully considered the rival contentions of the parties and perused the material on record. In the following decisions of the Apex Court it has been held that once a benefit is extended to an employee the same should also be extended to similarly situated in case they are identically situated and equal in all respects and cannot be denied either

on the ground that applicants were not parties to the earlier decision or there is delay in their approach:

- i) K.C. Sharma v. Union of India, 1998 (1) SLJ SC-54.
- ii) Ajay Jadhav v. Govt. of Goa, 2000 (1) SLJ SC 223.
- iii) Chander Prakash Madhav Rao Dawda v. Union of India, 1998 (2) SCSLJ 390.

7. Having regard to the aforesaid decisions and keeping in view the various pronouncements of this Court as well as decisions of Guwhati and Jabalpur High Courts, respondents are directed to consider the claim of applicants for accord of pay scale as referred to in para 8 of the OAs regarding grant of pay scale of Rs.1640-2900 w.e.f. 1.1.86 and Rs.5500-9000 w.e.f. 1.1.96 alongwith arrears, if they are identically situated and equal in all respects, within a period of three months from the date of receipt of a copy of this order, treating these OAs as representations of applicants, by passing a detailed and speaking order, under intimation to applicants. No costs.
