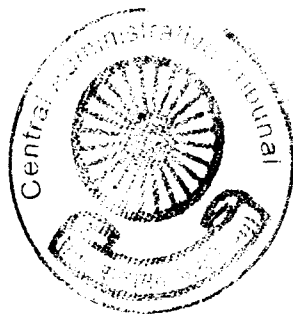

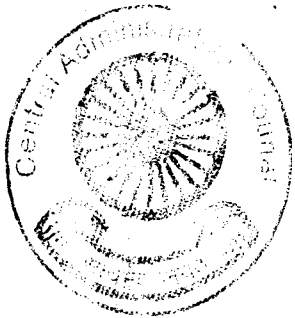
The applicant has filed this Original Application seeking a direction to the respondents for appointment of the applicant on the post of L.D.C. on compassionate basis as per the Rules.


The applicant has filed this Original Application seeking a direction to the respondents for appointment of the applicant on the post of L.D.C. on compassionate basis as per the Rules.
