O R D E R

By Anand Kumar Bhatt, Administrative Member:

The following reliefs have been sought
in the present OA:

- "I. to issue a direction to the respondents to forthwith provide 3 grade structures for CTIs as per memo. dated 28.2.94 (Annexure A-8) and also provide promotional avenues for CTIs to the post of Asstt. Lecturer as per memo. dated 21.12.85 (Annexure A-7).
- II. to direct the respondents to place the applicants on the pay scale of Rs.5500-9000 which is equalent to their counter parts in Polytechnic Colleges and Central Govt. Schools keeping in view the length of service i.e. 16-25 years of the applicants.
- III. to direct the respondents to grant relief No.2 to the applicants on basis of established principle of law i.e. "Equal Pay for Equal Work".
- IV. to call all original records pertaining to the case of applicants.
- V. to grant any other relief which may deemed fit."

2. Brief facts of the case are that the applicants are working as Civilian Technical Instructor (in short as 'CTI') 1 T.T.R, 1 Signal Training Centre, Jabalpur. Applicant No.1 has ^{Passed in} M.Sc. (Physics) and the other applicants are B.Sc. All the applicants are

in the grade of Rs.4500-125-7000 and they have been in the service of Respondent No.3 for the period between 16 to 25 years. However, this is an isolated post and they do not have any promotional channels.

3. The applicants have stated that the nature of work of Lecturer, Assistant Lecturer and CTI are similar in the sense^{that} all of them are providing technical training to the army personnel. Whereas the Vth Central Pay Commission recommended the scale of Rs.5000-8000 for Graduate Instructors, Civilian Education Instructors (Graduate in any discipline), the applicants are stagnating in the scale of Rs.4500-7000.

4. The applicants have stated that in the Central Govt. Schools there are 3 scales for Primary School Teachers, which are extracted below:

"1) Primary School Teacher

- (A) Rs.4500-7000 - Initially
- (B) Rs.5000-8000 - After 8 years service
- (C) Rs.5500-9000 - After 10 years service

ii) Upper Division Teacher:

- (A) Rs.5500-9000 - Initially
- (B) Rs.7500-12000 - After 8 years service
- (C) Rs.8000-13500 - After 10 years service

iii) Lecturers

- (A) Rs.6500-10500 - Initially
- (B) Rs.8000-13500 - After 8 years service
- (C) Rs.10000-14500- After 10 years service

5. A proposal was preferred by Respondent No.2 that the post of Assistant Lecturers may be filled 50% by direct recruitment and 50% by promotion from the grade of CTIs as in the case of Civilian Foreman of Signal. However, Union Public Service Commission (in short as 'UPSC') observed that there are two more scales between CTIs and Asstt. Lecturers, and therefore, jumping of scales

may not be possible to be sanctioned to the CTIs. ^{by 1st MC} Therefore, it was suggested to the Army Headquarters to create a three grade structure, viz., CTI, CTI-I and Senior CTI. The correspondence made between Army Headquarters and 1 STC and 2 STC are at Annexure A-6, A-7 and A-8. However, no decision has been taken on the issue as yet.

6. In the oral submission, Shri Prashant Singh, learned counsel for applicant, has reiterated the above.

7. The respondents, in their reply, have admitted that there is a stagnation in the cadre of CTIs, but they have stated that it was known to the applicants at the time of entry. The applicants are authorised to financial upgradation on completion of 12 years and 24 years of their service which is meant for such isolated posts. Such Scheme is known as Assured Career Progression Scheme.

8. The respondents have tried to distinguish between the qualifications for Assistant Lecturers and CTIs.

9. In the additional reply, the respondents have submitted that 1 STC had initiated the case for providing promotion avenues to the CTIs to the post of Assistant Lecturer in January, 1978. However, UPSC observed that as there are two more scales between the posts of CTI and Assistant Lecturers, jumping of two scales ^{is} ~~does~~ not permissible.

After that on being asked by Army Headquarters in December, 1985, a proposal for creating a 3 Tier structure for CTIs was moved to Army Headquarters in January, 1986. A fresh proposal was also submitted by 1 STC on 12.5.2001 to Army Headquarters. It has also been recommended that the CTIs who have acquired Post Graduate Qualification with minimum Second Division or equivalent grade in the relevant subjects and are found to be competent and willing to teach higher level subjects to the proposed Diploma level and TER/TES Class 1 courses, have been recommended for a monetary incentive of Rs.450/- per month. It was also recommended the avenue of promotion of CTIs who meet the qualitative requirements to the post of Assistant Lecturers or even Lecturer may also be considered.

10. We have seen the pleadings and heard the counsel on both the sides at some length.


11. A detailed proposal^{which} had been sent to Army Headquarters by 1 STC is at Annexure R-III attached to the additional return to the Rejoinder. This proposal, ~~xxxxxxxxxxxx~~ although in a very general way, ~~xxxxxxxxxxxxxxxxxxxx~~ ^{contains} including the cadre of CTI in the regular promotion channel to the post of Assistant Lecturer and Lecturer on their acquiring the requisite educational and other qualifications. The said letter dated 12.5.2001 (Annexure R-III) also mentions that a case in this regard is pending in the Tribunal.

11. In view of the foregoing discussion, we feel that ends of justice would be met if the present OA is disposed with direction to Respondents No.1 and 2 to take a decision on the said proposal sent by 1 STC on 12.5.2001 (Annexure R-III), within a period of six months from the date of receipt of a copy of this order. It is also observed that as the proposal has already been pending for more than two years it would be appropriate for Respondents No.1 and 2 to take a final decision within the aforesaid stipulated period in accordance with rules. We order accordingly.
12. The OA is disposed of accordingly. No costs.


