

ORDER (Oral)

By G. Shanthappa, Judicial Member -

The above Original Application is filed seeking the relief for direction to quash the impugned provisional seniority list Annexure A-15 as being unlawful and unsustainable in the eyes of law. It was further prayed to direct the respondents to



place the applicants enblock senior to the private respondents who are ^{sup.} though out holding the lower pay scale than that of the applicants and issue fresh seniority list accordingly. The further relief is to direct the respondents to consider the case of the applicants and promote them to the post of Chargeman Grade I (T-ech) with retrospective effect i.e. from the date when their juniors and persons holding the lower pay scale and equivalent pay scale had been promoted. ^{They} further pray to consider the case of the applicants for ^{ex-} promotion in accordance with the provisions made in the SRO No. 13-E of 1989 and grant promotion with retrospective effect when their counter parts in the equivalent pay scale and grade have been given the benefit of the same and granted promotion. In the alternative the respondents be directed to grant time bound promotion to the applicants as Senior Draughtsman in terms of the orders dated 15.09.1995 (Annexure A-5) and OM dated 19.10.1995 (Annexure A-4).

2. After hearing the advocate for the applicant and the advocate for the respondents, we are of the view that admittedly Annexure A-15 dated 23.05.1998 is a provisional seniority list. The applicants have submitted their objections to the provisional seniority list vide Annexure A-12. In pursuance to the said representation the respondents have not finalised the final seniority list. The learned counsel for the applicants submitted that direction be given to respondent No. 3 to finalise the seniority list on the basis of the objections submitted by them. The learned counsel for the applicants also submitted that they may also be given liberty to file an additional representation in respect of the latest developments taken place and to include the circulars regarding seniority, subsequent to filing of the OA.

3. Accordingly, we direct the applicants to file a detailed fresh representation to the respondents and they are at liberty to include the subsequent instructions/orders issued by the Government with regard to the fixation of the seniority, within a period of two months from the date of receipt of copy of this order. ^{Gr} After receipt ^{the respondents are} of the detailed representation from the applicants, ^{Gr} will ^{Gr} decide the same by passing a speaking, detailed and considered order within a period of three months from the date of receipt of the representation. Accordingly, the Original Application stands disposed of. No costs.
