ORDER (ORAL)

All the seven OAs are similar in nature and hence the same are being disposed of by this common order.

2. Learned counsel for the applicants contended that he has challenged the impugned order dated 8.4.2008 (Ann.A/1 in all the OAs) on the ground that as the applicants, who are working as Assistant Loco Pilots, were not given adequate training as per respondents orders/circulars, they could not pass the examination for the post of Loco Pilot Grade-II.

3. The aforesaid contention of learned counsel for the applicant is strongly controverted by learned counsel for the respondents.

3. However, at this stage, without challenging the impugned order on merit, as the same has attained finality, learned counsel for the applicants wishes to withdraw these OAs with a liberty to file afresh, if so advised.

4. In view of the foregoing, all the seven OAs stand disposed of as having been withdrawn with liberty to file afresh, if so advised. No order as to costs.
