**ORDER (ORAL)**

The applicants have filed this OA jointly for seeking relief of regularisation.



2. Learned counsel for the applicants produced a copy of the order dated 17.3.2011 passed in OA 81/2011 [Banty Sharma & Ors. v. UOI & Ors.], which was disposed of by this Tribunal at admission stage with a liberty to the applicants to file representation and the respondents were directed to consider the same in accordance with the provisions of law and the conditions laid down in the order of the Hon'ble High Court. Learned counsel for the applicants submitted that the present OA being similar he does not wish to press this OA on merit and similar relief, as granted in OA 81/2011, may also be granted to the present applicants.

3. In view of the order dated 17.3.2011, this OA also stands disposed of with liberty to the applicants to file fresh representation and the respondents are expected to consider the same in accordance with the provisions of law and the conditions laid down in the order of the Hon'ble High Court.

4. With these observations, the OA stands disposed of. IR granted earlier stands vacated.
