

### **ORDER (ORAL)**

Since similar question of facts and law is involved in these OAs, therefore, there are being disposed of by this common order.

2. Heard the learned counsel appearing for the respective parties.

3. Both the learned counsel for the parties agree that the controversy involved in these OAs is squarely covered by the judgment dated 1<sup>st</sup> May, 2012 rendered by this Tribunal in OA No.669/2011 along with other similar OAs as also the judgment dated 18.3.2010 passed in OA No.27/2010.

4. In view of the submissions made on behalf of the respective parties, since the controversy involved in the present OAs has already been considered in OA No.669/2011 and also in OA



No.27/2010, therefore, without discussing the controversy in detail, these OAs are disposed of in the light of the judgments dated 1<sup>st</sup> May, 2012 passed in OA No.669/2011 and dated 18.3.2010 in OA No. 27/2010. The judgments in the aforesaid OAs be treated as part of judgment in this OA. No costs.
