ORDER (ORAL)

The aforementioned OAs are heard together due to similar facts and the law involved and are being disposed of by this common order.

2. The applicants submitted these OAs with the prayer that they may be allowed pay of Rs. 292/- per day and are aggrieved and dis-satisfied with the impugned order dated 31.5.2011 by which their pay has been reduced from Rs. 292/- per day to Rs. 164/- per day. It is also contended on behalf of the applicants that the order dated 31.5.2011 was earlier challenged before the Central Administrative Tribunal, Jodhpur Bench and the CAT-Jodhpur Bench vide its order dated 14.8.2012 ordered as under:-

"(i) The impugned order dated 31.5.2011 (A1) is hereby quashed.

- (ii) The respondents are directed to continue making payment to the applicants @ 1/30<sup>th</sup> of the pay at the minimum of the time scale of the Group 'D' staff plus dearness allowance ie., Rs. 292 per days as basic pay w.e.f. 1.7.2008 with all consequential benefits.
- (iii) No modification of the OM dated 12.9.2008 is warranted as the legality of the OM has not been in challenge nor would the same be necessary for granting the reliefs (i) and (ii).
- (iv) No order as to the costs."

3. The learned counsel appearing for the applicants prayed that the controversy involved in the present OAs is squarely covered by the order dated 14.8.2012 passed by the CAT-Jodhpur Bench and the order dated 14.8.2012 is squarely applicable in the cases of the applicants. It will not be out of place to mention here that the relief claimed by the applicants before the CAT-Jodhpur Bench in various OAs was as under:-

- "(i) That the applicants may be permitted to peruse this joint application on behalf of five applicants under Rule 4(5) of CAT Procedure Rules, 1987.
- (ii) That impugned order dated 31.5.2011 (Annexure.A1) issued by 3<sup>rd</sup> respondent may be declared illegal and the same may be quashed. The respondents may be directed to make payment to the applicant @ 1/30<sup>th</sup> of the pay at the minimum of the time scale of pay of the Group D staff plus dearness allowances i.e., Rs. 292 per day as basic pay w.e.f. 1.7.2008 and applicant allowed with all consequential benefits including the due arrears thereof. The OM dated 12.9.2008 (Annexure.A2) may be ordered to be modified accordingly.
- (iii) That any other direction or orders may be passed in favour of the applicants, which may be deemed just and proper under the facts and circumstances of this case in the interest of justice.
- (iv) That the costs of this application may be allowed."

4. In addition to the relief claimed in the OAs filed before the CAT-Jodhpur Bench, decided vide order dated 14.8.2012, the applicants have also prayed for grant of temporary status in view of



the policy of the Government of India and it is contended that the issue of temporary status was not raised in the OAs decided by the CAT-Jodhpur Bench.

5. The learned counsel appearing for the respondents does not dispute to the extent that the order dated 31.5.2011 by which it was ordered that the daily wages of the casual workers without temporary status is to be paid at the rate of Rs. 164 per day, has earlier been assailed before the CAT-Jodhpur Bench. The order dated 31.5.2011 was issued in the light of the clarification issued by the Principal Chief Controller of Accounts, New Delhi vide communication dated 25.3.2011 and it is contended that the CAT-Jodhpur Bench has not granted temporary status to the applicants therein. It is also not in dispute that the 'Casual Labourers (Grant of Temporary Status and Regularisation) Scheme of Government of India, 1993' was applicable only to the casual labourers working at that point of time and it was not ongoing scheme, but was one time only. In such circumstances, the applicants cannot claim the benefit of temporary status or claim status at par with the workmen having temporary status.

6. The learned counsel appearing for the respondents further submits that the judgment passed by the CAT-Jodhpur Bench is per incuriam as the CAT-Jodhpur Bench has not considered the judgment of the Hon'ble Supreme Court in the case of S.C.Chandra and ors. Vs. State of Jharkhand and ors. reported in (2007) 8 SCC 279 and vide order dated 14.8.2012 has relied upon the judgment of Surindra Singh and another vs The Engineer-in-



Chief, CPWD and others reported in AIR1986 SC' 584, which was of the year 1986 and the same was considered by the Hon'ble Apex Court in subsequent judgments and referred the judgment in the case of State of Haryana and ors. Vs. Charanjit Singh and ors, reported in (2006) 9 SCC 321, decided by the Larger Bench of the Hon'ble Supreme Court. Having considered the judgment in the case of Surindra Singh, the Larger Bench has observed as under:-

".....The Full Bench judgment dealt only with daily rated and casual workers. Where a person is employed under a contract, it is the contract which will govern the terms and conditions of service. In the case of State of Haryana vs. Surinder Kumar and ors. Reported in MANU/SC/0516 :[1997]2SCR917, persons employed on contract basis claimed equal pay as regular workers on the footing that their posts were interchangeable. It was held that these persons had no right to the regular posts until they are duly selected and appointed. It was held that they were not entitled to the same pay as regular employees by claiming that they are discharging same duties. It was held that the very object of selection is to test eligibility and then to make appointment in accordance with rules. It was held that the Respondents had not been recruited in accordance with the rules prescribed for recruitment."

7. Having considered the rival submissions of the respective parties and upon careful perusal of the material available on record and the relief claimed by the applicants, so far as the relief claimed by the applicants to quash and set-aside the impugned order dated 31.5.2011 is concerned, the judgment rendered by the CAT-Jodhpur Bench is fully applicable as the Division Bench of the CAT-Jodhpur Bench has already quashed and set-aside the impugned order dated 31.5.2011. Therefore, having considered the order dated 14.8.2012 of the CAT-Jodhpur Bench, so far as the impugned order dated 31.5.2011 is concerned, the same is quashed and set-aside and respondents are directed to continue



making payment to the applicants @ 292/- per day instead of Rs. 164/- per day from the date when lesser payment of Rs. 164/- per day is paid to the applicants. The applicants are also entitled to arrears of lesser payment paid by the respondents.

8. So far as the relief claimed by the applicants that the applicants may be granted temporary status is concerned, I am in full agreement with the learned counsel appearing for the respondents that the scheme 'Casual Labourers (Grant of Temporary Status and Regularisation) Scheme of Government of India, 1993' was one time measure and was applicable only to the casual labourers working in the year 1993 and was not ongoing scheme and in view of the said scheme, the applicants cannot claim the benefit of temporary status or claim status at par with the workmen having temporary status. As already discussed hereinabove, the said scheme was one time measure and the same has been considered by the Hon'ble Supreme Court in the case of Union of India vs. Mohan Pal, reported in AIR 2002 SC 2001; Union of India vs. Gagan Kumar, reported in AIR 2005 SC 3107; Director General, Doordarshan vs. Manas Dey and Ors., reported in AIR 2006 SC 263 and Controller of Defence Accounts vs. Dhani Ram and Ors. reported in AIR 2007 SC 2650.

9. Therefore, in my considered view, the Casual Labourers (Grant of Temporary Status and Regularisation) Scheme of Government of India, 1993 is not applicable to the present case and the applicants cannot claim temporary status in view of the said scheme.



10. Consequently, these OAs are disposed of in view of the judgment rendered by the Division Bench of the CAT-Jodhpur Bench vide its order dated 14.8.2012 and the judgment of the CAT-Jodhpur Bench be treated as part of this judgment.

11. All the OAs stand disposed of in the above terms with no order as to costs.

12. Interim direction already issued on 22.11.2011 and 25.11.2011 stands merged in this order.
