Order

BY HON'BLE MR. SANJEEV KAUSHIK, MEMBER(J)

1. The present O.A. has been filed by the applicants praying for issuance of a direction to the respondents to grant benefit of upgradation flowing from the accepted recommendations of the 5th CPC.
2. Learned counsel for the applicant submits that the applicants have, at first instance, approached the respondents vide representation dated 11.11.2013 (Annexure A-7) for the grant of relevant benefit, raising all the pleas taken herein but no decision thereon has yet been taken.
3. Learned counsel for the applicants makes a statement at the Bar that the applicants would be content if a direction is issued to the respondents to consider and take a view on their representation within a stipulated time.
4. In view of the limited prayer made by the learned counsel for the applicants, there is no need to issue notice to the respondents and call for their reply. However, Mr. Deepak

Agnihotri, learned Senior Standing Counsel for the respondents, who is having advance notice, appears. He states that he has no objection to the disposal of the case in the requested terms.

5. Accordingly, we dispose of the O.A, without going into the merits of the case, with a direction to the Competent Authority amongst the respondents to take a view on the representation of the applicants and pass a reasoned and speaking order thereon within a period of three months from the date of receipt of a copy of this order. No costs.
