Applicant Mr A.K.Sarkar moves
this application in person. Learned Addl.
C.G.S.C Mr A.K.Choudhury is present for
the respondents.

The applicant has been transferred
to Guwahati from Patna as Director, SISI,
Guwahati and is continuing in Guwahati
in the same post till today. He has made
several representations for his transfer
to a choice place of posting in terms
of O.M.No.20014/3/83-E.IV dated 14.12.83
and departmental guidelines conveyed by
letter No.A-22012/1/90-Admn(G) dated
3.12.91 issued by Development Commissio-
ner, Small Scale Industries, New Delhi.
However, he has not been favoured with
a posting to the place of his choice
till today. The last representations
for posting in Calcutta were submitted
by him on 24.2.1995 and 30.5.95. In
this representation dated 30.5.95 he has
pointed out that a vacancy will arise in
Calcutta in rank of Director of SISI as
a result of retirement of Shri N.K:Guha,
Director, on 31.8.95. It is his conten-
tion that there cannot be any reason to
say that it is not administratively

feasible to accommodate him in Calcutta in view of the vacancy that is arising.

There is no case for scrutiny and decision in this application. Therefore the application is disposed of with the direction to the respondents to consider posting of the applicant in the place of his choice in terms of the guidelines contained in letter No.A-22012/1/90-Admn(G) dated 3.12.91(Annexure-5) issued by the Development Commissioner, SISI, New Delhi and also in terms of the O.M.No.20014/3/83-E.IV dated 14.12.83 (Annexure-VII) issued by the Government of India, Ministry of Finance. It is to be ~~addressed to the~~ ~~Additional Secretary and Development~~ mentioned here that on the strength and authority of the above guidelines dated 3.12.1991 and the O.M. dated 14.12.83 which grant benefits to the Central Government employees posted on transfer to the N.E.Region these employees have acquired a right to make choice of places of posting after completion of their tenure in the N.E.Region and also the right to be considered for posting in a place of their choice. The respondents are therefore also directed to consider the applicant, as first preference for posting in the aforesaid vacancy that will arise in Calcutta, a place of his choice, on 31.8.95 keeping in view the above policy of transfer.

The application is disposed of with the above direction.

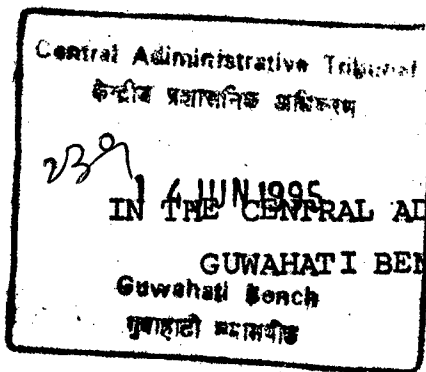

3. Particulars for which the application is made :

It is not against any order of the respondents but application is made to get choice station as per Govt. of India Policy on Fixed Tenure/choice station after serving in N.E. Region issued vide O.M.No.20014/3/83.E.IV dated 14th December, 1983.

4. Limitation :

The applicant declared that the application is within the limitation prescribed in Section 21 of the Central Administrative Tribunal Act 1985.

5. Jurisdiction :

The applicant declares that the subject of the case against which he wants redressal is within the jurisdiction of the Hon'ble Tribunal.

Facts of the Case :

1. That the applicant has served Central Government with dedication for nearly 26 years w.e.f. June, 1969 and was posted at Jamnagar, Allahabad, Patna etc. and served at various places viz. Trivandrum, Vizag, Muzaffarpur, Ranchi, Siliguri.

That the applicant's native place is in West Bengal.

2. That consequent upon the transfer order No.A-32012/06/89-Admn(G) dated 29-6-1990 (Annexure I Page 11-12) issued by the Development Commissioner(SSI), New Delhi, the applicant was transferred to SISI, Guwahati from SISI, Patna.
3. That as a humble Govt. servant the applicant obeyed the order, relinquished the charge of Director, SISI, Patna on 30-7-90 (Annexure-II Page 13) and resumed the charge of Director, SISI, Guwahati on 16-8-90 (Annexure III, Page 15).
4. That since 16-8-90, the applicant is dedicated in his work of development of industries in the States of Assam, Meghalaya and Arunachal Pradesh through 6 Branch Institutes under its control and has been successful in his effort of industrialisation.
5. That the applicant had given a representation No.A-19014(6)/90/8045 dated 11-2-91 (Annexure IV Page 17) to Development Commissioner(SSI), New Delhi with the request to transfer him to Calcutta as and when the vacancy arises and let him continue at Guwahati and worked there with dedication for speedy industrial development till he completed his tenure of posting in N.E. Region and the vacancy arises at the place of his choice at Calcutta.
6. That the Development Commissioner(SSI), New Delhi has issued following guidelines/norms for posting transfer of SIDO officers as follows vide letter No.A-22012/1/90-Admn.(G) dated 3-12-91 (Annexure V Page 19).

1) Para III(1) at page 20 says -

"All officers of SIDO will have to serve for at least one tenure of 3 years in the Region F, during their entire period of service in the Organisation."

ii) Para III(ii) at page 20 says -

"Generally no one will be required to serve more than one tenure in Region F. On completion of the tenure of 3 years in the Region F, everyone will have the option of posting to one of the two places of their preference, where the posts are available."

However, this principle of one tenure in North-Eastern Region will not be applicable to Officers of any grade at a particular level; where proportionately large number of posts have been created for the North Eastern Region only. In respect of such officers, depending upon the vacancy position, the officers may have to do two or three tenures in the Region F, in the course of their service."

7. That to the utter surprise of the applicant and in violation of own norms, Development Commissioner (SSI), New Delhi had transferred Shri T.N. Basu, Director, RTC, Bombay to RTC, Calcutta on 22-7-91 (Annexure IV VI Page 22) ignoring my claim and representation at (Annexure IV page 17). *Though Sri T.N. Basu had never served N-E region in any capacity.*
8. That Ministry of Finance, Deptt. of Expenditure had issued O.M.No. 20014/16/86/E, IV/E II(B) dtd. 1-12-88 (Annexure VII page 23) which says in para 1) on tenure of posting/deputation that "the existing provisions as contained in this Ministry's O.M. dated 14-12-83 (Annexure VII page 23) will continue.
9. That the Secretary, Ministry of Personnel & Training, Administrative Reforms & Public Grievance & Pension expressed in his D.O.No. 6/22/80/Estt(Pay)II dated 2-6-86 (Annexure VIII page 26) that the incentives as provided by Govt. of India vide Ministry of Finance O.M.No. 20014/3/83-E, IV dated 14-12-83 (Annexure VII page 23) to Central Govt. employees is not implemented and issued the Hon'ble Prime Minister's instruction (at para 3) as follows :

" After serving a full tenure in the tribal areas the officer should have choice of posting thereafter".

10. That the office of DC(SSI), New Delhi violated all norms and instructions of Govt. of India as enumerated at para 6, 8 & 9 above and again transferred Shri N.K. Guha, Director from (Annexure IX Page 27) Headquarter office to SISI, Calcutta after ignoring my claim and representations (Annexures IV, ~~XI, XII, XIII, XIV, XV, XVI, XVII~~ & at ~~XIX~~ pages 17).
11. That the applicant anticipated that the Department wants to victimise him and may transfer to distant place on the plea that the post at Calcutta is not vacant, so the applicant had included Guwahati in the option for posting vide letter No. A-22012(1)/91/5299 dated 21-1-94 to avoid further harrassment and humiliation (Annexure X page 28).
12. That the applicant came to know that the post of Director at SISI, Calcutta may fall vacant and the department may ignore his claim due to inclusion of Guwahati in the 'option for posting', the applicant immediately sent a representation at Annexure XI, ^{page 31} at page 30 option at Annexure XII ^{page 31} and representation at Annexure XIII } at page 32
13. That the applicant being of apprehensive of being ignored further sent a representation (Annexure XIV, XV & XVI page 33, 34, 35) through letter No. A-19014(6)/90/2384-85 dated 8/9-8-94 (Annexure XIV page 33).
14. That the applicant had received a letter No. A-22012/11/94-Admn(G) dated 8th Sept./94 (Annexure XVII page 36) that the applicant will be posted at Calcutta as and when the vacancy ~~is~~ arises.
15. That the applicant had given a representation vide letter No. A-19014(6)/90/6280 dated 24-2-95 (Annexure XVIII page 37, 38) to Shri Brahm Dutt, Joint Secretary & Development Commissioner(SSI), New Delhi with the request to transfer him to Calcutta explaining various difficulties.

16. That the present Director of SISI, Calcutta Shri N.K. Guha will retire on 31-8-95 after attaining superannuation and the post of Director at SISI, Calcutta will fall vacant w.e.f. 1-9-95 (Annexure XIX page 39)
17. That the applicant had therefore sent a representation to Shri S.A.T. Rizvi, IAS Addl. Secretary & Development Commissioner (SSI), New Delhi that the applicant may be posted at SISI, Calcutta after retirement of Shri N.K. Guha on 31-8-95 vide letter No. A-19014(6)/90/744 dated 30-5-95 (Annexure XX page 40, 41).
18. That the applicant have neither ^{received} ~~issued~~ order nor any other communication from Respondent No. 2 regarding his posting to SISI, Calcutta.
19. That the applicant apprehends that Development Commissioner (SSI), New Delhi will again ignore the legitimate claim of the applicant and will not post him at Calcutta inspite of the instructions issued by the Govt. of India.
20. Details of Remedies exhausted :
 - i) That the applicant had given 9 (nine) representations vide Annexures IV, XI, XII, XIII, XIV, XV, XVI, XVIII & XX, for his transfer to Calcutta.
 - ii) That the Department has violated the instructions of Govt. of India and transferred a number of Directors to SISI, Calcutta and RTC, Calcutta ignoring the legitimate claim of the applicant.
 - iii) As there is no response from the Respondent No. 2, there is no scope of any other remedy except to move the application before the Hon'ble Tribunal at Guwahati.

21. Reliefs prayed for :

Under the facts and circumstances the applicant pray for the following relief :

- i) Respondent No.2, i.e. the Development Commissioner(SSI), New Delhi may be directed to post the applicant at SISI, Calcutta as soon as the vacancy arises on 1-9-95 due to superannuation of Shri N.K.Guha, present Director of SISI, Calcutta as the applicant has completed 5 years (approx.) in N.E.Region (Annex VII Page 13) as per directive of Govt. of India O.M. No.20014/3/83-E. IV dated 14-12-83 & Prime Minister's instruction and also in terms (Annex VIII Page 26) of commitment of DC(SSI), New Delhi's letter No.A-22012/11/94-Admn(G) dated 8th Sept./94 (Annexure XVII) at page 36)

ii) The above relief is prayed for following ground :

- 1) That the applicant is working in N.E.Region at Guwahati for 5 years which is more than the tenure as specified by Govt. of India.
- ii) That in terms of O.M.No.20014/3/83-E. IV (Annex VII Page 23 & 26) dated 14-12-83, the applicant is entitled to the posting in his choice station Calcutta.
- iii) That the dependents of the applicant are wholly dependent upon the applicant and to look after his ailing aged mother, the applicant is required to stay at Calcutta.

22. Interim Relief :

- i) That the department may take time in filing counter affidavit. In doing so the department may post some other officer as Director at Calcutta ignoring the claim of applicant.
- ii) That the applicant therefore, prayed that stay order may be granted ^{restraining} to Respondent No.2 to post any other officer in lieu of the applicant till the disposal of application.

Sir,

During my recent visit to the Headquarters for attending the Senior Officers' meeting held on 28th & 29th January, 1991, the Joint Development Commissioner (SSI) was kind enough to offer me a transfer from SISI, Guwahati to the headquarters while discussing with him some important issues pertaining to my Institute. Needless to mention, I am very much grateful to him for his kind gesture shown to me and ordinarily I would have been very glad to accept the offer but for the following reasons :

(1) Barely 6 (six) months back I joined SISI, Guwahati on 16-8-90 as Director on my transfer from SISI, Patna despite my repeated protest. You will kindly appreciate that my transfer from SISI, Patna had entailed a lot of difficulties to me. Apart from the educational problem of my younger son, my sudden transfer from SISI, Patna to an easternmost Station at Guwahati had adversely told upon my health and so-much. So, I and my wife had a severe heart attack besides dislocation with my family members, economic hardship etc.

(2) I am now half the way settled down at Guwahati after admission of my school going son in a school in the middle of the academic session with great persuasion and personal influence. My son likely to appear for the Board Final Examination (Class X) with disturbance study for more than 3 months due to this transfer and readjustment in a new surroundings.

(3) In spite of my initial troubles and sufferings, I am now acclimatised with the local climatic conditions of this region and gradually I am establishing good contact with various promotional agencies at Central and State levels located in the N.E. Region for the development of small scale industries and that too within a short span of six months of my tenure of office. Naturally, I am confident that I will be in a position to spend my full term of posting at Guwahati without worries once I am settled down to the day to day normal life after initial setback.

Sir,

As you are aware, the Govt. of India have prescribed some guidelines for posting/transfers of Officers in the North Eastern Region vide Ministry of Finance, Deptt. of Expenditure OM No. 20014/3/83-E.IV, dated 14-12-83 (circulated through this Office letter No. A-26011(1)/82-A(NG), dated 22-5-84). Small Industries Development Organisation with Headquarters in Delhi has field offices located in all States/ Union Territories, throughout the country. Many of them are located in North Eastern Region. The personnel recruited on all India basis through UPSC/SSC in the SIDO are liable to be posted/transferred in any of the offices of the Organisation. Due to the absence of clear norms/guidelines with regard to transfer/posting in the Organisation, many officers continue to remain at a particular station without any disturbance while some others have faced transfers from one station to another. New recruits on many occasions decline offer of postings if such postings were not according to their preference. It has also been observed that officers in the Organisation show reluctance to move from one station to another on transfer, even on promotion, if the station where postings are ordered are not of their choice. In order to overcome these impediments and to mitigate as far as possible, the difficulties faced by officers on transfer from humanitarian or economic considerations and also keeping in view the overall interest of the Organisation, need has been felt to adopt some norms/guidelines for transfer and posting in the Organisation.

2. Accordingly, it has been decided to adopt the under-mentioned guidelines for transfer/postings in the Organisation:-

- I. These guidelines are indicative and general in nature and will not confer any right on any officer for seeking or resisting any transfer on the basis of these guidelines. The Govt. reserves the right to transfer any officer to any part of the country, in the exigencies of the public service.

II. SIDO offices other than the Headquarters office will be grouped into six regions as follows:-

<u>REGION</u>	<u>STATES/UTs WHERE OFFICES ARE LOCATED</u>
A	Jammu & Kashmir; Punjab and Himachal Pradesh, Haryana.
B	Delhi, Uttar Pradesh, Madhya Pradesh.
C	Rajasthan, Gujarat, Maharashtra, Dadra Nagar Haveli, Goa, Daman & Diu.
D	Karnataka, Andhra Pradesh, Tamil Nadu, Kerala, Pondicherry.
E	West Bengal, Bihar, Orissa, Andaman & Nicobar Islands, Sikkim.
F	Assam, Meghalaya, Arunachal Pradesh, Nagaland, Manipur, Mizoram and Tripura.

III.(i) All Officers of SIDO will have to serve for at least one tenure of 3 years in the Region F, during their entire period of service in the Organisation.

(ii) Generally, no one will be required to serve more than one tenure in Region F. On completion of the tenure of 3 years in the Region F, everyone will have the option of posting to one of the two places of their preference, where the posts are available.

However, this principle of one tenure in North-Eastern Region will not be applicable to Officers of any grade at a particular level, where proportionately large number of posts have been created for the North Eastern Region only. In respect of such officers, depending upon the vacancy position, the officer may have to do two or three tenures in the Region F, in the course of their service.

IV. Subject to para III above, officers of the level of Asstt. Directors (Gr. II) and below should not be transferred generally from one region to another, if post is available in that region, (excepting in the case of posting to Headquarters Office), unless there is a specific request from the individual officer concerned for posting outside the region or the exigencies of public service so demands.

V. On the same lines as followed for the purpose of grant of HRA and CCA to Central Govt. employees, offices in the SIDO shall be categorised into 3 types, namely A, B & C and every officer in the SIDO shall be categorised into 3 types, namely A, B & C and every officer in the SIDO has to serve at least one tenure in each category of station during his/her service in the SIDO, as far as possible.

VI. Of all other stations, not covered by para III above, the tenure will normally be 5 years.

VII. Officers who are within 3 years of their date of superannuation will not be transferred unless it involves promotion or unless exigencies of public interest specifically demand such transfer or to meet transfer request of the officers concerned subject to availability of vacancies at a particular station where the officer propose to settle down after superannuation.

VIII. First postings of the direct recruits (excepting those who are already working with SIDO) will normally be made at the main Institutes, so that a better opportunity can be provided to them, for getting acquainted with the objectives and functions of the Organisation.

IX. (i) In all other respects, officers posted in the North Eastern Region shall be entitled to all the benefits incorporated in the Ministry of Finance OM dated 14-12-83, mentioned above as amended from time to time.

(ii) Apart from these incentives and benefits, in so far as officers of the SIDO are concerned, whenever any proposal for training inside the country or abroad, foreign assignment, etc., are considered, due weightage will be given to the officers who have served or are serving in the Region F.

3. It shall be incumbent upon the local controlling authorities, i.e. Director/Deputy Director incharge to relieve the officers whose transfer has been ordered by the end of the next month from the date of issue of such orders, unless otherwise directed, irrespective of the fact whether the transferee officers had submitted any representation/request for change or cancellation of transfer or not.

4. In case any officer attempts to bring influence from outside to bear upon the authorities deciding the transfer/posting for a change of the transfer order to his own advantage, he will make himself liable to action as prescribed under Rule 20 of the CCS(Conduct) Rules.

5. In case an officer declines transfer on promotion or attempts to bring influence from outside to bear upon the authorities deciding transfer/posting, for a change in his transfer order to his own advantage, the officer may be transferred from the station of his position in the same capacity.

6. It may be reiterated that these are only general policy guidelines and will not confer any right on any individual for seeking a transfer. Any relaxation of these guidelines may be allowed in exceptional cases of extreme hardship or in public interest as deemed fit by AS&DC.

7. It is requested that these guidelines may be brought to the notice of all concerned.

has been engaging the attention of the Government Accordingly the President is now pleased to decide as follows:

The undersigned is directed to refer to this Ministry's O.M.No. 20014/3/83-B.IV dt. 14th Dec. 1983 and 30th March, 1984 on the subject mentioned above and to say that the question of making suitable improvements in the allowances and facilities to Central Govt. employees posted in North-Eastern Region comprising the States of Assam, Meghalaya, Manipur, Nagaland, Tripura, Arunachal Pradesh and Mizoram

1) Tenure of posting/deputation

The existing provisions as contained in this Ministry's O.M. dated 14.12.83 will continue.

1i) Weightage for Central deputation and training abroad:
Special mention in confidential reports.

The existing provisions as contained in this Ministry's O.M. dated 14.12.83 will continue. Cadre authorities are advised to give due weightage for satisfactory performance of duties for the prescribed tenure in the North-East in the matter of promotion in the cadre posts, deputation to Central tenure post and courses of training abroad.

1ii) Special (Duty) Allowance

Central Govt. Civilian employees who have All India transfer liability will be granted Special (Duty) Allowance at the rate of 12½% of basic pay subject to a ceiling of Rs. 1000/- per month on posting to any station in the North-Eastern Region. Special (Duty) Allowance will be in addition to any special pay and/or deputation (duty) allowance already being drawn subject to the condition that the total of such Special (Duty) Allowance plus Special pay/Deputation (Duty) Allowance will not exceed Rs. 1000/- p.m. Special allowances like Special Compensatory (Remote Locality) Allowance, Construction Allowance and Project Allowance will be drawn separately.

The Central Govt. Civilian employees who are members of Scheduled Tribes and are otherwise eligible for the grant of (Special Duty) Allowance under this para and are exempted from payment of Income-Tax under the Income-Tax Act will also draw Special (Duty) Allowance.

IV. Special Compensatory Allowance:

The recommendations of the 4th Pay Commission have been accepted by the Govt. and Special Compensatory Allowance at the revised rates have been effective from 1.10.86.

V. Travelling Allowance on First appointment

The present concessions as contained in this Ministry's

28 O.M. No dt. 14.12.83 will continue with the liberalisation that on first appointment TA should be admissible for the total distance instead of for the distance in excess of first 400 kms. only.

VI. Travelling Allowance for journey on transfer

The existing provisions as contained in this Ministry's O.M. dated 14.12.83 will continue.

vii) Road mileage for transportation of personal effect on transfer:

The existing provisions as contained in this Ministry's O.M. 14.12.83 will continue.

viii. Joining time with leave

The existing provisions as contained in this Ministry's O.M. dated 14.12.83 will continue.

ix. Leave Travel Concession

The existing concessions as contained in this Ministry's O.M. dated 14.12.83 will continue.

Officers drawing pay of Rs. 5100/- or above and their families i.e. spouse and two dependent children (Upto 8 years for boys and 24 years for girls) will be allowed air travel between Imphal/Silchar/Agartala/Aizwal/Lilabari and Calcutta and viceversa, between Portblair and Calcutta/Madras and vice-verse in case of posting in A & N Islands, and between Kavaratti and cochin and vice-versa in case of postings in Lakshadweep.

x) Children Education Allowance/Hostel subsidy:

Where the children do not accompany the Government servant to the North Eastern Region, Children Education Allowance upto class XII will be admissible in respect of children studying at the last station of posting of the employees concerned or any other station where the children reside. If children studying in schools are put in hostels at the last station of posting or any other station, the Government servant concerned will be given hostel subsidy without other restrictions.

The rates of Children Education Allowance/Hostel subsidy will be as in the DOP&T, O.M. 18011/1/87-Estt(Allowances) dated 31.12.87 as amended from time to time.

xi) Concession regarding grant of House Rent Allowance to officers posted in the States of North Eastern Region, Andaman & Nicobar Island and Lakshadweep/Islands

The present concession as contained in this Ministry's O.M. No. 11016/1/E.II(B)/84 dated 29.8.84 as amended from time to time will continue to be applicable.

xii. Telephone facilities

The officers who are eligible to have residential telephone may be allowed to retain their telephone at their residences in the last place of the posting subject to the condition that the rental and all other charges are paid by such officers.

2. The above orders will also apply mutatis-mutandis to the Central Government employees posted in Andaman & Nicobar Islands and Lakshadweep Island. These orders will also apply mutatis-mutandis to officers posted to N.E. Council, when they are stationed in the NE Region.

3. These orders will take effect from the date of issue.

4. In so far as the persons serving the Indian Audit & Accounts Department are concerned these orders issue after consultation with the Comptroller & Auditor General of India.

Copy of D.O. Letter No.6/22/80/Estt(Pay)II, dated 2nd June, 1986 from Shri K. Ramanujam, Secretary, Ministry of Personnel & Training, Administrative Reforms & Public Grievances and Pension.

During his visit to the North Eastern Region as also the Tribal Areas in the various part of the country, the Prime Minister has found that bright and motivated officers are rarely posted to those areas. Officers are not quite anxious to serve in such remote areas because of the hardships they have generally to undergo there. As a result, development programmes in such areas are affected adversely.

2. After examining the various aspects connected with the problem incentives are now being provided to attract efficient officers to serve in such areas. In the Ministry of Finance (Department of Expenditure) O.M.No.20014/3/83-E.IV dated the 14th December, 1983 certain improved facilities has been provided for the civilian employees of the Central Government serving in the State and Union Territories in the North Eastern Region as also in the Andaman & Nicobar Islands. In that O.M. it is interalia provided that on completion of the tenure of service in these areas, the officers may be considered for posting to a station of their choice as far as possible. However, it has been brought to our notice that this incentive is not being implemented in practice in some cases.

3. In this connection the Prime Minister has observed as under :-

" After serving a full tenure in the tribal areas the officer should have choice of posting thereafter."

4. I shall be grateful if you will kindly look into the matter and ensure that the in respect of the services and cadre which are being controlled and administered by your Ministry/Department the officers are given a choice of posting after they have served a full tenure in North Eastern Region, or the Tribal areas in the various part of the country.

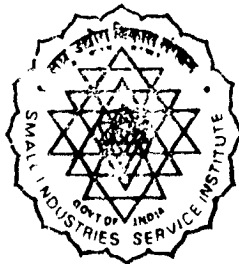
